## **NOTIFICATION**

Whereas the State Election Commission, Haryana in exercise of the powers conferred on it under Clause (1) of article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and Rules 4 to 11 of the Haryana Municipal Election Rules, 1978, has issued programme for preparation of electoral rolls of all the wards of the **Municipal Council, Panchkula** intensively w.r.t. 01.01.2008 as qualifying date on the basis of assembly constituency electoral rolls finally published on 31.08.2007 with reference to 1st January, 2007 as qualifying date vide its notification No.SEC/2ME/2007/13083, dated 11.12.2007.

- 2. And whereas the Deputy Commissioner, Panchkula vide his letter No.115/LFA/2008, dated 08.01.2008 has stated that lot of people met him and stated that they were out of station during the holidays of last week of December, 2007 and on new year. They came to know that their names have not been included in the draft electoral rolls published on 28.12.2007 of Municipal Council, Panchkula and requested to give more time to submit their claims for including their names in the voter list of Municipal Council, Panchkula. The Deputy Commissioner, Panchkula has further requested that in view of the problem being faced by inhabitants of Panchkula, to extend the last date for submitting claims and objections for another five days in public interest.
- 3. In view of the above request of the Deputy Commissioner, Panchkula the State Election Commission hereby extends the dates for filing claims and objections as per the following programme:-

1.	Last date by which claims and objections shall be presented to the Revising Authority (Rule-9)	14.01.2008
2.	Last date by which the claims and objections shall be disposed of by the Revising Authority. (Rule-10 (1)(i)	19.01.2008
3.	& (ii) ) Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority (Rule-10(2) )	24.01.2008
4.	Last date for disposal of appeals by the Deputy	29.01.2008
5.	Commissioner (Rule-10(3)) Final Publication of Electoral Rolls (Rule-11)	08.02.2008

4. Now, the final publication of electoral rolls of Municipal Council, Panchkula shall take place on 08.02.2008. The other directions issued vide above referred Commission's notification shall remained unchanged.
