## **NOTIFICATION**

Whereas, on the request of the Financial Commissioner & Principal Secretary to Govt. Haryana, Urban Development Department, the election programme of ward No. 1,2,3,10,11,12 & 28 of Municipal Council, Karnal was cancelled by this Commission vide its Notification No. SEC/1ME/2005/1871, dated 15.04.2005 as the certain area of the same wards were also included in 12 villages namely Baldi, Uchani, Mukkarampur, Kailash, Mangalpur, Budhakhera, Phusgarh, Rampur Katabag, Daha, Madanpur, Kambohpura and Saidpura of District Karnal, where the elections to the Sarpanches & Panches were already held on 3.4.2005.

- 2. And, whereas, the State Govt. under sub-section(2) of Section 6 of the Haryana Municipal Act, 1973 (Act 24 of 1973) vide its notification No.18/5/2003/3CI, dated 12.07.2006 has now excluded certain areas of this Municipal Council, Karnal from the Municipal limits of Karnal.
- And, whereas the State Govt. under Rule 10 of Haryana Municipal Delimitation of Wards Rules, 1977 has partially modified the schedule of boundaries of ward Nos.1, 2, 3, 10, 11, 12 & 28, vide its notification No. 18/53/2004-3CI, dated 17.7.2006 as was already published vide Govt. Notification No.18/53/2004-3CI, dated 17.09.2004 and the State Govt. further clarified that there is no electors in the area of ward No.I and 12 of the Municipal Council, Karnal.
- 4. And, whereas, in order to hold bye-election of Ward No, 2,3,10,11&28 of Municipal Council Karnal only for remaining period to fill the vacant seats, it is necessary that the existing ward wise electoral rolls of Municipal Council Karnal be revised.
- 5. The State Election Commission, Haryana in exercise of the powers conferred on it under Clause (1) of article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and Rules 4 to 11 of the Haryana Municipal Election Rules, 1978, has decided to prepare the electoral rolls of all the wards of the **Municipal Council Karnal**, **Distt. Karnal** summarily on the basis of Assembly

Electoral Rolls finally published on 31.05.2006 with reference to 1st January, 2006 as qualifying date as per following programme:-

1.	Preparation of Draft Electoral Rolls of all the wards of the Municipal Council, Karnal, Distt. Karnal on the basis of Assembly electoral rolls finally published on 31.05.2006 with qualifying date as on 01.01.2006 (Rule-4 of the Haryana Municipal Election Rules, 1978) and also adding the names of eligible persons after conducting house to house survey and deleting the names of persons who had died and also of those who are found to be no longer ordinarily residing in the territorial limits of the municipal council.	20/7/2006 to 31/7/2006
2.	Draft publication of Electoral Rolls of all the wards of the concerned Municipal Council on the basis of Assembly electoral rolls finally published on 31.05.2006 with qualifying date as on 01.01.2006 for inviting claims and objections. (Rule-7 of the Rules ibid)	01/8/2006
3.	Last date by which claims and objections shall be presented to the Revising Authority (Rule-9 of the Rules ibid)	11.08.2006
4.	Last date by which the claims and objections shall be disposed of by the Revising Authority. (Rule-10 (1)(i) & (ii) of the Rules ibid)	19.08.2006
5.	Last date for filing appeals with the Deputy Commissioner against the orders of Revising Authority (Rule-10(2) of the Rules ibid)	25/8/2006
6.	Last date for disposal of appeals by the Deputy Commissioner (Rule-10(3) of the Rules ibid)	28/08/2006
7.	Cyclostyling/Photocopy/typing of finally publishing of addenda to the existing electoral roll, meaning thereby addition or deletion of names in the form of supplementary/addendas are to be appended with the electoral rolls (Rule-11 of the Rules ibid).	04/09/2006

5. The State Election Commissioner further directs that all the names of the electors entered in the Assembly Electoral Rolls finally published on 31.05.2006 and also in the existing Municipal electoral rolls finally published on 18.11.2004 and supplementary addenda on 16.02.2005, except the names of the persons who have been died and also of those who have ceased to be ordinary resident or no longer ordinarily residing in the territorial area of the concerned wards of the Municipal Council should be

included/deleted in the ward wise draft of the Municipal rolls now to be prepared for publishing them to invite claims and objections.

- 6. The State Election Commissioner further directs to use the CDs of the Assembly Electoral Rolls obtained from the Chief Electoral Officer, Haryana. These CDs are available with District Election Officer (Panchayat) in the District. A copy of electoral roll may also be obtained from the District Election Officer (Election Deptt.) It is further directed to procure only the relevant part of the Electoral Rolls, which is related to these Municipalities. Requisite format prescribed for the Municipal Rolls, as "Annexure-1" attached herewith is required to be got typed.
- 7. The State Election Commissioner further directs that:-
  - (a) The Deputy Commissioner shall give widest possible publicity to the above programme indicating place and time of receiving & disposal of claims and objections by the Revising Authority and disposal of appeals by the concerned Deputy commissioner. He will issue press notes and also paid advertisements in the two local newspapers. He will also make publicity through electronic media.
  - (b) One copy of the draft electoral rolls published for inviting claims /objections shall be made available to the Secretary of the Municipal Council, one copy to the office of concerned Tehsildar, one copy to the office of concerned Sub-Divisional Officer (Civil), one copy to the concerned Revising Authority and one copy will be kept in the office of concerned Deputy Commissioner for making it available for inspection to the public free of cost.
  - (c) The Deputy Commissioner shall publish the ward-wise draft Municipal Electoral Rolls together with a notice including the date 11-08-2006 by which the claims & objections with reference to the draft Rolls, may be presented to the Revising Authority. The Deputy Commissioner shall appoint one Authorised Officer for three Wards and sufficient number of required supporting staff and other officials of Municipal Council, to assist the Revising Authority for providing copies of the Draft Municipal Electoral Rolls for inspections to public and also to receive claims & objections. After the draft publication of the ward-wise Municipal Electoral Rolls is made on 01.08.2006, these draft Municipal Electoral Rolls should be made available to the public for consultation and

inspection at some prominent places, preferably at Government or Municipal buildings and for this purpose Centres having three Wards i.e. assigning three Wards to each centre and the last centre will consist of the remaining wards for Municipal Council, Karnal and it should be created under the charge of an Authorised Officer. At these centres, the ward-wise draft Electoral Rolls should be placed for supervision of the Authorised Officer assisted by supporting staff so that after inspection of these ward-wise draft Electoral Rolls, the aggrieved person/(s) may file claims and objections before the Authorised Officers and proper receipts for these claims & objections filed before them, should also be issued to the concerned person/(s). And these Officers should also inform them the date, time and place of disposal of their claims & objections by the Revising Authority.

- (d) The Revising Authority shall, after holding an enquiry into the claims or objections as he thinks fit, record his decision in writing and shall make available on demand a copy of such decision to the objector or claimant free of charge forthwith.
- (e) The Revising Authority after disposal of all the claims & objections in terms of under Sub-rule (1) of Rule 10 of the Haryana Municipal Elections Rules, 1978, shall forward a list of such claims and objections along with his orders thereon to the Deputy Commissioner, within the prescribed time. Any person aggrieved by any such order of the Revising Authority, may within five days apply to the Deputy Commissioner for revision of the orders of the Revising Authority. The Deputy Commissioner shall within a period of three days confirm such order, or set it aside or pass such order with respect to such claim or objection as he may deem fit. The decision of the Deputy Commissioner on an appeal shall be final.
- (f) The concerned Deputy Commissioner shall publish the final Electoral Rolls on 04.09.2006 and the Electoral Rolls of the Municipal Council, Karnal District Karnal shall come into force from the date of publication.
- (g) After completion of every stage of the preparation process, the concerned Deputy Commissioner shall invariably send a message to the State Election Commission and shall also keep the State Election Commission informed of the

Statistical Data like the numbers of claims, objections and corrections received accepted or rejected.

8. The State Election Commission further directs that a copy of ward-wise Municipal Electoral Rolls of concerned Municipal Council shall finally be published on 04.09.2006 and be submitted to the State Election Commission on the same day and one copy thereof shall be supplied to all the Political Parties in the State of Haryana under intimation to the State Election Commission.
