The State Election Commission in exercise of the powers conferred on it under clause (1) of article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and sub-rule (1) of Rule 12 and Rule 14 of the Haryana Municipal Election Rules, 1978, has decided to **prepare addenda (meaning thereby additions) to the existing electoral rolls of all the wards of 47 Municipal Councils and Committees** mentioned in Annexure "A" which were finally published on 25.11.2004 and 15.12.2004 for inclusion of names of persons whose names have not been included in the electoral rolls with reference to 1st January, 2005 as qualifying date, as per following programme :-

1. The Electoral rolls for Municipal Councils/Committees listed in Annexure- "A" were prepared on the basis of Assembly electoral rolls finally published on 23.02.2004 for which the State Election Commission had issued Notifications No.

SEC/2ME/2004/10036, dated 28.09.2004,SEC/2ME/2004/12410 dated 18.11.2004 and No. SEC/2ME/2004/12765 dated 25.11.2004. After following the procedure prescribed in the Haryana Municipal Election rules, 1978, the electoral rolls of all these Municipal Councils and Municipal Committees were finally published on 25.11.2004 and 15.12.2004. The qualifying date for the electoral rolls of these 47 Municipalities was kept as 01.01.2004.

2. In order to provide an opportunity to all those persons, who had become eligible to be registered as voters for the Municipal elections after the qualifying date of 01.01.2004 on attaining the age of 18 years as on 01.01.2005 and also to those persons whose names are not included in the existing electoral rolls of these Municipalities, it has been decided that such persons may file their applications for inclusion of their names in the Addenda to the existing electoral rolls to be so prepared.

3. The State Election Commission further directs that applications from the persons eligible to be registered as voters for Municipal elections with qualifying date as 01.01.2005, whose names are not included in the electoral rolls of the Municipal Councils/Committees mentioned in Annexure-"A" finally published on 25.11.2004 and 15.12.2004 on the basis of Commission's Notifications No. SEC/2ME/2004/10036, dated 28.09.2004, No. SEC/2ME/2004/12410, dated 18.11.2004 and Notification No. SEC/2ME/2004/12765, dated 25.11.2004, be invited and filed before the respective Revising Authorities. The Revising Authorities are also directed to give wide publicity to the programme of inviting and filing applications.

4. The State Election Commission further directs that Revising Authorities should prepare ward-wise list of names of such applicants and the draft of these names be published on 10.02.2005 for inviting objections.

5. The State Election Commission further directs that wide publicity should be given for the dates on which such objections shall be decided so that the applicants may also be able to put up/ present their cases, if they desire, before these objections are decided.

6. The State Election Commission further directs that the objections received against the proposed additions of names to the existing Municipal electoral rolls should be decided by 11.02.2005 by the concerned Revising Authority/ies.

7. The State Election Commission further directs that the appeals against the decision of the Revising Authority be filed before the Deputy Commissioners by 12.02.2005 and appeal thereto shall be decided by the Deputy Commissioners by 14.02.2005.

8. The State Election Commission further directs that after the appeals are decided by the Deputy Commissioner on 14.02.2005, ward-wise list of names should be prepared for Typing/cyclostyling/photocopying and finally published on 16.02.2005 and appended to the existing electoral rolls. No fresh printing of these Electoral rolls be done, only addendas are to be enclosed .
