(b) Period of making nomination under rule 24(a).

17.03.2008 (Monday) to 19.03.2008 (Wednesday)

(10.00AM to 04.00 PM)

Date by which information shall be furnished 20.03.2008 (Thursday) (c) by the candidate that he/she is not suffering from any disqualification in the format prescribed, to the Returning Officer (Panchayat)

Before 10.00 AM

Date of Scrutiny under rule 24 (b) (d)

20.03.2008 (Thursday) From 10.00 AM to 04.00 PM

Date of Withdrawal under rule 24(c) (e)

24.03.2008 (Monday) (Upto 04.00 PM)

(f) Date of Poll, if required 30.03.2008 (Sunday) (From 8.00 AM to 4.00 PM)

(g) Counting of votes For elections to Panches & Sarpanch

Immediately after the close of poll at the Polling Stations.

2. The District Election Officer (Panchayats), shall by notice in Form 2 or 3, as the case may be, specify the above programme i.e. (i) last date, time and place of making nominations; (ii) the date, time and place for the scrutiny of the nomination papers (iii) date and time for withdrawal of candidature and (iv) the date on which and the time during which the polling will be held (v) the date, time and place of counting of votes in accordance with the provisions contained in sub rule (a), (b) and (e) of Rule

24 of the Haryana Panchayati Raj (Election) Rules, 1994 and send a copy of the notice to the Commission by fax.

- 3. The State Election Commission further directs that the nomination papers for the election to Panches and Sarpanch of Gram Panchayat shall be filed and received at Gram Panchayat Head Quarter by the Returning Officer (Panchayat) / Assistant Returning Officer (Panchayat) .The State Election Commission further directs that the work of scrutiny of the nomination papers shall not be delegated to the Assistant Returning Officer.
- 4. The State Election Commission further directs that the signatures of the candidate or his election agent should be obtained on the nomination paper for allotment of symbol to the candidates in token of the fact that the candidates have been informed about the symbols allotted to him.
- 5. The State Election Commission also directs that the Returning Officer (Panchayat) shall supply copy of the prescribed form regarding criminalization of politics, declaration of assets and liabilities, educational qualification (annexure-III), to the contesting candidates with the nomination form. The Returning Officer (Panchayat) shall also obtain a dated receipt in the prescribed form of issuing the copies of the proformas and retain with the nomination papers.
- 6. The State Election Commission further directs that if there is any stay order passed by any competent authority or Court against these vacancies, then the election to that seat shall not be held.
