In accordance with the provisions contained in Section 163, 164, 165 and 166 of the Haryana Panchayati Raj Act, 1994 read with Rule 8, Rule 9, Rule 10, Rule 11 and Sub-Rule 2 of Rule 12 of the Haryana Panchayati Raj Election Rules, 1994 in exercise of powers conferred under Sub-Section (1) of Section 212 of the Haryana Panchayati Raj Act, 1994, the State Election Commission, Haryana hereby directs that list of voters in respect of all the wards of Gram Panchayats, Panchayat Samitis and Zila Parishads in the State of Haryana for the third Panchayat general elections shall be prepared on the basis of the Assembly electoral rolls published on 23/02/2004 under the provisions of the Representation of People Act, 1950, with qualifying date as 01/01/2004.

The State Election Commission further directs that the list of voters in respect of all the districts in the State of Haryana shall be prepared in accordance with the procedure given hereunder: -

1.	Preparation of list of voters of all wards of Zila Parishads, Panchayat Samitis and Gram Panchayat (where work relating to wardbandi has been completed) on the basis of Assembly Electoral Rolls published on 23.02.2004 with reference to qualifying date as 01.01.2004(Rule 8)	08.12.2004 (Wednesday) to 10.12.2004(Friday)
2.	Draft publication of list of voters of all the wards of Zila Parishads, Panchayat Samitis and Gram Panchayats (where work relating to wardbandi has been completed) on the basis of Assembly electoral roll published on 23.02.2004 with reference to qualifying date 01.01.2004 for inviting claims and objections (Rule 9).	11.12.2004(Saturday)
3.	Last date for receipt of claims and objections (Rule 9).	15.12.2004(Wednesday) (upto 3.00 P.M.)
4.	Last date for disposal of claims/objections by the District Electoral Officers (Panchayat) sub rule (1) of Rule 10.	18.12.2004 (Saturday)
5.	Publication of final voter list under sub rule (4) of rule 10.	27.12.2004 (Monday)

The State Election Commission further directs that the title page of the voters lists shall be as per enclosed proforma prescribed by the State Election Commission. The State Election Commission further directs that identity card serial numbers as indicated against the names of voters lists in the Assembly electoral rolls, shall also be entered under column (8) of the voters list prepared for the Zila Parishads, Panchayat Samitis and Gram Panchayats.

The State Election Commission further directs that two copies of relevant part of the Assembly Electoral Roll published on 23.2.2004 with reference to qualifying date 1.1.2004 be obtained free of cost from concerned Tehsildar/Naib Tehsildear (Elections) and if additional copies of the relevant part of the Assembly Electoral Rolls are required then the same be purchased from the concerned Tehsildar/Naib Tehsildar (Election) after making payment per pages as fixed by the Election Department Haryana, data base CD of the Assembly Electoral Rolls should also be obtained from the concerned Tehsildar/Naib Tehsildar (Elections), if necessary.

The State Election Commission further directs that the draft voters list so prepared for preliminary publication for all wards of Zila Parishads, Panchayat Samitis and Gram Panchayats should be in conformity with the electoral rolls of the Assembly constituency published on 23/02/2004. Only such person should be registered as voter in the draft voters list whose name appears in the electoral rolls of the Assembly constituency and no other person should be registered as voter. The names of such persons whose names appear in the Assembly electoral rolls are not excluded from the voters list at the time of its preliminary publication.

The State Election Commission further directs that for the purpose of above preparation: -

 Three copies of the relevant portion of the voters list prepared shall be made available to the Gram Sachiv for placing them in the relevant Gram Panchayats, two copies to the relevant Block Development and Panchayat Officer for placing them in the Panchayat Samiti's office and one copy be kept in the Zila Parishad's office for inspection by the public free of cost. Beside a copy of the relevant part of the voter list shall be kept in Tehsil, Block Election Officer (Panchayat)'s office as well as at the office of District Election Officer for inspection by the public free of cost.

- 2. A notice in this respect shall be affixed at the office of the Gram Panchayat, Panchayat Samiti and Zila Paishad and the notice board of the Tehsil Office, the Block Election Office within which the village be, the District Election Officer (Panchayat) concerned and at the one or two conspicuous places within the village to which the list pertains.
- 3. The District Electoral Officer shall, after holding such summary enquiry into the claims and objections as he thinks fit, record his decision in writing and shall make available on demand a copy of such decision to the objector free of charge forthwith.
- The District Electoral Officer shall amend the voters list in accordance with his decision.
- 5. The voters list so amended shall be final and copy thereof duly signed by the District Electoral Officer (Panchayat) shall be kept in his office and another copy deposited in the office of District Election Officer (Panchayat) and shall be finally published in the manner prescribed above.
- 6. The District Election Officer (Panchayat) shall give widest possible publicity to the above programme by issue of press notes and other handouts and also by inserting paid advertisements in the local two news papers and publicity through electronic media.
- 7. After completion of every stage of the preparation process the District Election Officer (Panchayat) shall invariably send a message to the State Election Commission and shall also keep the State Election Commission informed about

the statistical data like the number of claims, objections and corrections received, accepted and rejected.

The State Election Commission further directs that a copy of list of voters of Zila Parishads, Panchayat Samitis and Gram Panchayats on its final publication on 27.12.2004 shall be submitted to the State Election Commission on the same date and two copies thereof shall be supplied to all the Political Parties in the State of Haryana under intimation to the State Election Commission.
