Whereas, in exercise of the powers conferred under Clause(1) of article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and Rules 4 to 11 of the Haryana Municipal Election Rules, 1978, the State Election Commissioner, Haryana had prescribed programme vide its notification No. SEC/2ME/ 2010/29, dated 23.1.2010 for preparation of electoral rolls of all wards of 10 municipal councils and 28 municipal committees intensively on the basis of Assembly Electoral Rolls finally published on 22.1.2009 with reference to 1st January, 2009 as qualifying date (with all supplements). As per programme, draft electoral rolls have been prepared from 25.1.2010 to 9.2.2010, draft publication of electoral rolls on 10.2.2010, claims and objections presented before the revising authority upto 20.2.2010 and the same have been disposed off by them upto 25.02.2010.

2. During the meeting held on 27.02.2010 at Ambala and Panipat by Hon'ble State Election Commissioner with Deputy Commissioners, it was discussed that due to many holidays falls during the period prescribed earlier by the Commission, the time for filing of appeals to be filed by electors against orders of the Revising Authority to the Deputy Commissioner and the time for disposal of the appeals may be extended to give much opportunity to the public. It

has been requested that the programme for preparation of electoral rolls of the Municipal Councils and Municipal Committees may be revised.

3. Whereas, the process upto the stage of disposal of claims and objections by the Revising Authority has already been completed. In exercise of powers conferred under Clause(1) of article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and Rules 4 to 11 of the Haryana Municipal Election Rules, 1978, I , Dharam Vir, State Election Commissioner, Haryana hereby revise the programme for preparation of electoral rolls of all wards of Municipal Councils/Municipal Committees mentioned in **Annexure-B** (except Municipal Council Palwal) intensively on the basis of Assembly Electoral Rolls finally published on 22.1.2009 with reference to 1st January, 2009 as qualifying date (with all supplements), as under:-
