Chandigarh April 02, 2005: The State Election Commission, Haryana has already issued the Time Schedule to conduct 3<sup>rd</sup> Panchayat General Elections of Panches and Sarpanches of Gram Panchayats, Members Panchayat Samitis and Zila Parishads in the State of Haryana. As you are already aware that these elections are being conducted in two phases i.e. 03.04.2005 (Sunday) and 09.04.2005 (Saturday). In the first of this General Elections, State Election Commission is going to conduct elections respect of 53 blocks where Poll would be held in following blocks:-

State Election Commission, Haryana has received information from the district authorities as well as from the Observers that the law & Order in all the polling stations is totally in good condition and the polling parties have already reached to their destinations and the elections with regard to these blocks will be conducted in totally peaceful manner. It is for the information of general public that the adequate

security/police arrangements have also been made at all the polling stations by the district authorities, so that the voters can exercise their constitutional right to franchise in

free and peaceful manner.

had informed the Commission that while checking of ballot papers on 01.04.2005, it was

discovered that the ballot papers got printed for the election of Panch, Ward No.10 of

Gram Panchayat Didwada, name of a male candidate is printed on the ballot papers of

this ward whereas the seat is reserved for a female candidate. The Deputy

Commissioner-cum-District Election Officer (Panchayat) has recommended that election

to the office of Panch, Ward No.10, Gram Panchayat Didwada scheduled to be held on

03.04.2005 may be cancelled. So, keeping in view the recommendations of the Deputy

Commissioner-cum-District Election Officer (Panchayat), Jind, State Election

Commission, Haryana has cancelled the election of Panch, Ward No.10 of Gram

Panchayat Didwada, District Jind. Now, the election of Ward No.10 of Gram Panchayat

Didwada will be conduced on some other date.
