Whereas the State Election Commission, Haryana vide its notification No. SEC/3E-II/2010/1773 dated 15.05.2010 has issued the time schedule for the conduct of 4<sup>th</sup> general elections of Panchayati Raj Institutions in 13 districts namely Ambla, Bhiwani, Fridabad, Fatehabad, Jind, Jhajjar, Kaithal, Kurukshetra, Mahendergarh, Sirsa, Sonepat, Mewat and Palwal. In the last sentence of para 6 of the notification it has been mentioned that the work of scrutiny of nomination papers and allotment of symbols shall not be delegated to any of the Assistant Returning Officer.

2. Whereas, the Deputy Commissioner, Jind vide his memo No. 868/Panchayat dated 17.05.2010 has pointed out that practically it is not possible for a Returning Officer(Panchayat) to allot the symbol in that short period in all the villages of his cluster.

3. Therefore, in view of the above position the State Election Commission, Haryana, hereby substitute para 6 of the said notification as under:-

"The State Election Commission further directs that nomination papers for the election for members of Gram Panchayats and Sarpanches of Gram Panchayats shall be filed and received at Gram Panchayat Head Quarters by the Returning Officer/Assistant Returning Officer, nomination paper for the members of Panchayat Samiti shall be filed and received at block Headquarters by the Returning Officer/Assistant Returning Officer and for election for the members of Zila Parishad the nomination papers shall be filed and received by the Deputy Commissioner-cum-Returning Officer to the Zila Parishad or to the Assistant Returning Officer of Zila Parishad. The work of scrutiny of nomination papers should not be delegated to the Assistant Returning Officer (Panchayat)."
