In exercise of the powers conferred under clause (1) of Article 243K of the Constitution of India and Section 212 of the Haryana Panchayati Raj Act, 1994 and Rule 33 of the Haryana Panchayati Raj Election Rules, 1994 and all powers enabling it in this behalf, I, Dharam Vir, State Election Commissioner, Haryana hereby order to further amend the Haryana Panchayati Raj Election Symbols (Reservation and Allotment) Order, 1996, as under:-

- 1. These orders may be called Haryana Panchayati Raj Election Symbols (Reservation and Allotment) Amendment Order, 2010.
- 2. In the Haryana Panchayati Raj Election Symbols (Reservation and Allotment) Order, 1996, for para 11 the following para shall be substituted, namely:-
 - "11. When a candidate shall be deemed to be set up by a political party: For the purpose of this order, a candidate shall be deemed to be set up by a political party, if, and only if, -
 - (a) the candidate has enclosed a declaration to that effect alongwith the nomination paper;
 - (b) the candidate is a member of that political party and his name is borne on the rolls of members of the party;
 - (c) a notice in writing, in Form-B (Annexure-III), to that effect has, not later than 3.00P.M. on the last date for making nominations, been delivered to the concerned Returning Officer of the Panchayat Samiti and Zila Parishad.
 - (d) the said notice is signed by the President, the Secretary or any other office bearer of the party and the President, Secretary or such other office bearer authorised by the party to send such notice in form 'A' in (Annexure-II);
 - (e) the communication with regard to the name and specimen signature of such authorised persons are delivered to the concerned Returning Officer of the Panchayat Samait and Zila Parishad not later than 3.00 P.M. on the last date for making nominations; and
 - (f) form A & B (Annexure II & III) are signed, in ink only, by the said office bearer or person authorised by the party.

Provided that no facsimile signature or signature by means of rubber stamp, etc, of any such office bearer shall be accepted and no form transmitted by fax shall be accepted."
