Subject:- Ban on posting/transfer of officers/officials who are engaged in Panchayat General Elections to be held in June/July, 2010.

Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2010/4183, dated 14.06.2010 (copy enclosed) for the conduct of Panchayat General Elections of the offices of Panches and Sarpanches of Gram Panchayats and Members of Panchayat Samitis and Zila Parishads of 8 districts i.e. Panchkula, Yamunanagar, Karnal, Panipat, Rohtak, Hisar, Gurgaon, Rewari and Panches and Sarpanches of Gram Panchayat Siwanamal Naya Gaon Siwanamal of district Jind. The poll on these districts shall be held on two phases i.e. 06.07.2010 and 10.07.2010. The counting of votes in respect of Panches and Sarpanches shall be held on 06.07.2010 & 10.07.2010 and in respect of Member Panchayat Samiti & Zila Parishad, it shall be held on 12.07.2010 at Block and District headquarter.

- 2. I am further directed to inform you that following officers/officials of the State Government posted in the Districts are connected with the conduct of Panchayat General Elections:-
 - (i) The Deputy Commissioners/Additional Deputy Commissioners/Sub-Divisional Officers (Civil)/City Magistrates/District Development & Panchayat Officers/Duty Magistrates/Tehsildars/Naib Tehsildars/Block Development and Panchayat Officers etc. and such other officers of the Panchayati Raj Institution entrusted with the work connected with the elections.
 - (ii) The officers appointed as Supervisory Officers.
 - (iii) Officers/officials appointed as Presiding Officers, Polling Officers, Counting Supervisors, Counting Agents and other staff posted for conduct of elections and counting of votes.
 - (iv) Commissioner of Police/Joint Commissioner of Police/Deputy Commissioner of Police/ Assistant Commissioner of Police / Superintendents of Police/Deputy Superintendents of Police/Assistant Superintendents of Police and other Police Officers like Inspector, SHO, Police Station In-charge, Head Constable & Constable who are entrusted with the task of maintenance of law and order and peaceful conduct of elections.

In view of the position explained above, I am further directed to request you that the above mentioned officers connected with the work of Panchayat General Elections should not be transferred till the declaration of election results. However, in the cases where it is considered necessary to transfer an officer connected with the above said Panchayat General Elections, prior approval of this Commission be obtained. Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations etc. of the State Government under intimation to the State Election Commission, Haryana.
