Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2013/12854, dated 11.12.2013 (copy enclosed) for the conduct of the Panchayat bye elections on the vacant seats of Panches, Sarpanches of Gram Panchayat and Members of Panchayat Samitis and Zila Parishads in the State of Haryana for which poll shall be held on 29.12.2013.

- As the election programme has been issued by this Commission on 11.12.2013, the Model Code of Conduct prescribed by the State Election Commission has come into operation with w.e.f. 11.12.2013 in the ward/Gram Panchayat concerned of the Panchayati Raj Institution, where the poll is to be conducted.
- Therefore, I am directed to request you that this may be brought to the notice of 3. Hon'ble Chief Minister / Ministers / Chief Parliamentary Secretaries / Parliamentary Secretaries and other authorities and they may be requested to strictly follow the model code of conduct. I am further directed to request you to invite attention of Hon'ble Chief Minister / Ministers / Chief Parliamentary Secretaries / Parliamentary Secretaries towards Para No.7 of the Model Code of Conduct (Part-II-for Government Department and Government servants), that no grant be sanctioned by them from the discretionary fund or from the Govt. fund nor will they sanction any scheme till elections are completed in the ward/Gram Panchayat concerned of the Panchayati Raj Intuitions in all respect. During this period neither any foundation stone shall be laid nor will any scheme / plan be inaugurated in the respective areas. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission.
- I am further directed to say that State Election Commission will not hesitate to cancel the election in respect of above Panchayati Raj Institutions in case of any violation of the Model Code of conduct.
