Sir,

I am directed to refer to the subject cited above and to say that the State Election Commission, Haryana has issued notification No.SEC/3E-II/2012/2692, dated 29.11.2012 (copy enclosed) for the conduct of Bye Elections of the vacant seats of Panches, Sarpanches, Members of Panchayat Samitis and Zila Parishads in the State of Haryana and second General Election of Gram Panchayat, Sambhalkha in district Kurukshetra on 16.12.2012. The nominations for these Elections, as prescribed in the notification would start from 04.12.2012 to 06.12.2012. The date of scrutiny of nomination papers has been prescribed as 07.12.2012. The last date of withdrawal of nomination papers is 10.12.2012. The counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations and in respect of Member Panchayat Samitis and Zila Parishads, it shall be held on 17.12.2012 at Block Headquarter concerned.

2. As the election programme has been declared by this Commission on 29.11.2012, the Model Code of Conduct prescribed by the State Election Commission has come into operation with w.e.f. 29.11.2012 in the area where the poll is to be conducted.

3. Therefore, I am directed to request you that this may be brought to the notice of Hon'ble Chief Minister / Ministers / Chief Parliamentary Secretaries / Parliamentary Secretaries and other authorities and they may be requested to strictly follow the same. I am further directed to request you to invite attention of Hon'ble Chief Minister / Ministers / Chief Parliamentary Secretaries / Parliamentary Secretaries towards Para No.7 of the Model Code of Conduct (Part-II-for Government Department and Government servants), that no grant be sanctioned by them from the discretionary fund or from the Govt. fund nor will they sanction any scheme till elections are completed in all respect. During this period neither any foundation stone shall be laid nor will any scheme / plan be inaugurated. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission.

4. I am further directed to say that State Election Commission will not hesitate to cancel the election in respect of above Panchayati Raj Institutions in case of any violation of the Model Code of conduct.

5. 10 Copies of Model Code of Conduct are sent herewith for making them available to all concerned.
