During this period neither any foundation stone shall be laid nor will any scheme / plan be inaugurated in the respective areas. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission.

4. I am further directed to say that State Election Commission will not hesitate to cancel the election in respect of above Panchayati Raj Institutions in case of any violation of the Model Code of conduct.
