Whereas, the Election Commission of India has issued directions that all electors in the State of Haryana who have been issued with their Electoral Photo Identity Cards, shall have to produce these Cards to exercise their franchise when they come to the polling stations for voting at the General Elections to the Member of Parliament and Member of Haryana Legislative Assembly; and

- 2. Now, therefore, after taking into account all relevant and the legal and factual position, in exercise of powers vested in it under Article 243K(1) of the Constitution of India read with section 212 of the Haryana Panchayati Raj Act, 1994 and all other powers enabling it in this behalf, the State Election Commission, Haryana hereby directs that all voters of the respective area who have been issued the Electoral Photo Identity Cards for Assembly and Lok Sabha Elections and the Electoral Photo Identity Card numbers have been mentioned in case of the Panchayat Voters list also, shall have to produce these cards to exercise their franchise when they come to the polling stations for voting, the polling for which is scheduled to take place on 25.06.2013.
- If any elector has not been issued Electoral Photo Identity Cards by the Election Commission of India, he/she will have to produce any one out of the following documentary evidence to establish his/her identity:--
