#### **NOTIFICATION**

In accordance with the provisions contained in Section 163, 164, 165 and 166 of the Haryana Panchayati Raj Act, 1994 read with Rules 8, 9, 10, 11 and Sub-Rule (2) of Rule 12 of the Haryana Panchayati Raj Election Rules, 1994 and powers conferred under Sub-Section (1) of Section 212 of the Haryana Panchayati Raj Act, 1994, the State Election Commission Haryana, hereby directs for the preparation/amendment and brought upto date the existing voters list (published on 15.04.2010 and 07.06.2010) of those Gram Panchayats, Panchayat Samitis & Zila Parishad where Bye/General Elections are to be conducted in near future. The list of such Gram Panchayats, Panchayat Samitis & Zila Parishad is attached as Annexure "A". The voters list of these institutions is to be prepared/amended and brought upto date on the basis of relevant parts of the Assembly Electoral Rolls published on 05.01.2011 with qualifying date as 01.01.2011.

2. The State Election Commission, Haryana further directs that the voters list of Panchayati Raj Institutions finally published on 15.04.2010 and 07.06.2010 under sub-rule 4 of Rule 10 of the Haryana Panchayati Raj Election Rules, 1994, be amended and brought upto date in respect of Gram Panchayats, Panchayat Samitis and Zila Parishads mentioned in Annexure –"A" in accordance with the procedure and schedule given hereunder: -

1.	The voters list (hereinafter referred to as draft voters list) of the Gram Panchayats, Panchayat Samitis and Zila Parishads mentioned in Annexure "A", be prepared/amended and brought uptodate on the basis of the relevant part of the Assembly Electoral Rolls, finally Published on 05.01.2011 with reference to qualifying date as on 01.01.2011 i.e. by adding the names of those voters whose names have not been entered in the existing voters list of these Gram Panchayats, Panchayat Samitis and Zila Parishads finally published on 15.04.2010 and 07.06.2010 and deleting the names of persons, who have died and no longer residing in the area (Rule-8).	12.05.2011 (Thursday) to 16.05.2011 (Monday)
2.	Publication of draft voters list of the Gram Panchayats, Panchayat Samitis and Zila Parishads as mentioned in Annexure "A", for inviting claims and objections (Rule 9).	17.05.2011 (Tuesday) (10.00 AM to 05.00 PM)

3.	Last date for receipt of claims and objections.	20.05.2011 (Friday) (10.00 AM to 03.00 PM)
4.	Last date for the disposal of claims/objections by the District Electoral Officers (Panchayat) sub rule (1) of Rule 10.	24.05.2011 (Tuesday) (excluding Sunday dated 22.05.2011)
5.	Typing and finally publishing of the addenda's to the existing voters list, meaning thereby the addition or deletion of names in the form of supplementary / addenda appending to the voters list (Under Sub-rule (4) of Rule 10).	28.05.2011(Saturday)

- 3. The State Election Commission further directs that for the purpose of preparing the draft voters list, the names to be added in the existing voters list, should be typed or written by hand. It is also made clear that the draft lists of voters should not be got printed for this purpose.
- 4. The State Election Commission further directs that copies of existing lists of voters which are already lying with the District Election Officers (Panchayat) should be used for this purpose and no fresh printing of these voters lists be done. If at all it becomes necessary, then few copies may be got printed.
- 5. The State Election Commission further directs that identity card serial numbers as indicated against the names of voters list in the Assembly electoral rolls shall also be entered under column (8) of the voters list prepared for the Gram Panchayat.
- 6. The State Election Commission further directs that four copies of relevant part of the Assembly Electoral Roll published on 05.01.2011 and data base CD of the Assembly Electoral Rolls may be obtained free of cost from the concerned Tehsildar/Naib Tehsildar (Elections).
- 7. The State Election Commission further directs that the draft voters list so prepared for preliminary publication of all the wards of concerned Gram Panchayats Panchayat Samitis and Zila Parishads of the districts should be in conformity with the electoral rolls of the Assembly constituency published on 05.01.2011, except those persons who have died or no longer residing in the respective Gram Panchayat Panchayat Samiti and Zila Parishad area. Only those persons should be registered as voter in the draft voters list, whose names appears in the electoral rolls of the Assembly constituency. It should also be ensured that the names of such persons whose names appear in the Assembly electoral rolls are not excluded from the voters list at the time of its preliminary publication. A person who has attained the age of 18 years as on 01.01.2011 is eligible for inclusion of his/her name in the voters list.
- 8. It is further directed that four copies of Assembly Electoral Rolls may be obtained free of cost from concerned Election Tehsildar / Election Naib Tehsildar. Data base compact discs of these electoral rolls have already been supplied to Deputy Commissioners.

- 9. It is further ordered that draft voters list shall be published as under:-
  - Three copies of the relevant portion of the voters list shall be made available to the Gram Sachiv i.e. one for affixing on the notice board of Gram Panchayat Office, second for affixing at a conspicuous place of the village to which it pertains and third will remain with him for the inspection by the public free of cost for inviting claims and objections.
  - ii) Two copies of the relevant portion of voters list shall be made available to the concerned Tehsildar, i.e. one for affixing on the notice board of the Tehsil Office and second will be kept in his office for inspection by the public free of cost.
  - iii) Two copies of the relevant portion of voters list shall be made available to Block Election Officer (Block Development & Panchayat Officer), i.e. one for affixing on the notice board of Panchayat Samiti office and second will be kept in his office for inspection by the public free of cost.
  - iv) One copy of the voters list shall be made available to Executive Officer of Zila Parishad which shall be kept in his office for inspection by the public free of cost.
  - v) One copy of the voters list shall also be made available to the concerned District Election Officer (P) for affixing on the notice board of his office.
  - vi) One copy of the voters list shall also be made available to the concerned District Electoral Officer which shall be kept in his for the inspection by the public free of cost.

A notice with regard to the publication of the voters list as specified above shall be affixed at the offices of the Gram Panchayat, Panchayat Samiti and Zila Parishad and on the notice boards of the Tehsil Office and Block Election Office (BDPO) within which the village falls and notice board of the District Election Officer (Panchayat) concerned and also affixed at one or two conspicuous places within the village to which the list pertains.

- 10. The District Election Officer (Panchayat) shall give the widest possible publicity to the above programme by munadi in villages, issue of press notes and other handouts and also by inserting paid advertisements in the two local news papers and making publicity through electronic media. In case of munadi, necessary entry shall be made in the relevant revenue record (Rapat Rojnamcha Vakyati) and record of Gram Panchayat.
- 11. The voters list, as prepared for draft publication, shall also be hosted on the official website of the concerned district for the information of the public and inviting claims and objections.
- 12. The District Electoral Officer shall, after holding such summary enquiry into the claims and objections as he thinks fit, record his decision in writing

within three days and shall make available on demand a copy of such decision to the objector free of charge forthwith.

- 13. The District Electoral Officer shall amend the voters list in accordance with the decision taken by him. The voters list so amended shall be final and copy thereof duly signed by the District Electoral officer shall be kept in his office and another copy be deposited in the office of District Election Officer (Panchayat) and shall be published in the manner prescribed under Rule 9 of Rules.
- 14. After completion of every stage of the preparation of voters list process, the concerned District Electoral Officer shall send information of the statistical data in the format attached as Annexure-"B" to the State Election Commission, Haryana, Panchkula as well as District Election Officer (Panchayat) of the concerned District.
- 15. It is further directed that a copy of voters list of Gram Panchayats, Panchayat Samitis and Zila Parishads on its final publication on 28.05.2010 shall be submitted to the State Election Commission, Haryana.
- 16. It is further directed that the final voters list of Gram Panchayats, Panchayat Samitis and Zila Parishads be hosted on the website of the District Administration.
