**NOTIFICATION**

**The 1<sup>st</sup> September, 2022**

**No. SEC/3E-II/2022/2041.-** Whereas, the State Election Commission, Haryana had issued programme for preparation of voters list of all Panchayati Raj Institutions i.e. Gram Panchayats, Panchayat Samitis and Zila Parishads in the State of Haryana vide notification No. SEC/3E-II/2022/1269, dated 13<sup>th</sup> May, 2022, according to which final publication of voters list has been made on dated 22.07.2022.


2. The Haryana Government, Urban Local Bodies Department vide its notification No. 8/28/2022-4CII, dated 13.08.2022 has constituted Municipal Council, Pataudi Mandi by including the Municipal Committee, Pataudi and Haily Mandi and also ten Gram Panchayats namely; Narhera, Devlawas, Heraheri, Khanpur, Chawan, Rampura, Milakpur, Mirzapur of Block Pataudi and Gram Panchayats Mubarikpur and Janola of Block Farukhnagar. Thereafter, the Haryana Government, Development & Panchayat Department vide its notification No. S.O. 69/H.A.11/1994/Ss/58 and 59/2022 dated 24<sup>th</sup> August, 2022 has re-determined the seats of Panchayat Samiti, Pataudi and Farukhnagar accordingly. The Deputy Commissioner, Gurugram vide its order issued under Endst. No. 406-15, dated 25.08.2022 has issued order to revise delimitation of wards of Zila Parishad, Gurugram and Panchayat Samiti, Pataudi and Farukhnagar, according to which the final publication of the same shall be made on 08.09.2022.

3. In view of the above, the State Election Commission, Haryana in accordance with section 163 of the Haryana Panchayati Raj Act, 1994 read with rule 8 of the Haryana Panchayati Raj Election Rules, 1994 and the powers conferred under sub-section (1) of section 212 of the Haryana Panchayati Raj Act, 1994 hereby directs the Deputy Commissioner-cum-District Election Officer (Panchayat), Gurugram for updating the existing voters list (published on 22.07.2022 vide notification referred to above) of Zila Parishad, Gurugram and Panchayat Samitis, Pataudi and Farukhnagar. The voters list of these Panchayati Raj Institutions shall be updated as per the revised delimitation orders to be finally published on 08.09.2022 and the revised voters list shall be updated simultaneously and published on 09.09.2022. The updated voters list shall be hosted on the official website of the District Administration on the same day. It is also directed that a public notice shall also be published by the Deputy Commissioner-cum-District Election Officer (Panchayat), Gurugram in two popular newspapers (one in English and one in Hindi) having wide circulation in the area as a paid and a notice shall also be pasted on the notice board of the O/o Deputy Commissioner Officer, SDO (C), Pataudi and all Block Development and Panchayat Officers and all Gram Panchayats concerned. to be read in the area of Pataudi and Farukhnagar
