NOTIFICATION

No.SEC/3E-II/2022/2949 Whereas the State Election Commission, Haryana has issued programme for preparation of voters list of all Panchayati Raj Institutions i.e Gram Panchayats, Panchayat Samitis and Zila Parishads in the State of Haryana vide notification No. SEC/3E-II/2022/269 dated 13th May, 2022, according to which final publication of voters list has been made on 22.07.2022.

2. The Haryana Government, Development and Panchayat Department, Chandigarh vide its notification No. DPH/ECA-2/223/2022 and Notification No. DPH/ECA-2/224/2022, dated 25.09.2022 has constituted new Gram Panchayat, Adampur village. After constitution of new Gram Panchayat, 20 wards have been determined for Gram Panchayat Adampur village, Wards of Panchayat Samiti Adampur have been increased from 19 to 21 and due to constitution of Gram Panchayat Adampur village, ward No. 1,2,3,4,5, 8,10,11,13,15,21,23,24,27, 29 and 30 of Zila Parishad, Hisar have been affected. The Deputy Commissioner, Hisar vide order under Endst Nos. Panchayat/PA/2022/5171-80, 5181-90 and 5191-97, dated 27.09.2022 has issued the programme for the wardbandi of Gram Panchayat Adampur village, Panchayat Samiti Adampur and Zila Parishad Hisar, according to which the final publication of ward bandi shall be made on 03.10.2022. The Deputy Commissioner-cum-District Election Officer (P), Hisar has requested to issue the voter list programme for the Gram Panchayat Adampur, Panchayat Samiti Adampur and Zila Parishad Hisar

3. Now, in view of the above, the State Election Commission, Haryana hereby directs to prepare the voters list of Gram Panchayat Adampur village, ward No.20 & 21 of Panchayat Samiti, Adampur and updation of voters list of ward No.1,2,3,4,5, 8,10,11,13,15,21, 23, 24, 27, 29 and 30 of Zila Parishad, Hisar as per schedule given under:-

v.	Last date by which the appeals shall be disposed of by the Appellate Authority {rule 8(4) (ix)}.	15.10.2022
vi.	Final publication of the voters list (rule 8 (4)(ix)).	17.10.2022
