Counting for election of Members of Panchayat Samitis and Zila Parishads shall be held on the date which will be notified by the State Election Commission, Haryana with the election schedule for the remaining 12 districts at the place(s) specified by the Deputy Commissioner-cum-District Election Officer (Panchayat) concerned and result shall be declared immediately after the completion of counting.

2. To facilitate voters and the staff on duty, it is essential that uninterrupted supply of electricity and drinking water is maintained from

29.10.2022 to 30.10.2022 and 01.11.2022 to 02.11.2022 in the area of the Panchayati Raj Institutions concerned.

3. I have further been directed to request you to issue necessary directions to the field staff to ensure that supply of electricity and drinking water must not be interrupted during the election of Panchayati Raj Institutions concerned.
