Arrangement for Supply of Uninterrupted Electricity and Drinking Water during the forthcoming General Elections of Panchayati Raj Institutions in the State.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections for three tiers of Panchayati Raj Institutions in 9 districts, namely; Ambala, Charkhi Dadri, Gurugram, Karnal, Kurukshetra, Rewari, Rohtak, Sirsa and Sonipat vide Notification No.SEC/4E-II/2022/3526, dated 14.10.2022(copy enclosed). As per election schedule, nomination papers shall be presented from 21.10.2022 to 28.10.2022 and poll shall be held on 09.11.2022 and 12.11.2022. Re-poll, if any, required, shall be held on 12.11.2022 and 14.11.2022 and counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations of the Gram Panchayat concerned. Counting for election of Members of Panchayat Samitis and Zila Parishads shall be held on the date which will be notified by the State Election Commission, Haryana with the election schedule for the remaining four districts at the place(s) specified by the Deputy Commissioner-cum-District Election Officer (Panchayat) concerned and result shall be declared immediately after the completion of counting.

2. To facilitate voters and the staff on duty, it is essential that uninterrupted supply of electricity and drinking water is maintained from

08.11.2022 to 09.11.2022 and 11.11.2022 to 12.11.2022 in the area of the Panchayati Raj Institutions concerned.

I have further been directed to request you to issue necessary directions to the field staff to ensure that supply of electricity and drinking water must not be interrupted during the election of Panchayati Raj Institutions concerned.
