Subject:- Deemed Deputation of Polling Personnel, IAS/IFS/HCS Officers and Police Officers who are deputed as Observers & other officers/officials on election duty with the State Election Commission during general elections of Panchayati Raj Institutions.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections for three tiers of Panchayati Raj Institutions in 9 districts, namely; Ambala, Charkhi Dadri, Gurugram, Karnal, Kurukshetra, Rewari, Rohtak, Sirsa and Sonapat vide Notification No.SEC/4E-II/2022/3526, dated 14.10.2022(copy enclosed). As per election schedule, nomination papers shall be presented from **21.10.2022 to 28.10.2022** and poll shall be held on **09.11.2022 and 12.11.2022**. Re-poll, if any, required, shall be held on **12.11.2022 and 14.11.2022** and counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations of the Gram Panchayat concerned. Counting for election of Members of Panchayat Samitis and Zila Parishads shall be held on the date which will be notified by the State Election Commission, Haryana with the election schedule for the remaining four districts at the place(s) specified by the Deputy Commissioner-cum-District Election Officer (Panchayat) concerned and result shall be declared immediately after the completion of counting.

2. As per Rule 23-A of the Haryana Panchayati Raj Election Rules, 1994 are reproduced here as under:-



“23-A. Officers and staff deemed to be on deputation to State Election Commissioner.—The officers and staff deputed for election duty in connection with the preparation, revision and correction of the voters lists for, and the conduct of, all elections shall

be deemed to be on deputation to the State Election Commission for the period during which they are so deputed and such officers and staff shall, during that period, be subject to the control, superintendence and discipline of the State Election Commission.”.

3. In view of the above, I have been directed to request you to bring these provisions into the notice of all concerned for information and strict compliance.
