Subject: - Reserving the Symbol "BROOM" (झाड़ू) for Aam Aadmi Party Candidates in  
the State of Haryana for General Elections of Panchayati Raj Institutions-  
2022


Sir/Madam,

I have been directed to refer to the above subject and to state that an application has been received in the State Election Commission from political party, namely, "Aam Aadmi Party" registered with Election Commission of India under section 29A of the Representation of People Act, 1951 seeking allotment of a common symbol to its candidates to be set up in the general elections of three tiers of Panchayati Raj Institutions, 2022.

2. After consideration, the State Election Commission has decided to allot the symbol "BROOM" (झाड़ू) to the candidates to be set up by the Aam Aadmi Party during general elections of Panchayati Raj Institutions (for the post of Member, Zila Parishads and Panchayat Samits only ) provided that the candidates to be set up by the party submit the requisite information to the Returning Officer in the prescribed form "A" and "B" as per the provisions made in the Haryana Panchayati Raj Elections Symbols (Reservation and Allotment) order, 2014 and notification No. SEC/3E-II/2022/1177, dated 05.08.2022. It is also directed that symbol "BROOM" (झाड़ू) mentioned at Sr.No.43 in Table-C vide Notification No. SEC/3E-II/2021/189 dated 16.03.2021 shall be treated as frozen for all other candidates. You are also requested to provide a copy of the same to the Returning Officer/Assistant Returning Officer for the election of all wards of Gram Panchayats of Panchayati Raj Institutions, 2022.

This may be brought into the notice of all the concerned.


