Subject:- Arrangement for Supply of Uninterrupted Electricity and Drinking Water during the forthcoming General Elections of Panchayati Raj Institutions in the State.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections for three tiers of Panchayati Raj Institutions in 4 districts, namely; Faridabad, Fatehabad, Hisar and Palwal vide Notification No.SEC/4E-II/2022/4332, dated 28.10.2022(copy enclosed). As per election schedule, nomination papers shall be presented from **05.11.2022 to 11.11.2022** and poll shall be held on **22.11.2022 and 25.11.2022**. Re-poll, if any, required, shall be held on **25.11.2022 and 27.11.2022** and counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations of the Gram Panchayat concerned. Counting for election of Members of 143 Panchayat Samitis and 22 Zila Parishads shall be held on **27.11.2022** at the place(s) specified by the Deputy Commissioner-cum-District Election Officer (Panchayat) concerned and result shall be declared immediately after the completion of counting.

 To facilitate voters and the staff on duty, it is essential that uninterrupted supply of electricity and drinking water is maintained from
21.11.2022 to 22.11.2022 and 24.11.2022 to 25.11.2022 in the area of the Panchayati Raj Institutions concerned and also uninterrupted supply of electricity and drinking water is maintained on 27.11.2022, the day of counting in all the districts in the State.

3. I have further been directed to request you to issue necessary directions to the field staff to ensure that supply of electricity and drinking water must not be interrupted during the election of Panchayati Raj Institutions concerned.
