Subject: Ban on Postings/Transfers of Officers/Officials who are engaged in conduct of General elections of the Panchayati Raj Institutions in the State of Haryana during the period of Model Code of Conduct is in force.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections for three tiers of Panchayati Raj Institutions in 4 districts, namely; Faridabad, Fatehabad, Hisar and Palwal vide Notification No.SEC/4E-II/2022/4332, dated 28.10.2022(copy enclosed). As per election schedule, nomination papers shall be presented from **05.11.2022 to 11.11.2022** and poll shall be held on **22.11.2022** and **25.11.2022**. Re-poll, if any, required, shall be held on **25.11.2022 and 27.11.2022** and counting of votes in respect of Panches and Sarpanches shall be held immediately after the close of poll at the polling stations of the Gram Panchayat concerned. Counting for election of Members of 143 Panchayat Samitis and 22 Zila Parishads shall be held on **27.11.2022** at the place(s) specified by the Deputy Commissioner-cum-District Election Officer (Panchayat) concerned and result shall be declared immediately after the completion of counting.

2. I have, therefore, been directed to request you that officers/officials of the State Government deputed to conduct the above said elections or connected with the conduct of these elections in any manner must not be transferred till the declaration of election results of the Panchayati Raj Institutions. However, in case, where it is considered necessary to transfer an officer/official connected with the above said Panchayat elections in larger public interest due to some emergency, prior written approval of the State Election Commission must be obtained. Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations, Autonomous Bodies/Authorities etc. of the State Government under intimation to the State Election Commission, Haryana.
