Subject:- General Elections of Panchayati Raj Institutions -- Declaration of Holiday on Poll Day.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for re-poll for the post of Panch, Ward No.4 & 6, Gram Panchayat, Lisana, Block Rewari, District Rewari vide Notification No.SEC/4E-II/2022/5665, dated 12.11.2022(copy enclosed). As per re-poll election schedule poll shall be held on 14.11.2022 and counting of votes shall be held immediately after the close of poll at the polling stations of the Gram Panchayat concerned.

2. I have, therefore, been directed to request you to declare 14.11.2022 a public holiday under section 135B of the Representation of People Act, 1951 applicable under section 173A of the Haryana Panchayati Raj Act, 1994 for all Government establishment, the factories, commercial establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction of the concerned Gram Panchayat, where re-poll shall be held on 14.11.2022, to enable Government employee, workers of the factories, commercial establishments, shops etc. located in the areas of the Panchayati Raj Institutions to cast their votes. Extract of section 173A of the Haryana Panchayati Raj Act, 1994 and section 135B of the Representation of People Act, 1951 is reproduced as under:-

Section 173A of the Haryana Panchayati Raj Act, 1994

"173A. Application for certain sections of Central Act 43 of 1951 to Haryana Act 11 of 1994:- The provisions of sections 20B, 33A, 134A, 134B, 135B and 135C of the Representation of the People

Act, 1951 (Central Act 43 of 1951), shall mutatis mutandis apply to the provisions of this Act: Provided that provisions of section 135B shall be applicable to the residents of the area".

Section 135B in the Representation of the People Act, 1951

"135B. Grant of paid holiday to employees on the day of poll.—

- (1) Every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at an election to the House of the People or the Legislative Assembly of a State shall, on the day of poll, be granted a holiday.
- (2) No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in accordance with sub-section (1) and if such person is employed on the basis that he would not ordinarily receive wages for such a day, he shall nonetheless be paid for such day the wages he would have drawn had not a holiday been granted to him on that day.
- (3) If an employer contravenes the provisions of sub-section (1) or sub-section (2), then such employer shall be punishable with fine which may extend to five hundred rupees.
- (4) This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged."
- 3. I have also been directed to request you that a copy of the orders issued in this respect may kindly be sent to the State Election Commission, Haryana, immediately.
