NOTIFICATION

No.SEC/3E-II/2023/814 In accordance with the provisions contained in Section 163 of Haryana Panchayati Raj Act, 1994 with rule 8 of the Haryana Panchayati Raj Election Rules, 1994 and powers conferred under sub-section(1) of section 212 of the Haryana Panchayati Raj Act, 1994, the State Election Commission, Haryana hereby directs for updating the existing photo based voters list of all wards of Gram Panchayat, Sambhalkha, Block Ladwa, District Kurukshetra published on 22.07.2022 by taking data base of the relevant part of the Legislative Assembly Constituency finally published on 05.01.2023 with qualifying date as 01.01.2023 with all supplements.

The existing photo based voters list of Gram Panchayat Sambhalkha, Block Ladwa, District Kurukshetra shall be amended and brought up to data with the help of National Informatics Center (NIC) by converting the relevant parts of the voters list of Legislative Assembly constituency finally published on 05.01.2023 into the wards of Gram Panchayat Sambhalkha with all supplements. The voters list shall be updated on the format attached at Annexure-'A' and in accordance with the procedure to be followed and schedule given here as under:-

1.	Existing voter list of Gram Panchayat, Sambhalkha published on 22.07.2022 shall be updated by taking into consideration the electoral rolls of Legislative Assembly published by the Chief Electoral Officer, Haryana with reference to 1st January, 2023 as qualifying date with all supplements finally published on 05.01.2023. List of new electors included/deleted in the relevant part of the electoral rolls of Legislative Assembly Constituency shall be prepared and will be published with existing voters list of the Gram Panchayat Sambhalkha as draft voter list. 2.	Publication of ward wise and booth wise draft voters list of all wards of the Gram Panchayat for inviting claims and objections. {rule 8(3)}.	03.04.2023
3.	Last date by which claims and objections shall be presented to the District Electoral Officer in the prescribed forms 1A & 1B {rule 8 (4) (i to vi)}.	10.04.2023 Upto 4.00 pm (excluding 04.04.2023 and 09.04.2023 being holidays)
4.	Last date by which claims and objections shall be disposed of by the District Electoral Officer {rule 8(4) (vii)}.	17.04.2023
5.	Last date for filing an appeal before Deputy Commissioner-cum- District Election Officer (P) against the decision of the District Electoral Officer (rule 8 (viii)).	20.04.2023
6.	Last date by which the appeals shall be disposed of by the Appellate Authority {rule 8(4) (ix)}.	25.04.2023
7.	Final publication of the voters list (rule 8 (4)(ix)).	28.04.2023

It is further directed that one set of electoral rolls of the Legislative Assembly 3 constituency prepared and published on 05.01.2023 alongwith supplements if any, by the Chief Electoral Officer, Haryana be obtained free of cost from the Tehsildar/ Naib Tehsildar (Elections) concerned. The data base of the Legislative Assembly electoral rolls uploaded on the server of NIC, Haryana shall be downloaded by District Informatics Officer concerned for this purpose.

- It is further directed that:-
 - (i) The Deputy Commissioner-cum- District Election Officer (Panchayat)

 concerned shall give wide possible publicity to the above programme by making Munadi in village, issue a press note and other handouts and also by inserting paid advertisements in two local newspapers. He shall also make publicity through electronic media.
 - (ii) The Deputy Commissioner-cum-District Election Officer (Panchayat) concerned shall publish booth wise and ward wise voter list, so prepared of the Gram Panchayat Sambhalkha as draft together with a notice including the dates by and the place where the claims and objections with reference to the draft voter list may be presented to the District Electoral Authority/ Authoritie(s).
 - (iii) The relevant portion of the draft voter list so published shall be made available to the following:
 - a. Two copies to Gram Sachiv concerned. One for affixing on notice board of the Gram Panchayat Office and another shall be retained by Gram Sachiv for inspection of general public free of cost for inviting claims and objections.
 - b. One copy to Block Development and Panchayat Offier for inspection of general public.
 - c. Two copies to District Election Officer (P) concerned. One for affixing on the notice board and another for inspection by the general public in his office.
 - (iv) After publication of booth wise and ward wise draft voter list, the same shall also be hosted on website of the District Administration.
 - (v) A copy of the draft and the final voter list duly signed by the District Electoral Officer along with database in compact disc shall be kept in sealed cover in the Treasury within 24 hours from the date of their publications.
 - (vi) In order to facilitate the voters and the public to obtain information regarding voter list and to file claims and objections, the Deputy Commissioner-cum-District Election Officer (Panchayat) concerned shall set up sufficient number of Voters Information and Collection Centres (VICCs) within territorial limits of these Institutions. These Centres shall be fully equipped with computers and broadband internet connection. The Centres will be set up with the help of National Informatics Centre.
 - (vii) Every claims and objections regarding distribution of voter list ward wise shall be addressed and presented to the District Electoral Officer in the prescribed Form 1A and 1B or may be sent by registered post to him.
 - (viii) Claims in Form 1A shall be filed by those applicants, who intend to include their name, make correction in their entry or transposing of their name in another ward in the list of voter.
 - (ix) Objections in Form 1B may be filed by that applicant who intends to object inclusion of name or seek deletion of a name from the voter list.
 - (x) Only those persons may file claims for inclusion of their name in the voter list of the Gram Panchayat, whose name appeared in the respective area of the electoral roll of Legislative Assembly, but do not appeared in the draft voter list published under rule 8(4) of the Haryana Panchayati Raj (Amendment), Rules, 2019.
 - (xi) The VICCs shall make available the prescribed forms, on demand free of cost, for filing claims and objections and receive the same for consideration and decision by the District Electoral Officer. These forms shall also be hosted on

- website of the District Administration for downloading the same for filing claims and objections.
- (xii) As and when any person files claim or objection, the official concerned shall give a receipt in the prescribed format given in the form. An entry shall also be made in the register accordingly.
- (xiii) The Deputy Commissioner-cum-District Election Officer (Panchayat) shall appoint one authorized officer not below Group-B for maximum up to three wards and sufficient number of supporting staff to assist the District Electoral Officer to discharge his duty.
- (xiv) The District Electoral Officer shall, after holding such enquiry into the claims or objections as he think(s), fit record his decision in writing and shall make available forthwith a copy of such decision to the objector or the claimant free of charge. The decision of the District Electoral Officer shall also be hosted on website for the information of public. The number of claims/objections accepted or rejected along with decision of the Appellate Authority shall also be hosted on website of the District Administration under intimation to the Commission in Annexure-B.
- (xv) The District Electoral Officer after disposal of all claims and objections shall forward a list of such claims and objections along with his orders passed thereon to the Deputy Commissioner-cum-District Election Officer (Panchayat) aggrieved by such order of the District Electoral Officer may, within the prescribed period to the Deputy Commissioner-cum-District Electoral Officer (Panchayat) who shall within the specified period decide the appeal. The decision of the Appellate Authority on appeal shall be final. The voter list so amended shall be final and two copies thereof duly signed by the Deputy Commissioner-cum-District Election Officer (Panchayat) and the District Electoral Officer shall be kept in their offices together with list of additions and correction prepared in accordance with the said orders.
- (xvi) The Deputy Commissioner-cum-District Election Officer (Panchayat) shall publish the final voter list on 28.04.2023 which shall come into force from the date of its publication.
- (xvii) After completion of every stage of the preparation of the voter list process as stated above, Deputy Commissioner-cum-District Election Officer (Panchayat) shall send information to the Commission in the format in Annexure "C"
- 6. It is further directed that a copy of booth wise and ward wise updated voter list of Gram Panchayat, finally published on 28.04.2023 shall be supplied to the State Election Commission on the same day. In addition, a copy of the finally published voter list alongwith a CD (compact disc) containing the database of the same in PDF format shall be sent to all the political parties in the Haryana State.
- 7. It is further directed that the final voter list of Gram Panchayat shall be hosted on the website of the District Administration.
