PREFACE

The State Election Commission, Haryana is a constitutional body responsible for the conduct and supervision of elections to the Panchayati Raj Institutions (Gram Panchayats, Panchayat Samities and Zila Parishads) and Urban Local Bodies (Municipal Committees, Councils and Corporations) in the State of Haryana.

This report pertains to the First General Elections of seven newly constituted Municipal Corporations, namely Ambala, Karnal, Hisar, Panipat, Panchkula, Rohtak and Yamunanagar. The polling took place on June 2, 2013 and results were declared on June 4, 2013.

During the last five years, the Commission had taken numerous steps to simplify the process of conducting the PRIs and ULBs elections and making them more public friendly and transparent. For the first time, the electoral rolls of the seven Corporations were prepared and published ward-wise and polling station-wise and also hosted on website of the district administration. Earlier, the practice was to make ward-wise electoral rolls and a few days before the polling day, they used to be divided polling station-wise. The new practice improved the public satisfaction. Secondly, information and communication technologies (ICT) were extensively used to simplify the procedures and all important election related documents and information were hosted on the net.

For the benefit of the general public, the wards and the polling stations were mapped using the GIS techniques and put on the Google Earth along with their pictures and electoral rolls with convenient search facility. With the help of the National Informatics Centre, Haryana, a web based election management and monitoring solution, e-Dashboard, was developed to track the various operations involved in conducting the poll. Several modules of the dashboard were open to the public and anyone could visit the website for a variety of information related to the elections. For instance, a hyperlink on a candidate's name led to the details of all the candidates contesting from that particular wards and hyperlink on Corporation's name displayed full list of wards in the Municipal Corporation, status of the contesting candidates etc.

This report is also unique in a few other ways. It gives statistics on various attributes of the contesting and winning candidates, such as age, gender, political affiliation, educational qualifications, occupation, moveable and immovable assets. Such a huge data on several attributes has been collected, compiled, analyzed and presented in an easy to read and comprehend format.

I hope that the present report would prove to be a valuable asset for the field officers, especially Divisional Commissioners, Inspectors General of Police, Police Commissioners, Deputy Commissioners, Revising Authorities, and District Superintendents of Police as important guidelines with details have been incorporated in the various chapters of the report. The report shall also be useful for scholars of universities, colleges and research institutions, who may be interested in grass-root democratic processes in urban areas.

For the benefit of the public, the report has also been hosted on the Commission's website, www.secharyana.gov.in.

For the successful organization of the first general elections of the seven Municipal Corporations, I would like to put on record my appreciation of the assistance rendered by all the officers and the staff of the State Election Commission and field offices, and especially Inspectors General of Police, Police Commissioners, Deputy Commissioners, Superintendents of Police, Sub-Divisional Magistrates and City Magistrates.

This unique document could not have been prepared without the whole hearted assistance and hard work of the officers and staff of the State Election Commission in general and in particular S/Sh. Ghan Shyam Bansal, Director, Pardeep Kumar Kaushal, PSA of the NIC, Deep Chand, Deputy Director (Retired), Department of Economic & Statistical Analysis, Haryana, Parmal Singh, Assistant State Election Commissioner and Vijay Kumar Bansal, Superintendent of the Commission.

The Commission would welcome feedback from readers and users of the report for making improvements while bringing out similar reports in future.

INTRODUCTION

- 1.1 Elections play an important role in a democratic set up and are its lifeline. It is only through the elections that the true wishes and the will of the people in the matter of choosing their representatives is reflected and the aims of democracy realized. The conduct of elections in a free, fair, transparent and impartial manner is, therefore, imperative and assumes significance, especially in the context of proper functioning of the local bodies.
- 1.2 In Article 40 of Constitution of India, under Part IV-Directive Principles of State Policy, there is a special provision relating to 'Panchayats', which provides that the State shall take steps to organize 'Village Panchayats' and endow them with such powers and authorities as may be necessary to enable them to function as units of self-government. In pursuance of this constitutional provision, the State Governments had enacted the laws for establishing village panchayat, block samiti and zila parishad (commonly known as Panchayati Raj Institutions) at village, block and district levels respectively. Likewise, the States had enacted the laws for the constitution of municipal bodies, i.e. municipal committees, councils and coprorations (Urban Local Bodies).
- 1.3 However, both Panchayati Raj Institutions and Urban Local Bodies had become weak and ineffective as institutions of local self-government in rural and urban areas. Their elections were not held on a regular basis and several bodies were superseded and remained in the administrative control of bureaucracy and government for a very long period. Neither proper devolution of funds was made available to them, nor the required administrative and financial powers delegated to them.
- 1.4 In view of several defects in the legal framework and shortcomings in their functioning, the Panchayati Raj Institutions (PRIs) and Urban Local Bodies (ULBs) were not able to live up to the expectations of the people as well as the founding fathers of the Constitution.
- 1.5 It was, therefore, felt that the basic and essential features of the PRIs and the ULBs, such as certainty of tenure, continuity and financial and administrative authority, should be provided Constitutional safeguards. For this purpose, the Constitution was amended by the Constitution (Seventy Third) Amendment Act, 1992 and the Constitution (Seventy Fourth) Amendment Act, 1992 in respect of the PRIs and the ULBs respectively. After the ratification by the requisite number

- of the State Legislatures, the Seventy Third and Seventy Fourth Amendments came into force on April 24, 1993 and June 1, 1993 respectively.
- 1.6 Four most significant features of the two amendments are (1) constitution of an autonomous body "State Election Commission" under Articles 243K and 243ZA of the Constitution of India in every State for conducting elections to the PRIs and the ULBs, (ii) superintendence, direction and control of the preparation of electoral rolls for, and the conduct of, elections to PRIs and ULBs to vest in State Election Commission, (iii) holding of elections to the Panchayati Raj Institutions and urban local bodies at an interval of every five years without break and (iv) reservation of seats and offices including those of Chairpersons of such bodies for the Scheduled Castes, Scheduled Tribes and Women. With the two constitutional amendments, it is now not possible for State Governments to curtail or enhance the life of the elected bodies of the PRIs and the ULBs beyond the period of five years and also to postpone their elections.
- 1.7 At the time of the Seventy Fourth Amendment Act, there was no municipal corporation in the State. However, there existed a municipal body for Faridabad city. This was known as Faridabad Complex Administration, which was set up under the Faridabad Complex (Regulation and Development) Act, 1971 (Act No.42 of 1971) and notified by the Government on November 16, 1971. After the Seventh Fourth Constitutional Amendment, this Act was repealed and a new Act with the name of "The Haryana Municipal Corporation Act, 1994 was made. This Act was notified vide Notification No.Leg.21/94, dated October 22, 1994 and deemed to have came into effect on May 31, 1994. According to the Section 3(1) of the the Act ibid, which deals with the declaration of municipal area as Corporation, the Municipal Corporation of Faridabad is deemd to have been declared as such with effect from May 31, 1994, for the municipal area specified in the First Schedule appended with the Act ibid.
- 1.8 All the necessary provisions contained in the Seventy Fourth Amendment Act relating to the matters of constitution and composition of the municipalities and their wards etc., reservation of seats, duration of municipalities, disqualification of members, powers, authorities and responsibilities of municipalities, power to impose taxes by, and funds of municipalities, constitution of Finance Commission, audit of accounts of municipalities, elections of municipalities, committee for

- district planning, bar to interference by Court in the electoral matters etc., were incorporated in the Act of 1994 ibid.
- 1.9 The State Election Commission in the State of Haryana was constituted by the State Government vide Notification No. No.SO.101/Const/Art.243K/ 243ZA/93 dated November 11, 1993 with effect from November 18, 1993.
- 1.10 The provisions relating to the status and powers of the State Election Commission in Article 243K and 243ZA are analogous to that of the Election Commission of India provided under Article 324 (1) of the Constitution of India. The only difference in the two provisions is that the State Election Commission has been entrusted with the responsibility for the preparation of the electoral rolls for, and the conduct of, all elections to the Panchayati Rai Institutions and Municipalities under Articles 243K and 243ZA, whereas the Election Commission of India has been assigned the responsibility for the preparation of electoral rolls for, and the conduct of, all elections to Parliament and to the Legislatures of every State and of elections to the offices of President and Vice President of India. In order to ensure that the State Election Commission functions as an independent Constitutional body outside the control of executive and to enable it to conduct the elections to the Panchayat and municipalities in a free and fair manner, the concept of independence has been made explicit in the provisions of Article 243K(2). This Article provides that the State Election Commissioner shall not be removed from his office except in the like manner and on the like grounds as the Judge of a High Court and the conditions of service of the State Election Commissioner shall not be varied to his disadvantage after his appointment. The State Election Commission, unlike the Election Commission of India, is a Commission headed by the State Election Commissioner, who is appointed by the Governor of the State under clause (2) of Article 243K of the Constitution of India. Clause (3) of Article 243K explicitly provides that the Governor of the State shall, when so requested by the State Election Commission, make available to the State Election Commission such staff as may be necessary for the discharge of functions conferred on the State Election Commission by clause (1).
- 1.11 Since the constitution of the State Election Commission, the incumbency position of the State Election Commissioners is as under:-

- a. Shri J. K. Duggal, IAS (Retired) officer of 1963 batch of Haryana Cadre, from July
 15, 1994 to July 14, 1999. During his tenure, the First General Elections to Urban Local Bodies were conducted in the year 1994.
- Shri T. D. Jogpal, IAS (Retired) officer of 1968 batch of Haryana Cadre, from July
 14, 1999 to July 14, 2004. During his tenure, the Second General Elections to
 Urban Local Bodies were held in the years 2000, 2003 and 2004.
- c. Shri Chander Singh, IAS (Retired) officer of 1973 batch of Haryana Cadre, from September 14, 2004 to November 7, 2009. During his tenure, the Third General Elections to the Urban Local Bodies were held in the years 2005, 2007, 2008 and 2009.
- d. Shri Dharam Vir, IAS (Retired) officer of 1973 batch of Haryana Cadre, from November 9, 2009 onwards. Prior to this assignment he was Chief Secretary to the Government of Haryana. During his tenure, the Fourth General Elections to the Urban Local Bodies and Panchayati Raj Institutions were held in May, 2010, December, 2010 and June, 2013.
- 1.12 The State Election Commissioner is supported by a team of 64 officers and officials at the Headquarter and 13 officials at field offices. The details are given in Annexure 1.1.
- 1.13 At present, there are nine municipal corporations in the State: Faridabad, Gurgaon and seven new corporations namely, Ambala, Hisar, Karnal, Panchkula, Panipat, Rohtak and Yamunanagar, constituted by the State Government on March 17, 2010, vide notification No. 18/1/2010-3CI, No. 18/5/2010-3CI, No. 18/3/2010-3CI, No. 18/2/2010-3CI, No. 18/4/2010-3CI, No. 18/6/2010-3CI and No. 18/7/2010-3CI respectively. The new coprorations had the first general elections on June 2, 2013. The Faridabad and Gurgoan Corporations had their general elections in the years 2010 and 2011 respectively.
- 1.14 The notification dated March 17, 2010 of the State Government regarding constitution of Panchkula Municipal Corporation was challenged through three Civil Writ Petitions (No. 5149 of 2010 V. K. Kapoor & Others Vs. State of Haryana, No. 2493 of 2010 Vijay Bansal Advocate & Others Vs. State of Haryana and No. 5235 of 2010 -V. K. Sood & Others Vs. State of Haryana). The notification was quashed by the Hon'ble High Court vide its order dated October 29, 2010. The operative part of the judgment is as follows:

"Thus, viewing the case from all angles it would have to be held that memo no.18/1/95/2008-3C, dated January 18, 2010 (Annexure P-6) and notification dated March 17, 2010 (Annexure P-7) are in clear cut contravention of 73rd and 74th amendment of the Constitution so also the guidelines as well as the aforesaid provisions of the 1973 Act and the 1994 Act, therefore, the same are hereby quashed. However, the State Govt. would be at liberty to issue fresh notification after following due procedure as provided under the aforesaid Acts and Guidelines and in accordance with the principles of natural justice. It is further made clear that any development scheme would not be hammered and the funds allocated to the town of Panchkula under the JNNURM. Scheme would not go unutilized. Rather, such development schemes would remain in operation and remain unaffected the process to constitute the Municipal Corporation, Panchkula is in operation."

- 1.15 The State Government challenged the above order in the Hon'ble Supreme Court of India through Special Leave Petition (Civil) No. 164-166 of 2011 (State of Haryana and Others Vs. V. K. Kapoor and Others). Hon'ble Supreme Court stayed the operation of the order on August 10, 2011. The Panchkula Corporation has, therefore continued to function as such. The SLPs are still pending in the Hon'ble Supreme Court.
- The wardbandi (delimitation) of all the seven new corporations were notified in the month of Januray, 2013. Immediately thereafter, the State Government, vide Letter No. 18/8/2013-3C1 dated January 17, 2013, conveyed 'no objection' to conduct of the General Election, 2013 of these corporations before March 16, 2013. Within this time period, it was not possible to conduct the elections as the time was not sufficient to prepare electoral rolls. Besides, examinations of the Central Board of Secondary Education and the Haryana Board of Secondary Education were likely to be over by first week of April, 2013. Therefore, the Commission proposed to conduct the elections during April, 2013 or by middle of May, 2013. Accordingly the Government amended the Haryana Municipal Corporations Act, 1994 by inserting the words "3 years and 3 months" for the words "3 years" and vide its letter No. 18/8/2013-3C1, dated April 3, 2013, conveyed no objection for conducting general elections before June, 2013.

- 1.17 The State Election Commission, vide notification No.SEC/2ME/2013/188, dated January 21, 2013, issued the programme for preparation of electoral rolls in all the wards of the seven Municipal Corporations on the basis of Assembly electoral rolls finally published on January 15, 2013. The electoral rolls were finally published on March 15, 2013.
- 1.18 In the meantime, the wardbandi of Municipal Corporations, Panchkula and Hisar were challenged in the Hon'ble High Court through two writ petitions (CWP No.1905 of 2013, Inderjeet Singh Vs. State of Haryana and CWP No. 2824 of 2013, Pankaj Diwan Vs. State of Haryana) on the ground that wardbandi be made on the basis of Census of 2011.
- 1.19 Since there was no stay, the Commission, vide its notification No. SEC/1ME/2013/2387, dated May 9, 2013, issued the election programme for the conduct of elections in all wards of seven municipal corporations. According to this programme, the elections were scheduled to take place on June 2, 2013.
- 1.20 Seven CM No.7635, 7636, 7587, 7588, 7601, 7602, 7494 of 2013 were filed challenging the election programme in the High Court issued by the Commission. Hon'ble High Court passed an interim order dated March 18, 2013 with the direction that the elections, if held, shall be subject to final outcome of the writ petition and respondents shall not be entitled to take objection that the alternative remedy of election petition is available to the petitioner(s). Thereafter the elections were held on June 2, 2013 as per schedule. The writ petitions and the CMs were finally decided by the Hon'ble High Court on August 7, 2013. The operative portion of the order of the High Court is as follows:-

"In view of the above, no case is made out for interference of this Court in the process, in exercise of extra ordinary jurisdiction under Articles 226 and 227 of the Constitution of India, more so when elections to the seven corporations have already been held and the respondents are expected to hold the next elections on the basis of 2011 census. The writs petitions, therefore, fails and are dismissed."

1.21 This report relates to the first general elections of the seven Municipal Corporations namely Ambala, Hisar, Karnal, Panchkula, Panipat, Rohtak, Yamunanagar.

Chapter-2

DE-LIMITATION AND RESERVATION

- 2.1 The delimitation and reservation of wards are the first requisite for holding any election of a municipal body. In accordance with the provisions of Sections 6 and 11 of the Haryana Municipal Corporation Act, 1994 and Rule 3 of the Haryana Municipal Corporation De-limitation of Ward Rules, 1994, this function has been assigned to the State authorities.
- 2.2 Norms for Number of Wards Section 6 of the Act ibid provides that after every census, the total number of seats of a Corporation shall be fixed by the State Government on the basis of the latest census figures. If certain area is included within, or excluded from the limits of a municipal area, the population shall be ascertained on the spot in respect of such area and shall be added to or excluded from the latest census figures of that Corporation for the purpose of re-fixation of seats. The number of wards is fixed or refixed in accordance with the formula given below:-

The number of seats for members belonging to the Scheduled Castes shall be fixed in accordance with the following formula:-

Total number of seats x Population of Scheduled Castes Total Population

- 2.3 **Delimitation Committee** Rule 4 of the rules ibid provides as under:-
- 2.3.1 For the purpose of carrying out the provisions of these rules, the Government shall constitute an Adhoc Body for each Corporation consisting of the following members, namely:-

a. Deputy Commissioner	Chairman
b. Mayor or any member or his representative	Member
c. Director, Local Bodies or his representative	Member
d. Commissioner or his representative not below the	Member
rank of Extra-Assistant Commissioner	

- 2.3.2 The Ad-hoc Body shall associate with itself not more than five members belonging to various interests or groups out of the sitting members of the Corporation or not of the member of the dissolved Municipalities.
- 2.3.3 If municipality mentioned in sub-rule (2) of the above rule does not exist, the Ad-hoc Body shall associate with itself not more than five members belonging to various interests or groups from Municipal area.
- 2.4 **Principles for Delimitation** Rule 7 of the rules ibid provides that the following principles shall be observed by the Ad hoc body in carrying out the delimitation of wards of a Corporation :-
- (a) Wards shall, as far as practicable, be geographically compact areas, and having regard to physical features, existing boundaries of administrative units, if any, facilities of communication and public convenience,
- (b) The population of each ward, as far as practicable, should be the same throughout the municipal area with a variation upto 10 per cent above or below the average population per ward, and
- (c)Wards reserved for the members of Scheduled Castes and Backward Classes shall as far as practicable be located in those areas where population of persons belonging to these categories is maximum.

- 2.5 The proposal for delimitation of wards of the Corporation prepared by the Adhoc Body is submitted to the government for consideration, and after the government's approval, it is published in the official gazette for eliciting objections or suggestions from the public. After considering all objections and suggestions that are received, the final order made by the government for the delimitation of wards of the corporation is published.
- 2.6 The Urban Local Bodies Department completed the delimitation of wards of all seven municipal corporations in accordance with the rules and notified the same vide notifications mentioned in Table 2.1.

2.7 Reservation of Seats and Office of Mayor of Corporation - Article 243T of the Constitution of India provides for reservation of seats and the offices of chairpersons in municipalities for the Schedule Castes, the Scheduled Tribes and women. According to Clause 6 of this Article, the Legislature of a State can make any provision for reservation of seats and Chairpersons in any municipality. Accordingly, provision for the reservation of seats and Mayor for Scheduled Castes, women and backward classes in a corporation has been made in the Section 11 of the Haryana Municipal Corporation Act, 1994. In brief, details are as under:-

Seats

2.8 Section 11(1) - Seats shall be reserved for the Scheduled Castes in the Corporation and the number of seats so reserved shall be, as nearly as may be, the same proportion to the total number of seat to be filled by direct election in the Corporation, as the population of that area and such seats may be allotted by

- rotation to such wards having maximum population of persons belonging to Scheduled Castes.
- 2.9 Section 11(2) Not less than one-third of the total number of seats reserved for Scheduled Castes shall be reserved for women belonging to the Scheduled Castes and such seats may be allotted by rotation and by lots amongst the wards reserved for them.
- 2.10 **Section 11(3) -** Not less than one-third (including the number of seats reserved for women belonging to the Scheduled Castes) of the total number of seats to be filled by direct election in the Corporation, shall be reserved for women and such seats may be allotted by rotation and by lots to different wards in the Corporation except those falling under sub-sections (1), (2) and (4).
- 2.11 Section 11(4) Two seats in the Corporation shall be reserved for the persons belonging to Backward Classes which shall be allotted in such wards as having maximum population of persons belonging to Backward Classes.

Mayor

2.12 Section 11(5) and Rule 71 - The office of Mayor shall be filled up from amongst the members belonging to the General Category, Scheduled Castes, Backward Classes and women by rotation and by lots in the manner as may be prescribed. This has been prescribed in Rule 71(6), according to which rule, this will be determined through a draw of lots by the committee consisting of the Commissioner of the Division, Deputy Commissioner of the District and the Commissioner of the Corporation concerned, provided that once the Mayor is elected from the category then that category shall not be included in the next draw of lots. The election of Mayor is not conducted by the Commission.

General

- 2.13 **Section 11(7) -** The reservation of seats and the office of Mayor shall be given effect to, through notification issued at the time of each election.
- 2.14 **Number of Seats Reserved in Seven Corporations** The number of seats reserved for different categories in the seven Municipal Corporations is given in Table 2.2.

Chapter-3

PREPARATION AND PRINTING OF ELECTORAL ROLLS

- 3.1 Electoral rolls, commonly known as voters' lists, which list out the names of electors, i.e voters, who are eligible to cast their votes, are another set of essential document for conducting an election in a free and fair manner. The preparation of electoral rolls is a six stages' process, i.e. (i) preparation of draft electoral rolls for inviting claims and objections, (iii) publication of draft electoral rolls for inviting claims and objections, (iv) appeal against the order of Revising Authority, on claims and objections, (iv) appeal against the order of Revising Authority before the Deputy Commissioner concerned and decision on the appeals and (vi) final publication of electoral rolls.
- 3.2 **Legal Provisions -** Rules 3 to 19 of the Haryana Municipal Corporation Election Rules, 1994 lay down the procedure for the preparation, revision, correction, custody and preservation of the electoral rolls of Municipal Corporations. The salient features are as under:-
 - (i) Rule 4(1) The Deputy Commissioner shall, under the superintendence, direction and control of the State Election Commissioner, Haryana, cause to prepare roll for each constituency of the Corporation in accordance with these rules.
 - (ii) Rule 4(2) The rolls shall be prepared in Hindi or in such other language(s) and in such form as the State Election Commission may direct. The Commission has decided that electoral rolls shall be prepared in Hindi language.
 - (iii) Rule 5 Disqualifications for Registration in Electoral Roll This rule prescribes disqualifications for registration of a person in the electoral roll. They are (a) if he is not a citizen of India or (b) he is of unsound mind and stands so declared by a competent court, or (c) he is for the time being disqualified for voting under the laws relating to corrupt practices and other offences in connection with elections including Parliamentary and State Assembly elections or (d) he is less than eighteen years of age on the qualifying date.
 - (iv) **Rule 6** Qualifications for Registration in Electoral Roll This rule prescribes the qualifications for registration of an elector in the electoral

rolls i.e. every person who is not less than 18 years of age on the date of qualifying date (January 1 of the year in which the electoral rolls are to be prepared or revised) and is an ordinary resident in a ward shall be entitled to be registered in the roll for that ward.

- (v) Rule 8 Revising Authority The Deputy Commissioner may appoint any gazetted officer to be Revising Authority for the purpose of hearing claims and objections relating to roll and may specify the ward or wards for which he shall be the Revising Authority.
- (vi) Rule 9 Claims and Objections A person willing to register his name in the roll of the wards shall have to submit his application in the prescribed form 'A'. One can also file objection in form 'B' against inclusion of any name in the roll. In addition, an objection to a particular or particulars in an entry in the roll can also be filed in form 'C'. All such claims and objections are required to be presented to the Revising Authority or sent by registered post to him within the time prescribed by the District Election Officer in the notice issued for the preparation of the electoral rolls.
- 3.3 **Punishment for Making False Declaration -** Section 8C of the Haryana Municipal Corporation Act, 1994 provides that if any person makes a false declaration in connection with any of the following:-
 - (a) the preparation, revision or correction of an electoral roll and
 - (b) the inclusion or exclusion of any entry in or from an electoral roll,
 - a statement or declaration in writing, which is false and which he either knows or believes to be false or does not believe to be true, he shall be punishable with imprisonment for a term which may extend to one month, or with fine which may extend to one thousand rupees, or with both.
- 3.4 **Procedure for Preparation of Electoral Rolls** In the past, the electoral rolls of the Municipal Corporations used to be prepared by carrying out door to door survey. Besides being time consuming and expensive, this process involved deployment of huge manpower for a long period and the possibility of errors could not be ruled out. On the recommendation of the Commission, Rule 4 of the rules was amended by the State Government, vide its Notification No. SO 65/HA/16/1994/S.32/2012, dated August 31, 2012. According to the

notification, the electoral roll of a Corporation shall be prepared on the basis of Assembly rolls prepared under the provisions of the Representation of People Act, 1950 (Central Act, 43 of 1950), for the time being in enforce for such part of the constituency of the Assembly as is included in the relevant electoral division, subject to any amendment, deletion or addition or any inclusion of any name and same shall be the draft electoral roll for that constituency of the Corporation. Application form for claim was inserted on the pattern of the form available for the Assembly rolls. This amendment made the preparation of draft electoral rolls public friendly, simpler, cost effective and reliable.

- 3.5 Before notifying the programme for the preparation of electoral rolls, the State Election Commissioner held a detailed meeting (video conference) with the Deputy Commissioners (DCs) concerned on January 8, 2013 and the decisions taken in the meeting were conveyed vide letter No. SEC/2ME/2013/285-94, dated January 24, 2013, which, in brief, are as under:
 - a. Electoral rolls of the Municipal Corporations shall be prepared with photo images of the electors on the basis of the latest database of the Assembly electoral rolls to be prepared with January 1, 2013 as qualifying date and to be published on January 15, 2013 by the Chief Electoral Officer, Haryana. The latest databases and sufficient number of copies of electoral rolls of Assemblies should be obtained from the Chief Electoral Officer, Haryana.
 - b. The electoral rolls of the Assemblies are polling station-wise, whereas the rolls of the Municipal Corporations shall be prepared ward-wise. The list of Assembly electoral rolls shall be converted in to ward-wise rolls for the Municipal Corporation concerned. This practice has been adopted in the past and the help of the National Informatics Center (NIC) may be obtained, wherever required.
 - c. The DCs should not entrust the work of preparation of electoral rolls solely to the Corporation staff. They should identify a competent officer of higher level to act as nodal officer and sufficient number of dedicated officers to function as Revising Authorities as well as officials and computer professionals to prepare draft electoral rolls. While doing so, they could take the help of the NIC staff and the Municipal Corporation concerned wherever required.

- d. The Revising Authorities shall be responsible for the preparation of draft voter list of the wards assigned to them. This is a very crucial step and all efforts should be made to prepare the draft voter lists as correct as possible.
- e. After publication of draft roll, the claims and objections are required to be heard by the Revising Authority. Here comes the role of Booth Level Officers (BLOs). The Revising Authorities should not blindly depend on the report of the BLOs and take decision after proper application of mind.
- f. For the facilitation of the public to get information about electoral rolls and to file claims and objections, sufficient number of Voter Information and Collection Centers (VICCs) shall be set up in the territorial jurisdiction of the Corporation. Every Center shall be equipped with a computer and broadband internet connection and manned by an efficient and intelligent computer operator and a government official. Sufficient number of copies of Forms A, B and C along with guidelines of the Commission shall be made available at the Centers for the use of the general public on demand. The VICCs shall receive claims and objections from the public and issue receipt. Therefore, the immediate task is to identify the numbers of VICC to be set up, their locations and staff so that they become functional as soon as the draft voter lists are notified.
- g. A round the clock helpline shall be established to provide information and assistance on phone to the public.
- h. To ensure that a person is not entered in more than one ward and in other parts of the district, de-duplicate software would be run on district basis. If duplicate name (s) is found, the same should be deleted after giving a notice to the concerned persons.
- i. Every Center shall maintain a register of claims/objections presented in person and enter the same online system/Harsamadhan.
- 3.6 **Programme for the Preparation of Electoral Rolls** As stated in para 2.6 of Chapter 2, the wardbandi (delimitation) of the Corporations were notified on January 16, 2013 and January 17, 2013. Soon thereafter, the programme for preparation of electoral rolls of seven Municipal Corporations was issued by the

Commission vide its Notification No.SEC/2ME/2013/188, dated January 21, 2013. The Deputy Commissioners concerned were directed to prepare the draft electoral rolls on the basis of the Assembly Electoral Rolls published on January 15, 2013 with January 1, 2013 as qualifying date and by deleting the names of persons, who had died and also of those who are found to be no longer ordinarily resident in the territorial limits of the Municipal Corporations. The electoral rolls were to be prepared according to the following programme:-

In addition, the following directions were issued to them:-

- (i) The Deputy Commissioner shall give wide publicity to the above programme. He shall issue press notes and paid advertisements in two local newspapers. He shall also make publicity through local cable network.
- (ii) The Deputy Commissioner shall publish on the date prescribed in subpara (ii) of para (2) of the notification, the draft voter list along with a notice including the dates by and the places where the claims and objections with reference to the draft rolls may be presented to the Revising Authority/Authorities.
- (iii) One copy of the draft electoral roll, published for inviting claims and objections, shall be kept for inspection of the public free of cost at the following places:
 - a. Office of Deputy Commissioner,

- b. Office of the Commissioner, Municipal Corporation concerned,
- c. Office of Sub-Divisional Officer (Civil)'s concerned,
- d. Tehsil Office concerned,
- e. Office of Revising Authority/Authorities, and
- f. Voter Information and Collection Centers (VICCs).
- (iv) After the publication of the draft ward-wise electoral rolls, the same should also be hosted on the websites of the District Administration and the State Election Commission for the information of the public.
- (v) A copy of the draft and final rolls along with database in compact disc (CD) duly signed by the Revising Authority/Authorities shall be kept in a sealed cover in the Treasury within twenty four hours from the dates of the publication of draft and final electoral rolls.
- (vi) In order to facilitate the electors and the public to obtain information regarding electoral rolls and to file claims and objections, the Deputy Commissioner concerned shall set-up suitable number of Voters Information and Collection Centers (VICCs) within the territorial limits of the Municipal Corporation concerned. These Centers shall be fully equipped with computers and broadband internet connection. The Centers will be set up with the help of the National Informatics Center.
- (vii) Any person, who desires to file his claim and objection online, can submit his application on Harsamadhan by the date specified in this notification. Such persons would have to appear before the Revising Authority/Authorities or at the VICC concerned along with filled up form as prescribed in the Rules.
- (viii) The VICCs will make available the prescribed forms, on demand, free of cost, for filing claims and objections and receive the same for the consideration of and decision by the concerned Revising Authority or the officers authorized for this purpose. The forms shall also be hosted on the website of the State Election Commission and the District Administration and can be downloaded and used by any person for filing claim and objection.

- (ix) As and when any person files claim and objection, he shall be given a receipt in the prescribed format given in the form 'A'. An entry shall also be made in internet based monitoring system and manual register.
- (x) The Deputy Commissioner shall appoint one Authorized Officer not below Group-B category for maximum up to three wards and sufficient number of supporting staff and other officials of Municipal Corporation to assist the Revising Authority/Authorities to discharge his/their duty.
- (xi) The Revising Authority/Authorities shall, after holding such enquiry into the claims or objections as he/they thinks fit, record his decision in writing and shall make available forthwith a copy of such decision to the objector or the claimant free of charge. The decision of the Revising Authorities shall also be hosted on the website for the information of the public. Number of claims/objections accepted and rejected shall also be hosted on the website of the District Administration. The software to be used for this purpose shall be provided by the National Informatics Center, Haryana.
- (xii) The Revising Authority/Authorities after disposal of all the claims and objections in terms of under Sub-rule(1) of Rule 10 of the Haryana Municipal Corporation Election Rules, 1994 shall forward a list of such claims and objections along with his/their orders thereon to the concerned Deputy Commissioner. Any person aggrieved by any such order of the Revising Authority/Authorities may, within the prescribed period, file an appeal to the Deputy Commissioner. The Deputy Commissioner shall within the specified time decide the appeals. The decision of the Deputy Commissioner on appeals shall be final.
- (xiii) The Deputy Commissioner shall publish the final electoral rolls on March 15, 2013, which shall come into force immediately after the publication.
- (xiv) After completion of every stage of the preparation of electoral rolls process as stated above, the concerned Deputy Commissioner shall send information in the prescribed format to the State Election Commission, Haryana.
- (xv) A copy of ward wise electoral rolls of the Municipal Corporation finally published on March 15, 2013 shall be submitted to the State Election

Commission, Haryana and two copies of the electoral rolls along with a CD (compact Disc) containing the database of the same in the PDF format shall be sent to all the political parties in the State on the same day.

3.7 The representatives of a few political parties met the State Election Commissioner on February 13, 2013, with the request to extend the time for filing claims and objections. After considering their request, the programme for preparation of electoral rolls was revised vide notification No.SEC/2ME/2013/812, dated February 14, 2013 as under:-

3.8 The teams of the Commission inspected the preparation of electoral rolls of the seven Corporations and a checklist was also provided to the Deputy Commissioners to submit the information relating to electoral rolls. Some of the Deputy Commissioners sought time for the disposal of large number of claims and objections. After considering their requests, the programme for the preparation of electoral rolls of the Municipal Corporations was further revised vides notification No. SEC/2ME/2013/971, dated February 27, 2013 as under:

3.9 Vide No.SEC/2ME/2013/923-929, dated February 21, 2013 had asked the Deputy Commissioners to send their report on the profoma of nineteen checklist points prescribed by the Commission. A copy is annexed as annexure 3.1.

- 3.10 The wok of preparation of electoral rolls was reviewed in the meeting held on February 28, 2013 at Ambala and vide letter No.SEC/2ME/2013/1121-26, dated March, 05, 2013, the following directions were issued to all the Deputy Commissioners:
 - (i) Updating of all claims, objections and decisions on the website It should be ensured that data entry of all claims/objections and the decisions thereon have been uploaded on the website of the District Administration and the Harsamadhan.
 - (ii) **Duplicate voters** The de-duplication software should be run on district basis and not Municipal Corporation area basis only. All duplicate voters should be meticulously identified and steps taken to weed out the bogus and duplicate voters after affording them an opportunity of being heard. Physical verification through committee(s) headed by a responsible gazetted officer should also be done.
 - (iii) Shifting of voters from one ward to another The claims and objections in this regard should be decided after affording an opportunity of hearing to affected persons and verifying facts physically. A notice in this regard should also be issued through press.
 - (iv) Voters without addresses The voters without address should be got meticulously verified by a committee of three officials headed by a gazetted officer and necessary action be taken immediately.
 - (v) **GIS application** The wards and polling stations of the Municipal Corporation shall be put on the Google Earth using GIS techniques with the location etc. The Deputy Commissioner and the NIC should get the software from Chief Electoral Officer, Haryana for this purpose. In case of any difficulty, they should contact Director, National Informatics Center, Haryana or the State Eelection Commission, Haryana.
 - (vi) While publishing the final voters' list ward wise, the polling station-wise lists should also be published. Both these list should also be hosted on the websites of the District Administration and the State Election Commission.
 - (vii) A copy of the final rolls along with the compact disc (CD) shall be made available to all the recognized political parties on the day of final

publication of the rolls. The persons, whose claims are received after the closing date of presenting claims and objections, should be informed to file applications under Rule 14 of the rules ibid after the publication of rolls.

- (viii) The officers responsible for preparation of rolls should carry out inspection of the rolls and documents to ensure error free rolls.
- (ix) No supplements of addition, deletion, correction, shifting etc. shall be printed, as the final electoral roll of each ward shall also be published polling station wise. The decision of the Revising Authorities/Appeals etc. shall be incorporated in the draft rolls and after such incorporation, the electoral roll of each ward shall be divided and finally published polling station-wise.
- On the basis of a reference No. 454/LFA dated February 22, 2013, (x) received from the Deputy Commissioner, Panchkula, the Deputy Commissioners were advised that any person, who submits his application for registration of his name in the roll on the basis of 'no frills account' should be allowed to enter his name in the electoral rolls of the Corporation unless there are other conclusive proof(s) of his being ordinarily resident. Further to avoid bogus enrollment in the electoral rolls, it was decided that the instructions enclosed with the application form "A" prescribed for enrolment of a new voter shall be treated as an amended to the extent that in addition to a pass book of any type of account maintained in "any bank or post office, any of the additional documents as part of proof of claim (Form A) would also required to be submitted by the applicant. Further in doubtful cases, committee(s) of three officials headed by a responsible gazette officer should be constituted, who shall physically verify and assess the residence proof of the claimant properly and submit its report on the basis of documents so obtained to the Revising authority, who shall take decision in each case on merit accordingly. If any decision regarding inclusion of any name in the electoral roll has been taken merely on the basis of "no frill account", such cases should be re-verified and further action taken on merit. The Chief Electoral Officer, Haryana was also requested to direct the Deputy Commissioners concerned to run de-duplication software of the

database of the Assembly electoral rolls on district basis of which the draft electoral rolls of the municipal corporations have been prepared to avoid the person having double votes.

3.11 The Deputy Commissioner, Ambala vide its memo no.1230/PA, dated March 1, 2013 informed the Commission that the Revising Authorities concerned needed more time for verification of the voters, having identical particulars and the voters with zero address. The request of the Deputy Commissioner, Ambala was considered and the programme for preparation of electoral rolls of the Municipal Corporation, Ambala was revised vide Notification No.SEC/2ME/2013/1113, dated March 5, 2013 as such:

- 3.12 Initially, the electoral rolls were ordered to be prepared ward-wise. Later, after reviewing the progress of the preparation of electoral rolls of the Corporations, it was felt that the rolls should be prepared polling station-wise. While issuing certain directions to the Deputy Commissioners, the Commission vide its letter No. SEC/2ME/2013/1121-26, dated 5/3/2013 had directed that while publishing the final voters list ward-wise, the polling station-wise lists should also be published and hosted on the websites of the District Administration and the State Election Commission. Subsequently, the Commission vide No. SEC/2ME/2013/1996, dated March 29, 2013 had issued a revised notification in this regard.
- 3.13 Some of the districts again requested to extend the last date of final publication of electoral rolls as the physical verification of the electors with zero address could not be carried out. The request of the Deputy Commissioners was considered and it was decided vide notification No. SEC/2ME/2013/1996 dated March 29, 2013 that the final publication of electoral rolls of all the seven Municipal Corporation be made by April 5, 2013 instead of March 30, 2013.

- 3.14 The representatives of the various political parties of district Panchkula met the State Election Commissioner on April 30, 2013 and made complaints regarding the electoral rolls of Municipal Corporation, Panchkula. The Deputy Commissioner, Panchkula was also associated with the deliberations. The political parties brought out the following discrepancies:
 - a. The voter list is not seriatim wise,
 - b. In some of the cases, house numbers are not mentioned in the electoral roll,
 - c. Supplements of the Assembly roll were not merged with the present electoral rolls of the Corporation and due to this, the voters of a house have been divided into different polling stations, and
 - d. House numbers along with the name of area/colony etc. from where the voter list of the area started has not been mentioned on the title page and each page of voter's lists.

Vide Commission's letter No.SEC/2ME/2013/2265, dated April 30, 2013, the Deputy Commissioner, Panchkula was requested to take action in the matter immediately. The electoral rolls of the Corporation were revised after making necessary corrections and published on May 4, 2013 and the CD and the copies of the rolls made available to the political parties on May 4, 2013 and May 6, 2013 respectively.

3.15 For 144 wards of these Corporations, 93 voter information & collection centers (VICCs) were setup as given in Table 3.1.

- 3.16 The complaints regarding voter lists pertaining to other corporations were also received and the same were sent to the concerned Deputy Commissioners for disposal under intimation to the complainants.
- 3.17 The final electoral rolls of the Corporations except that of Panchkula were published on April 5, 2013. As stated in para 3.15, the rolls of Panchkula were published on May 4, 2013. There were total 17,09,407 electors, the details of which are given in Table 3.2.

Chapter-4

POLLING STATIONS

- 4.1 Legal Provisions As per provision made in rule 35 of the Haryana Municipal Corporation Election Rules, 1994, the Returning Officer shall provide such number of polling stations as he may deem necessary. The Returning Officer shall post the list of polling stations on the date specified in rule 21 ibid at his office and the office of the Corporation showing the polling area or the group of voters for which they have respectively been provided and the hours during which they shall remain open for the poll. The list of proposed polling stations shall be approved by the Commission. Accordingly, when the programme for election is issued, the Returning Officers are simultaneously requested to send lists of proposed polling stations.
- 4.2 **Number of Polling Stations** For establishment of polling stations, detailed instructions has been given in the Handbook for Returning Officers. In addition, the Commission had issued a few guidelines. The salient features are as under:-
- (a) As per provisions made in Chapter–III of the Handbook for the Returning Officers, the polling stations are to be established at the scale of 1,200 to 1,500 voters. In the review meetings held with them, a few Deputy Commissioners proposed that the limit of electors per polling station should be reduced from 1,500 to 1,000. Accordingly, vide its letter No SEC/2ME/2013/1121-26, dated 05.03.2013, the Commission issued the guidelines to the Deputy Commissioners concerned for establishing polling stations at the scale of 1,000 per polling station after getting physical inspection/ verification of the building for polling station by a Committee of three gazetted officers. However, keeping in view the non-availability of sufficient number of buildings in the congested areas, some of the Deputy Commissioners further requested to increase the limit of the voters. Therefore, the Commission, vide its letter No. SEC/2ME/2013/1857-1863, dated 16.03.2013 clarified that the scale of 1,000 voters per booth is an indicative and the numbers of voters per booth could be increased up to 1,500 voters.
- (b) In case, the distance of a booth is more than 2 Km., an additional booth with lesser than 1,000 voters could be set up so that no voter is required to travel more than 2 Km.
- (c) When the number of voters in a ward exceeds 1,500, a separate polling station should be set up as far as possible in the same building.

- (d) Polling Station may be set up in colonies predominantly inhabited by the Scheduled Caste (SC) and weaker sections of the society even though the number of voters may be less than 1,000.
- (e) The buildings for polling stations should, as far as possible, be only public building accessible to all communities. The religious buildings like temples, mosques, churches and mutts and hospitals and delivery centers should not be selected as polling stations. Where suitable public buildings are not available, the polling stations may be set up in private buildings subject to the written consent of the owner of the building. However, it should be ensured that the owner of such building is not directly or indirectly connected with any political party.
- (f) The polling station should have normally a minimum area of 22 sq. meters so that there is no congestion inside the polling station.
- (g) Select the actual site of each polling station carefully in advance and arrange for materials, structures, fittings etc., necessary to set up a polling station as per the legal requirements and practical convenience.
- (h) Make proper arrangements of drinking water in the buildings where polling stations have been set up.
- (i) If there is a leprosy sanitarium within the Corporation area, then a separate Polling Station may be set up for the inmates alone and the officers, medical and other staff and working in the sanitarium may be appointed as Presiding and Polling Officers of the Polling Station.
- (j) Identify the localities predominantly in-habited by weaker sections and locate Polling Stations in these localities irrespective of the number of electors. Welfare associations or voluntary organizations championing the cause of such weaker eections should also be associated in identifying such localities and locating the Polling Stations.
- 4.3 Change of Polling Stations Returning Officer should on no account make any change in the location of polling station already approved by the Commission. Where changes become unavoidable, approval of the Commission be obtained. The changes should be publicized for the information of the public and all the contesting candidates and the political parties etc. informed in writing.
- 4.4 **GIS Mapping of Polling Stations** The Deputy Commissioners concerned were advised, vide letter dated 05/03/2013, that the wards and the polling stations of the Municipal Corporations shall be put on the Google Earth using GIS techniques, showing their locations and photographs. The voters' lists should also be tagged

- with of the polling stations. The required software may be obtained from the office of the Chief Electoral Officer, Haryana.
- 4.5 For the Corporations' elections, on an average, there were 1,050 voters per polling station. The number of polling stations established, total number of voters, average number of voters per polling station and number buildings where polling stations were established are given in Tables 4.1.

4.6 The GIS mapping of the polling stations helped the district administration and police authorities for deploying elections staff and the police force and thus, making all arrangements, including law and order, more effectively.

Chapter-5

ELECTION PROGRAMME

- 5.1 **Legal Provisions** Section 9 (2) of the Haryana Municipal Corporation Act, 1994 provides that the State Election Commission shall consult the State Government before announcing the date of election so that the Government as well as the Corporation may, if so requested by the State Election Commission, make available to the State Election Commission such staff as may be necessary for the discharge of the functions conferred on it under article 243K and 243 ZA of the Constitution of India and the Act.
- 5.2 Rules 21 and 22 of the Haryana Municipal Corporation Election Rules, 1994 provide that the State Election Commission shall frame election programme of a Corporation, which shall be published at least five clear days from the date fixed for making nominations and shall specify the date or dates, by or within which
 - (i) the nomination papers shall be presented;
 - (ii) list of nomination papers shall be posted;
 - (iii) the nomination papers shall be scrutinized;
 - (iv) candidate may withdraw his candidature;
 - (v) list of contesting candidates shall be posted;
 - (vi) list of polling stations shall be posted; and
 - (vii) poll shall be held, votes shall be counted and the result shall be declared.
- 5.3 Sub-Rule 2 of Rule 21 also provides that a period of not less than five days shall be prescribed for the presentation of nomination papers and the last date of making nominations, their scrutiny and withdrawal shall not be a public holiday and if any of the last dates for these purposes happens to be a public holiday, such nomination, scrutiny or withdrawal shall take place the next succeeding day, which is not a holiday. It also provides that the date of poll shall not be earlier than seventh day after the last date fixed for withdrawal of candidatures.

As mentioned in Para 1.15 of Chapter 1, the State Government had, vide their letter No. 18/8/2013-3C1 dated January 17, 2013, asked the Commission to hold the Corporations' elections by March 16, 2013. However, the Commission could not do so for the reasons mentioned in the para referred to above. On the basis of the Commission's proposal, the Government conveyed no objection for holding the elections before June 16, 2013. Accordingly, the Commission issued the election programme of all the seven corporations, under clause (1) of the Article 243ZA of the Constitution of India, Section 9 of the Haryana Municipal Corporation Act, 1994 and Rule 21(1) of the Haryana Municipal Corporation Election Rules, 1994 vide its notification No.SEC/1ME/2013/2387, dated May 5, 2013. The schedule was as follows:-

The following directions were also issued:-

- i. The Returning Officers shall publish the above election programme on May 10, 2013 by pasting notices at their offices, the office of the Deputy Commissioner, offices of the Corporation and at such other conspicuous places in the Corporation area, as may be determined by him in this behalf under Rule 22 of the Haryana Municipal Corporation Election Rules, 1994.
- ii. Immediately after the expiry of the period within which candidatures may be withdrawn under Rule 29 of the Haryana Municipal Corporation Elections Rules, 1994, the concerned Returning Officer shall prepare in Hindi the lists of contesting candidates, that is to say, lists of candidates who have been included in the lists of validly nominated candidates, and those who have not withdrawn their candidatures within the prescribed period. The lists shall be caused to be posted at the some conspicuous place, in the offices of the Returning Officer and the Municipal Corporation.
- iii. The concerned Returning Officer or the Assistant Returning Officer as the case may be, shall at every stage prepare the notices of the nominations containing descriptions similar to those contained in the nomination papers both of the candidates and the proposers, the lists of candidates whose nomination papers have been rejected, the list of validly nominated candidates, the notices of withdrawal of

- candidatures and the lists of contesting candidates, and affix the same at some conspicuous places, at the notice board of their offices and at the office of the Corporation and shall submit one copy thereof to the Commission directly at every stage and one copy through the Deputy Commissioner.
- iv. The counting of votes polled at the elections shall take place on June 4, 2013 from 8.00 A.M. onwards at the place specified by the Deputy Commissioner. The details (Accounts) of votes polled at each polling station shall be prepared in Part-II of Form 17 and consolidated by the Returning Officer in Form 8 mentioning therein the total number of valid votes polled in favour of each candidates on each polling station and declare the candidate, who is found to have obtained the largest number of votes, elected as Member from the ward.
- v. After the declaration of result of elections under Rule 63, the Returning Officers shall forthwith post a copy of return (Form 8 Consolidation of account of the counted ballot papers) in a conspicuous place at his office and send with a copy thereof to the Deputy Commissioner, who shall within three days forward the names of the candidates elected to the State Election Commissioner, Haryana for notifying the same in official gazette. The Deputy Commissioners shall ensure that the names and other particulars of the elected candidates should be the same as are recorded in the nomination papers.
- 5.5 As the elections were conducted by Electronic Voting Machines (EVMs), it was necessary that proper arrangement of electricity shall be made particularly on the polling day.
- 5.6 As per provisions of Section 23A of the Haryana Municipal Corporation Act, 1994, the casting and recording of votes by EVMs had been adopted. 2,296 ballot units and 1,993 control units were used. The details are shown in Table 5.1.

NOMINATIONS

- 6.1 Legal Provisions As soon as the programme for the election is issued by the Commission, the Returning Officer concerned shall publish a notice under Rule 22 on the date specified by the State Election Commission and post the same at his office and at the office of the Corporation, and such other places as he may determine, clearly mentioning therein the following:-
- (i) Nomination papers are invited from the candidates those who are interested to contest the elections,
- (ii) Date, time and place where and how the nomination paper shall be delivered,
- (iii) Name of authority to whom the nomination papers are delivered, and
- (iv) Date, time and place fixed for the scrutiny of nomination papers of the candidates.
- 6.2 The last date for making nomination papers, their scrutiny and withdrawal should not be public holidays and if it so happens, such nominations, scrutiny or withdrawal shall take place on the next succeeding day which is not a public holiday. This is, however, subject to the provision that the State Election Commissioner, Haryana by an order amend, vary or modify the election programme at any time and no such order is deemed to invalidate any proceedings already taken before the date of the order.
- 6.3 Qualifications and Disqualifications for the Candidates Sections 7 and 8 of the Corporation Act, 1994 read with rule 23 of the rules provide the qualifications and disqualifications for the candidates. The relevant abstracts of the Act and Rules are given in Annexure 6.1.
- Nominations Rule 24 of the Haryana Municipal Corporation Election Rules, 1994 provides that the nomination paper completed in Form-1 (Annexure-9.1) appended to these rules and subscribed by the candidate himself as assenting to the nomination and by an elector as proposer, shall be presented either in person or by his proposer or by his agent between 11.00 AM and 3.00 PM or such hours as the Returning Officer may fix to suit the local requirements, on or before the date specified for presenting the nominations under Rule 22. A candidate is also required to submit the following documents:-
- (i) An affidavit in the prescribed format that he is not disqualified for being chosen as a member of the Corporation under Section 8 of the Representation of

- People Act, 1951 and Section 8 of the Haryana Municipal Corporation Act, 1994.
- (ii) An affidavit as per the format prescribed by the Commission to disclose the information of criminal antecedents, assets and liabilities and educational qualifications with the nomination paper or before the date and time as specified by the State Election Commission in the Election Programme. Statement showing the details of moveable and immoveable assets of the elected candidates as an abstract at Annexure 6.2.
 - 6.5 No nomination paper shall be received after the appointed time. The Returning Officers are further required to go out of the room a minute before the closing time and announce that they are going to close the door on the specified time and that no one will be allowed to enter the room thereafter.
 - 6.6 Deposits The amount of deposits to be made by the candidates along with the nomination papers, which is required to be deposited with the Returning Officer in cash or in the Government Treasury, as prescribed in the Rules, is given in Table 6.1.

6.7 **Scrutiny** - The Returning Officer or the Assistant Returning Officer, as the case may be, is required to acknowledge the receipt of the nomination paper in the printed form as prescribed in rule 26. In addition, a notice of the date and time for scrutiny of the nomination is also required to be given to every candidate as a token of receipt of his nomination and notice of scrutiny. The Returning Officer or Assistant Returning Officer, as the case may be, shall at every stage prepare the notices of nomination containing descriptions similar to those contained in the nomination papers both of the candidates and the proposers and affix the same at the notice board of their office and the office of the municipality concerned.

- 6.8 **List of Validly Nominated Candidates** Immediately after the nomination papers are scrutinized and decision regarding acceptance or rejection of the same is recorded, the Returning Officer shall prepare a list of validly nominated candidates and affix it to the notice board of his office. After this exercise, any candidate can withdraw his candidature by notice in writing and by delivering it to the Returning Officer before 3.00 P.M. or such other hours as the Returning Officer may fix to suit the local requirements as per the election programme.
- 6.9 Final List of Contesting Candidates Immediately after the expiry of the time period within which candidatures may be withdrawn, the Returning Officer shall prepare in Hindi and such other language or languages as may be prescribed by the State Election Commission, a list of the contesting candidates, that is to say, the candidates who were included in the list of validly nominated candidates and who have not withdrawn their candidatures within the prescribed period and cause it to be posted at some conspicuous place in his office and at the Municipal Corporation Office.
- 6.10 The said list shall contain the names in Hindi alphabetical order and address of the contesting candidates as given in the nomination papers together with the symbols assigned to each candidate. The detailed procedure for the allotment of symbols had been given in Chapter-7
- 6.11 The number of nominations received, rejected, withdrawn and contesting candidates in all the Municipal Corporations are given in Table 6.2.

- 6.12 From the above Table, it may be noticed that the number of nominations per seat after withdrawal was the highest in Hisar and the lowest in Panchkula.
- 6.13 Out of 1,686 candidates, 1,542 had lost the elections. The security of 289 candidates had been refunded and that of the remaining 1,253 candidates were forefeited. The Corporation-wise details are given in Table 6.3.

POLITICAL PARTIES AND ELECTION SYMBOLS

- 7.1 **Legal Provisions -** No separate registration and recognition of the political parties is done by the Commission at its own level. Rather the registration and recognition of national parties and state level parties in Haryana State made by the Election Commission of India is adopted by the Commission for which the list is maintained and updated as and when any change is notified by the Election Commission of India.
- 7.2 Rule 20 of the Haryana Municipal Corporation Election Rules, 1994 provides that the Commission shall, by notification in the Official Gazette, publish list of symbols along with restrictions, if any, subject to which those may be chosen by a candidate at the election. It is further provided that every nomination paper on Form-1 shall contain a declaration specifying the particular symbols which the candidate has chosen as his first, second and third preferences out of the list of symbols for the time being in force.
- 7.3 The Commission vide its notification No.SEC/3ME/2011/674 dated March 31, 2011, had notified the Haryana Municipal Election Symbol (Reservation and Allotment) Order, 1996 which provides that the Commission shall update/ notify a list of recognized political parties and symbols reserved for them and also a list of registered un-recognized political parties with a list of free symbols, allotment of symbols in election not held on party basis and not on party basis also. While superseding its earlier notifications issued in this regard, the Commission vide its notification No. SEC/3ME/2014/853, May 06, 2014 updated the list as under:-

- 7.4 There was a good response from the political parties to contest the elections on their symbols.
- 7.5 In all the 1,686 candidates contested election for 144 seats, out of whom 120 candidates were of BJP, 140 candidates of INLD, 4 candidates of CPI (M), and 3 candidates of NCP. The remaining 1,419 contested as independents candidates. The details are given in Table 7.4.

Chapter-8 PRINTING OF BALLOT PAPERS

- 8.1 Under the traditional system, voting takes place by means of ballot papers and ballot boxes. In this system, counting of votes is a very complex, laborious and time consuming process, which sometimes leads to confusion, chaos and law and order problem. All such problems were totally eliminated during the election of municipal bodies, as the State Election Commission has decided to hold all the municipal elections with electronic voting machine (EVM). The use of EVMs is permissible under Section 23A of the Haryana Municipal Corporation Act, 1994 read with rule 50 of the Haryana Municipal Corporation Rules, 1994.
- 8.2 Printing of Ballot Papers As per provisions contained in Rule 70F of the Haryana Municipal Corporation Elections Rules, 1994, the Deputy Commissioners were directed vide Commission's letter No. SEC/2ME/2013/2614-20, dated May 10, 2013 to prepare and print the ballot papers of all wards of the Municipal Corporations in Hindi as per the design so specified for EVMs.
- 8.3 As per practice, ten ballot papers i.e. two for EVM and eight tender ballot were got printed from the Controller, Printing and Stationery Department, Haryana and were supplied to the Deputy Commissioners accordingly. The Municipal Corporation-wise number of wards, polling stations and ballot papers printed is given in Table 8.1.

MODEL CODE OF CONDUCT

- 9.1 In exercise of the powers conferred upon it under Article 243K of the Constitution of India, the Commission has issued the Model Code of Conduct for election to Urban Local Bodies to ensure free, fair and peaceful elections. The Code is required to be observed by all the political parties, contesting candidates, ministers and employees of the State Government, statutory bodies, public sector undertakings and local bodies. The Code comes in force from the time elections are announced and ceases to exist after the declaration of results.
- 9.2 The elections were announced on May 5, 2013 and as such, the Code of Conduct came in force on this date and remained in force till declaration of results, i.e. 04.06.2013.
- 9.3 As per provisions of the Code, the campaigning was stopped 48 hours before the hours fixed for the close of poll.
- 9.4 The Commission had issued separate instructions vide letter No. SEC/1ME/2013/2534, dated May 09, 2013 requesting the Principal Secretary to Government of Haryana, Prohibition and Excise & Taxation Department to notify 'dry days' under the relevant laws for such period during the municipal elections as were appropriate at or around the area where the municipal elections were to be held. It was further clarified that such period of dry days declared and notified must include the period of two days before the polling days, i.e. the polling and counting days and the day immediately thereafter. He was further requested to issue the following directions: -
 - (i) No liquor shops, hotels, restaurants, clubs and other establishments selling/serving liquor shall be permitted to sell or serve liquor whatsoever on the aforesaid dates.
 - (ii) No proprietary clubs, star hotels, restaurants etc. and hotels run by anyone, even if they are issued different categories of licenses for possessions and supply of liquor, should be permitted to serve liquors on these days.

- (iii) The storage of liquor by individuals shall be curtailed during the above period and the restrictions provided in the excise laws on the storage in unlicensed premises shall be vigorously enforced.
- (iv) Steps should also be taken to prohibit sale of liquor in adjoining areas where elections are held, so that there are no chances of clandestine movement of liquor from those areas where the restriction not been in operation.
- 9.5 In response to the above request, the Principal Secretary to Government of Haryana, Prohibition and Excise and Taxation Department vide No. 3098/XL dated May 21, 2013 issued necessary orders imposing ban to sell, serve and storage of liquor within the jurisdiction of the areas of seven municipal corporations where the general elections were to be held as per the details given in the election programme, and areas adjoining the jurisdiction thereof during the above said period.
- 9.6 Simultaneously, on the request of the Commission, the State Government had, vide its notification No.28/2/2005/3GSH, dated May 23, 2013, declared a holiday on election days at the places where the elections were to be held under Section 25 of the Negotiable Instruments Act, 1881 to enable the workers engaged in various factories and commercial establishments located in the areas concerned to exercise their franchise.
- 9.7 On the request of the Commission, the Chief Secretary to Government of Haryana, had, vide her/his letter No.4/118/2010-1Election, dated May 21, 2013, banned the posting and transfer of the officers and officials connected with process of election of the Corporations and also on recruitment, appointment and the promotion during the period when Conduct is in force. Besides, the Ministers will neither give any grant from the government funds, nor lay any foundation for any new project or scheme during the period this period.
- 9.8 The Commission had, vide Order No. SEC/1ME/2013/ 2535, dated May 09, 2013, instructed the Deputy Commissioners to prevent misuse of vehicles on the poll day, deploy police force at the counting centers, law and order situation during the elections, prohibition on sale of liquor and declaration of holiday on poll day. Such instructions were hosted on Commission's website www.secharyana.gov.in

POLL PERSONNEL

- 10.1 Legal Provisions Under rule 35 of the Haryana Municipal Corporation Election Rules, 1994, it is the duty of the Returning Officer to appoint polling personnel such as Presiding Officers, Polling Officers, Supervisory Officers etc.
- 10.2 Poll Staff on Deputation to the Commission Under Section 8D of the Haryana Municipal Corporation Act, 1994 read with Section 28A of the Representation of People Act, 1951, the Returning Officer, Assistant Returning Officer, Presiding Officer, Polling Officer and any other official including police officer, designated for the time being by the State Government for the conduct of any election of a Municipal Corporation, shall be deemed to be on deputation to the Election Commission for the period commencing on and from the date of the notification calling for such election and ending with the date of declaration of the results of such election. Accordingly, all such officials shall, during the election period, are subject to the control, superintendence and discipline of the State Election Commission.
- 10.3 Drafting of Polling Personnel for Election Duty (Randomization of Polling Personnel) Since the duties discharged by the polling personnel are vital in the conduct of elections, sufficient care is needed to draft and deploy such personnel in the interest of free and fair election. Accordingly, the Commission had issued the following directions vide letter No.SEC/1ME/2013/2461-67, dated 09.05.2013 for the formation of polling parties:
 - in an electronic form, which can facilitate computerized randomization.

 All relevant particulars like name, gender, place (Municipal Corporation/Committee) of residence, work place, home municipality, designation, office and department/institution should be entered into an electronic database of the computerized randomization application software already available with NIC, which was used in the General Elections of the last Vidhan Sabha/Lok Sabha.
 - ii) Presiding Officer and Polling Officers should be classified on the basis of scale of grade pay, their post and rank. As far as practicable Gazetted Officers will be deployed as Presiding Officers and if that is

- not possible, the officials who are working in supervisory capacity only should be deployed as Presiding Officers. The Presiding Officer should be of higher scale/grade than that of Polling Officers of that formation.
- iii) While appointing Presiding Officers and Polling Officers, the Deputy Commissioners should ensure that the officials having political leaning towards any candidate are not appointed as poll personnel.
- iv) As per the Handbook of the Instructions for the Returning Officers, proper training should be given to the poll personnel.
- v) No person will be assigned polling duties in the ward of the Corporation in which he is either posted or he resides.
- vi) In order to avoid any allegation of collusion among the polling personnel in favour of any candidate or political party and to instill confidence in the minds of political parties and candidates about free and fair elections, proper mix of polling personnel drawn from different offices and departments at the time of formation of a polling party should be ensured. Two officials of the same serial group/category should not be put together. Further, two members of the polling party should not be from the same department. In case of school teachers, they should not be from the same school.
- vii) Polling personnel should be drawn both from the State Government departments as well as the Central Government offices. As far as practicable, the Central Government employees should be drawn to the extent possible and may be posted at relatively more sensitive polling stations. They should be mixed with the State employees on 50:50 basis, if available.
- viii) From the full database of officials, a list of twice the required number of polling persons should be generated (including reserve) randomly, using the software. This is the first of the three-stages of randomization process. The Observer's presence is not required at this stage. This is only to identify and select the officials who would be given training for poll duties as Presiding and Polling Officers in the elections. In no case, at this stage, the identity of the ward to which the polling personnel are likely to be deployed will be known. All that the polling personnel will know at this stage is whether he (or she) is a Presiding Officer or a Polling Officer and the venue and time of trainings.

- The second stage of randomization exercise should be done in the presence of the Observer. At this stage, actual polling parties shall be formed on random basis using the randomization software. The randomization should not take place before 3 days from the day of poll. For the purpose of serving the appointment letters, the Deputy Commissioner/Returning Officer can use the services of the sponsoring departments/authority and/or organize a training programme of poll personnel on that date when final briefing can be given and appointment letters issued to them.
- x) The third stage of randomization exercise shall take place at the time of dispersal of polling parties when the allocation of polling stations to the polling parties will be done. At this stage, final allocation of Polling Stations to each Polling Parties should also be done in the presence of Observer. The actual polling station allotted to individual polling personnel is to be disclosed just before the polling party actually leaves for the concerned polling station.
- xi) In order to ensure that above instructions are complied with strictly, the Commission directed that the Deputy Commissioner/Returning Officer shall furnish through the Observers as well as separately to the Commission, a certificate to the following effect immediately after the polling parties have been formed.-

Certified that:-

- (I) The polling parties have been formed by a proper mix of officials drawn from different offices and departments, in presence of Observer.
- (II) The officers have been drawn from the State Government Departments as well as from the Central Government Offices, PSUs, etc. as far as practicable.
- (III) For the purpose of making polling parties, the complete data base of all eligible employees in the district has been used.
- xii) The entire randomization exercise except the first stage must invariably be done in the presence of the Observer. If, by any chance, the formation of the polling parties through randomization (2nd stage) has been done in the absence of the Observer, the second stage randomization exercise should be done afresh in the presence of

- Observer and compliance report should be submitted to the Commission. The Observer should make a special reference to the randomization while submitting his report to the Commission..
- xiii) The Deputy Commissioner should make available all the copies of the instructions to the Observer of his district.
- xiv) All political parties should be invited to attend the randomization process.
- 10.4 As only one vote was to be polled by a voter, one Presiding Officer and four Polling Officers were deployed at every polling station. Their duties in brief were as under:-
 - (a) 1st Polling Officer : In charge of identification of electors and marked copy of electoral roll.
 - (b) 2nd Polling Officer : In charge of application of indelible ink and maintenance of register of voters.
 - (c) 3rd Polling Officer : In charge of voter slips
 - (d) 4th Polling Officer : In charge of control unit of voting machine.
- 10.5 The policemen for each polling station were deployed for election duty in consultation with Inspectors General of Police/Police Commissioners/ Superintendent of Police of the district concerned.
- 10.6 Detailed instructions for making poll arrangements were issued by the Commission to the Deputy Commissioners to ensure that the appointment of Presiding Officers, Polling Officers and other polling staff is made in time. In addition, they were aso asked to make proper arrangements for transporting the polling parties, poll material etc.
- 10.7 Two engineers from the Bharat Electronics Limited were deputed in each Municipal Corporation during the election period for checking and inspection of the Electronic Voting Machines.
- 10.8 The Municipal Corporation-wise number of polling personnel deployed in the Fourth Municipal Corporation General Elections, 2013 is given in Table 10.1

APPOINTMENT OF OBSERVERS

11.1 The institution of Observers has become an integral part of managing elections as well as generating confidence in the public. According to Section 8D of the Haryana Municipal Corporation Act, 1994, the provisions of 20B of the Representation of People Act, 1951 (Central Act 43 of 1951) shall mutatis mutandis apply to the provisions of the Corporation Act of 1994. The Section 20B of the Central Act provides for the appointment of Observer, who shall be an officer Government, to watch the conduct of elections. In accordance with the provisions of this Section, the Commission had appointed seven IAS officers of Haryana cadre as Observers (Election) and seven officers of the State Excise and Taxation Department as Observers (Expenditure) to watch the conduct of the Municipal Corporations Elections, 2013.

Observers (Election)

11.2 Vide No. SEC/3ME/2013/2714, 2717, 2720, 2723, 2726, 2753, 2809, dated May 15, 16 and 18, 2013, the following seven IAS Officers were appointed as Observers (Elections):-

- 11.3 The Commission had prescribed twenty two guidelines (Annexure-11.1) for the Observers (Elections) to discharge their duties. The Commission had also asked them to submit their reports in the format given in Annexure- 11.2. In addition, they were asked to take the following actions:-
 - 11.3.1 To visit the Corporation at least four times (i) before the last date of filing nominations, (ii) scrutiny of nominations, allotment of symbols and publication of final list of contesting candidates, campaign period and training session, (iii) second randomization of poll staff, formation of polling parties, distribution of poll material and till polling is over and EVMs are delivered back and stored safely, and (iv) day of counting and declaration of results.
 - 11.3.2 To visit the area assigned to them to review the arrangements made for the conduct of elections of the Corporation and convene a meeting of concerned officers e.g. Deputy Commissioner, Senior Superintendent of Police/Deputy Commissioner of Police, Returning Officer etc.
 - 11.3.3 To attend the meeting of the political parties and the candidates as and when convened by Deputy Commissioner and/or Returning Officer.
 - 11.3.4 In case of any shortcoming or gap in the arrangements or receive any complaint or representation from anyone, which needs to be looked into, send it to the Deputy Commissioner or any other authority for taking appropriate action.
 - 11.3.5 Not to give any interview and statement to any media-person and address any press conference at any stage.
 - 11.3.6 Be easily accessible to meet the contesting candidates, representatives of political parties and the public and hear their complaints, grievances and suggestions and wherever necessary, bring the same to the notice of Deputy Commissioner or any other officer for taking appropriate action in the matter.
 - 11.3.7 Not to obtain advice / direction from any other authority, including, State Government and / or its representative. Follow the directions of State Election Commission only.
 - 11.3.8 The Observers (Elections) were empowered to direct the Returning Officer of the Municipal Corporation to stop the counting of votes at any time before the declaration of result or not to declare the result.

11.4 The Deputy Commissioners concerned were directed to provide facilities to the Observers contained in the letter No.SEC/3ME/2013/2699-2706, dated May 10, 2013. A copy is annexed as Annexure 11.3.

Observers (Expenditure)

11.5 Vide No.SEC/3ME/2013/66, 70, 74, 78, 82, 86 and 90, dated May 13, 2013, the following seven officers of the State Excise and Taxation Department were appointed as Observers (Expenditure):-

- 11.6 Expenditure Limit for Candidate The Commission had, vide notification No. Sec/3ME/2011/2789, dated May 5, 2011, prescribed the expenditure limit of Rs.1,25,000/- to be incurred by a candidate for election of Member Municipal Corporation. A meeting was held with all political parties on 25.04.2013 in connection with the elections of the seven Municipal Corporations. Most of the representatives of the political parties suggested that expenditure limit should be increased to Rs.5,00,000. After considering the proposal, the Commission had revised the expenditure limit to Rs.1,75,000.
- 11.7 Vide letters referred in para 11.5, the Commission has prescribed the guidelines for the Observers (Expenditure) to discharge their duties. They were asked to take the following actions:
 - i) To keep a watch on expenditure incurred by the contesting candidates from 16.05.2013, which is the date for filing of nomination of candidature and upto the completion of election.
 - Each contesting candidate has to maintain day-to-day accounts of expenditure from the date of filing nomination paper up to the date of declaration of result.

- iii) The day-to-day account along with supporting documents/vouchers is maintained by the candidate and failure to produce proper accounts will be considered a major default.
- iv) All types of expenditure incurred by the candidates such as petrol, postage, printing of pamphlets/election campaign material, advertisement in media including newspapers, stationery items and any other such expenditure which may be directly in connection with the election campaign.
- v) Check the details of expenditure of each contesting candidate atleast once in two days till the date of election.
- vi) Analyze the expenditure in election of the contesting candidates and send a report to the Commission within three days after the completion of poll.
- 11.8 In addition, the Commission vide its letter no. SEC/MC/2013/3029-36, dated 30/05/2013 had directed the Deputy Commissioners and the Observers (Expenditure) to take the following actions in letter and spirit:-
 - Direct the District Public Relation Officer (DPRO) concerned to (i) maintain the cutting of all advertisements released by the candidates themselves or persons other than candidates in the newspapers, hand bills, pamphlets etc. and CDs of the advertisement given in the electronic media (TV channels) on day to day basis, after the last date of withdrawal of candidature and allotment of symbols till June 2, 2013 (including June 2) and give them to the Expenditure Observer with expenditure concerned. along the incurred such advertisements / promotional campaign along with the material.
 - (ii) In some cases, news are being given in newspapers and TV channels, which are in the nature of advertisement / promotional campaign. The DPRO should keep watch on all such material and give details along with cuttings and CDs to the Expenditure Observer of your Corporation.
 - (iii) Direct DPRO of your district to launch action under the appropriate law against the printing presses for publishing / printing any material without mentioning the name of printing press etc. The contesting candidates may also be directed to get the name of printing press published on the posters, banners, pamphlets etc.

- (iv) Direct all the Supervisory Officers and Municipal Corporation authorities to keep a close watch on banners, news, advertisements etc as mentioned above and bring the same to the notice of Expenditure Observer.
- (v) The Expenditure Observer shall ensure that the expenditure incurred by the contesting candidates on such advertisements has been entered by them in the expenditure register, which is required to be maintained day by day by the candidates concerned.
- 11.9 **Suggestions of the Observers (Elections)** The following suggestions were received from the Observers (Elections):-
 - Municipal Corporation, Panchkula: The counting of votes should be ward-wise at the polling booth rather than at one or two counting centers.
 - ii) The fresh exercise for delimitation of wards is undertaken at least 6 months prior to the date of poll in future.
 - iii) The area in ward No.13 of Municipal Corporation, Yamunanagar was quite congested. Half of the polling stations of this ward should be set up in nearby area.
 - iv) Municipal Corporation, Hisar: Booths, which have more than 1,000 votes, should be rationalized for the next election. For example in polling station No. 17/7.17/8 and 17/9 (Blooming Dales High School, Sector 15-A Hisar), 1482, 647 and 1253 votes have been registered. These three booths can be restructured to four polling stations. Similar exercise should be done for other polling stations, which have around 1,500 votes.
 - v) Since very good step has been taken by the Commission by distributing the voters identification slips to the voters, there is no need for setting up booths for assistance by the candidates outside the polling stations. The presence of such booths merely gives space to the people gather, which is not desirable during the poll as there is all likelihood of misuse of these spaces. Therefore, this can be easily dispensed with for the future elections.
 - vi) Three booths located in one building namely Goyal Dharamshala, (Polling Stations No. 14/4, 14/7 and 14/6) are very congested as there was no sufficient space for movement for the voters. These

- polling stations should be shifted to some other building for next election.
- vii) Municipal Corporation, Panipat More training should be given to the staff.

11.10 Reports of Observers (Expenditure)

- Municipal Corporation, Ambala: A meeting of all the 180 i) candidates of 20 wards was called by the Returning Officer, Ambala. In the meeting, he briefed the candidates regarding expenditure borne by them and to inform the Observer (Expenditure) in the expenditure register. The expenditure as well as through electronic media i.e. T.V. channel, distribution of pamphlet/ hand bills/ banners/ hoardings etc. has been taken into account while preparing account of expenditure incurred on election by the candidates. Necessary report from the DPRO, Ambala was obtained on cutting of all such advertisements appeared in the papers only. Other than newspapers cuttings, no other information of any kind was received from DPRO. However, a close watch over the TV channels, paper advertisements, pamphlet and hand bills etc. was taken into consideration while signing the registers on day today basis and after assessing the expenditure incurred thereon and the said expenditure incurred by the contesting candidates duly entered.
- Municipal Corporation, Hisar: He had visited more than 2/3 polling booths and all the 20 wards. The videography of the chair etc. installed at the outskirt of the polling booth by some of the contesting candidates was got done. The expenditure towards these goods will be counted to the expenditure of the contesting candidate on receipt of information from the DPR and other sources. After receipt of the DPR and other sources.
- iii) **Municipal Corporation, Karnal**: There was a complaint of Sh. Satyajit and during an enquiry, it was found that there was no distribution of money as well as cloths as alleged in the complaint.
- iv) **Municipal Corporation, Panchkula**: During the elections, Observer (Expenditure) had checked the activities of the candidates regarding the posters, hoardings and banners being put up, vehicles being

- used for campaigning and refreshment being provided were taken note of. He did check the expenditure registers of 99 candidates. In addition, cuttings of daily newspapers were obtained from the DPRO and candidate-wise details had been compiled.
- v) Municipal Corporation, Panipat: A close surveillance was kept in each ward on the expenditure being incurred by the candidates. A team of four S.O,s had collected the documents and expenditure register after verification and had gathered information from the printing press, city cable / local channel/ DPRO has also been conveyed to the team of S.O. and R.O. etc.. Notice to the candidates, who had not produced their expenditure accounts during the process of election had been issued. In the meeting, all the candidates were directed to deposit their expenditure register before 3.07.2013 in room No.17 of the Municipal Corporation, Panipat.
- Vi) Municipal Corporation, Rohtak: Visited various wards of the Corporation during the election time, the information regarding release of advertisement in local and national dailies and local cable had been obtained from the DPRO, Rohtak. Notices were issued for verification. Out of 26 candidates 14 candidates responded to the notice. There were all 56 candidates who incurred the expenditure on advertisement on local cable network and the same found entered in the expenditure register. No violation of law with regard to the expenditure aspect of the election came to his notice, nor was any violation by any candidate was brought to his notice.
- vii) Municipal Corporation, Yamunanagar: The details of accounts submitted by the candidates along with the supporting bill/ voucher/ documents had been examined and the same were found to be correct. He visited all wards of the Corporation and had reviewed the expenditure activities of the contesting candidate. The details of the bills of the owner of the local channel had been crossed tallied with the day to day account register of the candidate at the time. The advertisement charges were added in the expenditure. No major discrepancy/ defaults found during election on account of maintaining the record of election expenses.

LAW AND ORDER

- 12.1 In order to ensure fair and free elections in a peaceful manner, the State Election Commissioner reviewed the law and order and other arrangements to be made for the elections of the Municipal Corporations in a meeting with Additional Chief Secretary (Home Department), Director General of Police and Additional Director General of Police (Law and Order) on May 9, 2013, The officers present in the meeting assured the Commissioner that proper arrangements would be made to maintain law and order in all the districts for holding elections in a peaceful manner. The minutes of the meeting are attached as Annexure 12.1.
- 12.2 The State Election Commission, vide its letter No. SEC/1ME/2013/2481, dated May 9, 2013, advised the State Home Department to take the following actions:-
 - The police be asked to be vigilant and start the mopping up operation of the areas infested with known goondas and bad elements about ten days prior of the poll. During such mopping operation, special attention should be paid to unearth and seize unlicensed arms and ammunitions right from now.
 - ii) No new arms licenses be issued with effect from 09.05.2013, date on which model code of Conduct has come into force with the announcement of the election programme.
 - iii) An order be issued prohibiting carrying of all licensed fire arms and lethal weapons with effect from 09.05.2013. Further effective steps be also taken to unearth the un-licensed weapons and seize the same.
 - iv) Arrangement be made for deployment of police at each polling station and near each polling station and also in sensitive areas.
 - v) Adequate wireless sets shall be provided to improve communication for meeting any Law and Order problem of emergent nature.
 - vi) Strict vigil be kept over movement of un-desirable elements and vigorous check may be carried out to prevent men and vehicles moving with arms and ammunition.
 - vii) Thorough checking of lorries, trucks and other vehicles be carried out during three days before poll and on the poll day etc. to ensure that no

- undesirable element or arms ammunition are infiltrated into and around the polling areas.
- viii) Restriction on movement of vehicles on poll days be imposed and instructions should be issued to regulate vehicular traffic and playing of vehicles on poll days.
- ix) Sale and consumption of liquor should be stopped one day before the poll, on poll day and on the counting day otherwise penal action should be taken.
- 12.3 Later, the State Election Commissioner had reviewed the poll arrangements with the Inspector Generals of Police, Police Commissioners, Deputy Commissioners, Deputy Commissioners of Police, Senior Superintendents of Police and others. For these meetings, vide ltter No.SEC/1ME/2013/2945, dated May 24, 2013 (Annexure 12.2), the Deputy Commissioners were asked to furnish a information on thirty one points.. During the meetings, the officers were asked to take the following actions regarding law and order arrangements:-
 - The name, designation, contact numbers and email ids of Deputy Commissioners, Senior Superintendents of Police, Deputy Commissioners of Police, Returning Officers, Assistant Retuning Officers and the Executive Magistrates be hosted on the websites of the District Administration.
 - ii) Sufficient number of Executive Magistrates and police personnel be deployed to maintain law and order during the elections.
 - iii) Ward-wise details of the candidates, who filed nominations along with the documents filed by them regarding their education, profession, property and criminal background, whose candidature was rejected and the number of candidates who withdrew their nominations be hosted on the website of the District Administration.
 - iv) Detailed security plan for law and order be praepred and sensitive/ hyper sensitive polling stations be identified.
 - v) A special drive shall be launched by the police to get all arms deposited in the police stations and necessary steps shall be taken to prevent carrying of weapons.

- vi) Deploy police force in large number to maintain law and order at the polling booths and keep HAP and IRB reserve well in advance in every corporation area.
- vii) Send a daily report to the Commission on law and order on the pattern of elections of Lok Sabha/ Vidhan Sabha.
- viii) There would be sufficient number of Police Patrol parties, atleast one per ward. Every polling station shall be visited in routine by the Patrol as frequently as possible, atleast once an hour.
- ix) Keep a close watch on such persons such as Bail and Parole Jumpers and history Sheeters and efforts shall be made to nab them.
- x) The poll day monitoring e-dashboard (developed by the NIC) be set up and used in the districts concerned.
- xi) The building where the EVMs shall be stored after polling for counting of votes be identified and inspected jointly by the DC, DCP/SSP and the Returning Officer and security arrangements be made.
- 12.4 In addition above, vide order No.SEC/1ME/2013/2535, dated May 09, 2013, the Commission issued detailed instructions regarding restriction on use of vehicles on poll day during the Corporation elections, a copy of which is attached as Annexure 12.3.
- 12.5 The Presiding Officer were allowed to use their personal mobile in the polling station for sending information to the DC/SSP/Magistrate on Duty/Police Patrol Party/Supervisory Officer about the law and order situation to enable the authorities concerned to take action promptly wherever required. They were also required to send SMS every hour about the law and order and number of votes polled. For the use of mobile phone for sending messages, every Presiding Officer was given a sum of Rs.100.
- 12.6 For maintaining the law and order, 152 Magistrates, 186 Supervisory Officers, 26 Gazetted Police Officers and 10,664 police personnel were deployed. Category-wise number of police personnel deployed during the elections is given in Table 12.1

12.7 The elections of Municipal Corporations were completed peacefully and there was neither report of any major incident nor any re-poll took place.

Chapter-13 GENDER-WISE ANALYSIS OF CANDIDATES AND VOTERS

- 13.1 An analysis showing gender-wise number of contesting candidates, elected members, total number of voters and votes polled has been done in respect of all the seven Corporations. The analysis has been given in the subsequent paragraphs.
- 13.2 Voters A total of 1,626 polling stations were set up in all the 144 wards for polling of votes. There were 17,09,407 voters in all the Corporations, comprising 9,20,092 males and 7,89,315 females. The male and female voters constituted 53.8 and 46.2 percent respectively of the total number of voters. The details are given in Table 13.1:-

13.3 **Candidates** - In all 1,686 candidates contested the elections of all the Corporations, out of whom 1,043 were males and 643 females. The male and female candidates were in the ratio of 61.9 and 38.1 respectively of the total number of candidates. The details are given in Table 13.3.

- 13.4 The number of candidates elected according to gender and category of reservation is given in Table 13.4. The performance of the female candidates was better and their number was more than the seats reserved for them. Out of 144 members elected, 84 are males and 60 females. 45 women candidates were elected against the seats reserved for them and the remaining 15 against the seats which were open to both, males and females. In percentage terms, out of the elected candidates, 58.3% are males and 41.7% females.
 - 13.5 From the Table 13.4, it is also clear that against the 22 seats reserved for Scheduled Castes (14 for Scheduled Castes and 8 for Scheduled Castes Women), 13 male candidates and 12 female candidates were elected. 42 seats were reserved for women whereas 45 women from general category were elected, 14 seats were reserved for Backward Classes, whereas 23 candidates from Backward Classes were elected and 66 seats were unreserved against whom 51 were elected from general category. COUNTING OF VOTES AND DECLARATION OF RESULT

- Counting of votes is the most important stage of an election. Under the traditional system of voting by means of ballot papers and ballot boxes, the counting of votes used to be a very complex, laborious and time consuming process. The validity of each and every ballot paper polled at an election was to be decided after proper scrutiny and examination of each ballot paper. Very often, there were disputes and controversies with regard to the validity of ballot paper and the Returning Officers were required to resolve such disputes in respect of large number of ballot papers. All such disputes get totally eliminated by the use of electronic voting machines. The machine records correctly each vote polled by a voter by means of the voting machine and keeps an exact and up-to-date account candidate-wise of each vote so polled. All voters polled by means of a voting machine are valid votes and as such there will be no invalid or rejected vote in respect of any polling station where the voting machines have been used. Thus, with the use of electronic voting machines, the process of counting has become accurate, simple, easier and guicker. Besides, it has enhanced the confidence of voters and general public in the election system and the number of disputes has come down significantly.
- 14.2 Earlier, the counting of votes for the election of Corporations were held immediately after the close of the poll at the polling stations. On the basis of the experience of the elections of the Municipal Corporations, Faridabad and Gurgaon held in the years 2010 and 2011 respectively, the Commission decided to hold the counting at the centralized places on the pattern of the Assembly elections, at the place specified by the Deputy Commissioner concerned. This decision also gave sufficient time to hold re-poll, should such a situation arises.
- 14.3 Storage of EVMs -- Vide No.SEC/1ME/2013/2269, dated May 26, 2013 the Commission had issued detailed instructions to be followed by the Deputy Commissioners for the security and safety of strong rooms where the polled EVMs were kept for counting of votes as follows:-

- (i) The strong rooms should have double lock system. One key should be kept with Deputy Commissioner and the other with Returning Officer of concerned Municipal Corporation.
- (ii) Two cordoned security arrangements should be made round the clock for the strong rooms having polled EVMs kept for counting of votes. The police personnel of IRB/HAP should man the innermost perimeter security immediately outside the strong room and the police personnel of HAP/IRB should man the outermost perimeter security. If IRB personnel manages innermost perimeter, then HAP personnel shall manage outer most perimeter and vice versa.
- (iii) All contesting candidates should be intimated in writing to depute their representatives to keep a close watch on security arrangement of strong room. They should be allowed to stay outside the inner perimeter at a location, which enables them to view the entry points of the strong room. They should be allowed to stay outside the inner perimeter at a location, which enables them to view the entry points of the strong room. As far as possible, facilities such as proper shade, drinking water, etc. may be provided to them. If there is no direct view to the strong room, CCTV may be arranged at the location, so that they can see the strong room door n CCTV. In such a case, they may be taken periodically to the inner perimeter in batches to see for themselves and verify the strong room security.
- (iv) A control room adjacent to the strong room should be operative round the clock.
- (v) A Gazetted Officer along with a police officer should be put on duty round the clock for monitoring the security arrangements of strong room.
- (vi) There should be sufficient arrangement of fire extinguishers near and inside the strong room.
- (vii) There should be an arrangement round the clock for the security of unused EVMs also.
- (viii) No one should be allowed to enter the inner perimeter without following the protocol, as under:-
 - (a) The log book shall be maintained by the Police in which entry should be made about date, time, duration and name(s) of any

- one crossing the second security ring i.e. the middle perimeter. This includes visits by the Observers or Deputy Commissioner of Police or candidates or their agents or any other person.
- (b) Video cameras already available should be used by the police to record all visits made by such visitors.
- (ix) It should be ensured that there is uninterrupted power supply at the strong room locations during the entire period wherein EVMs are stored. Local Electricity Board officials should be asked to ensure the same. Contingency arrangement of stand by generators should be made to ensure uninterrupted power supply.
- (x) The phone nos. of Deputy Commissioner, Returning Officer concerned should be given to the candidates, who may provide the same to their people keeping vigil at the strong room location. They may be advised by the candidate to contact the officials in case of any need.
- (xi) All the entry points (doors etc.) of strong rooms should be under constant videography using the web-cams and laptops available. If there are other doors of the strong room, they should also be covered by the web-cams/videography. Persons coming to take back-up from the laptops should have identity cards given to them and their names should be recorded in advance with the Police contingent stationed there. Their visits should be video graphed by the Police contingent with the video camera provided for the entire duration.
- (xii) Returning Officers should visit the storage campus (up to the inner perimeter only) every day in the morning and evening and check the log book and videography and send a report to the Deputy Commissioner on the status every day. In case of strong rooms located in the district headquarters, the Deputy Commissioner should do the same.\
- (xiii) No vehicle, including that of any official or any other political functionary should be allowed inside the secured campus where the EVMs are stored. Alighting point for the vehicles should be marked clearly ahead of the outer security perimeter itself; beyond it should be a pedestrian zone only.

- (xiv) Deputy Commissioner or Senior Superintendent of Police/Deputy Commissioner of Police shall be personally responsible for security of strong room within the district and meticulous implementation of the protocol. The copy of this letter should be made available to all candidates, Returning Officer and Superintendent of Police/Deputy Commissioner of Police.
- 14.4 Counting of Votes and Compilation of Resuts- The Haryana Municipal Corporation Election Rules, 1994, prescribes System of Counting and Compilation of Results and Practice Adopted under the following rules:-
 - 14.4.1 **Scrutiny and Inspectin of Voting Machines** Rule 70T provides for scrutiny and inspection of voting machines before the counting, actual counting of votes recorded in the voting machines and declaration of result and sealing of voting machines after counting.
 - 14.4.2 **Checking Seals on Control Units** Rule 70S provides that before the votes recorded in any control unit of a voting machine are counted, the candidates, their election agents or their counting agents present at the counting table are allowed to inspect the outer strip seal, the special tag, the papers seals and such other vital seals as may have been affixed on the carrying case of the control unit to satisfy themselves that the seals are intact. The Returning Officer also satisfies himself that none of the voting machines is tampered with. If he is satisfied that any voting machine has in fact been tampered with, he shall not count the votes recorded in that machine and follow the procedure laid down in rules referred above in respect of the polling station where that machine was used.
 - 14.4.3 Counting of Votes After satisfying that the paper seal is intact, the control unit is the same as was supplied at the polling station and there is no tampering with the same, the votes recorded therein are counted. For the result, result button is pressed and the total number of votes recorded for each candidate of the polling station is displayed automatically on the Display Panels of the control unit. The counting supervisor records the number of such votes separately in respect of each candidate. After the result of voting recorded in a control unit has been ascertained, the same is entered candidate-wise in Part II -

- Result of Form 17 and in the Final Result Sheet in Form 8, for Municipal Corporation.
- 14.4.4 Resealing of Voting Machines after Counting After counting of votes, the control unit is required, under rule 70V of the rules ibid to be resealed with the seal of the Returning Officer and the seals of such of the candidates or their election agents who may desire to do so. The resealing has, however, to be done in such a manner that the result of voting recorded in the control unit is not obliterated and the unit retains the memory of such result.
- 14.4.5 Safe Custody of Voting Machines after Counting Sub-rule (2) of rule 70X provides that the voting machine sealed under rule 70V and kept in the custody of the Deputy Commissioner shall not be opened, inspected or produced except under the orders of a competent court. . Further clause (b) of rule 70Y of the rules ibid provides that the voting machines kept in custody of the Deputy Commissioner under the rules referred above shall be retained intact for such period as the State Election Commission may direct and cannot be used for next election without the prior approval of the State Election Commissioner.
- 14.5 **Sealing of Election Papers for Safe Custody -** Besides the voting machines, there are several important election papers, which require be sealing and storing safely. Under rule 70X (1) of the rules, the packets of election papers specified therein cannot be opened and their contents inspected by, or produced before, any person or authority except under the order of a competent court. Special care is required to be taken for the safe custody of these papers. In view of their importance, the papers are also required to be sealed with the seal of the Returning Officer.
- 14.6 Safe Custody of Election Records by Deputy Commissioner Immediately after the declaration of result of the election, on the same day and, in any case not later than the noon of the following day, all the voting machines and the sealed trunk(s) containing the packets mentioned in above paragraph are dispatched to the Deputy Commissioner or the Officer authorized by him at his headquarters and on receipt of the voting machines and the sealed trunk(s), the Deputy Commissioner forthwith arrange to deposit them for safe custody in the Treasury/Sub-Treasury under double lock. The key of one of the locks of each trunk is entrusted to the Treasury

Officer or an officer in the Treasury/Sub-Treasury authorized under the Treasury Code and the key of the other lock of each trunk is kept by the Deputy Commissioner himself or a senior officer nominated for the purpose by the Deputy Commissioner. The above mentioned procedure for counting of votes and declaration of result was followed for each and every ward of the seven municipal corporations where elections were held.

14.7 Notification of Elected Candidates - In pursuance of the provisions of subsection (1) of Section 14 of the Haryana Municipal Corporation Act, 1994, the Commission vide its notification No.SEC/1ME/2013/3221, dated 07.06.2013 has notified the names of the persons, who have been declared elected, as Members of Municipal Corporations in the General Election held on 02.06.2013. The notification is attached as Annexure 14.1

RESERVATION STATUS

- 15.1 As mentioned in Chapter-3 on "Delimitation and Reservation, Section 11 of the Haryana Municipal Corporation Act, 1994, provides reservation for Scheduled Castes, Scheduled Tribes, women and Backward Classes in seats and chairpersons of the Municipal Corporations. In accordance with the provisions of Sub-Section 8 of Section 11 of the Act ibid, the reservation is given effect to through notification issued by the Government before each election.
- 15.2 **Reservation of Seats in Municipal Corporations -** In all the seven municipal corporations, the ward numbers reserved for the scheduled castes, women belonging to the scheduled castes, backward classes and women and the unreserved wards, as per details given in Table 15.1, were notified by the Government under rule 10 of the Haryana Municipal Corporation Delimitation of Ward Rules, 1994, vide notifications discussed in para 2.6 of chapter 2 before the election programme was issued.

Chapter-16

ACCOUNT OF ELECTION EXPENDITURE FOR THE CONTESTING CANDIDATES

- 16.1 Legal Provisions Section 8B of the Haryana Municipal Corporation Act, 1994 provides the following:-
 - (i) Every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure in connection with the election incurred or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive.
 - (ii) The account shall contain such particulars, as may be notified by the State Election Commission in this behalf.
 - (iii) The total of such expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.
- In furtherance of the above provision of law, the State Election Commission vide its notification No.SEC/4ME/2007/7027, dated May 09, 2007 had revised the Haryana Municipal Election Expenditure (Maintenance and Submission of Account) Order, 1996, providing that the State Election Commission shall notify from time to time the Election Expenditure limit at election to be incurred by the candidate or authorized election agent. The order also provides that every contesting candidate at election shall have to maintain the day to day election expenditure account in accordance with the procedure as laid down in the order and shall lodge with the Deputy Commissioner or any other officer specified by the Commission in duplicate within 30 days from the date of declaration of result of the election. The Deputy Commissioner shall affix a notice on the notice board at his office within two days from the date, the account of election expenses have been lodged.
- 16.3 Earlier, the expenditure limit for a candidate contesting election of corporation was Rs.75,000. The Commission vide its notification No.SEC/3ME/2011/2789, dated 05/09/2011 had revised the expenditure limit to Rs.1,25,000. During a meeting held with all political parties on 25.04.2013 in connection with the elections of the seven Municipal Corporations, most of

the representatives of the political parties suggested that expenditure limit should be increased to Rs.5,00,000/-. The State Election Commission had assured them to look into the matter. After considering the matter, the State Election Commission revised the expenditure limit to Rs.1,75,000, vide its notification No.SEC/3ME/2013/2320, dated 02.05.2013.

16.4 Section 13D also provides that the Section 10A of the Representation of People Act, 1951 (RP Act, 1951) shall mutatis mutandis apply to the municipal elections which provides as under:-

Section 10A - In case a candidate

- (a) has failed to lodge an account of election expenses within the time and in the manner required by or any Act; and
- (b) has no good reason or jurisdiction for the failure, the State Election Commission shall, by order published in the Official Gazette, declare him to be disqualified and any person shall be disqualified for a period of three years from the date of the order.
- 16.5 Disqualification for not submitting Election Expenditure The polling for to the seven Municipal Corporation, Ambala, Hisar, Karnal, Panchkula, Panipat, Rohtak and Yamunanagar took place on June 2, 2013 and the results declared on June 4, 2013. Therefore, the election expenses account were required to be filed by July 3, 2013. Of the total 1,686 contesting candidates, 1,039 had submitted their expenditure statements within the prescribed period. A show cause notice to each of the the remaining 647 candidates, who had failed to submit their election expenditure statements, has already been issued and thereafter, 44 candidates have submitted their election expenditure statements. Further, action is being taken in the matter. The numbers of candidates who have and have not submitted accounts are given in Table 16.1.

Chapter-17

REVENUE RECEIPTS AND ELECTION EXPENDITURE

Receipts

17.1 During the Municipal Corporation General Elections, 2013, a sum of Rs.29,07,825 as revenue was generated from five sources - (i) forfeiture of security, (ii) sale of voters' list, (iii) sale of booklets, (iv) sale of expenditure registers, and (v) miscellaneous receipts. All the amount so received was deposited in the Government Treasuries by Deputy Commissioners-cum-District Election officers (Municipal) in the Receipt Head "0070-Other Administrative Services-02-Election-101 (Sale of Election Forms & Documents), 104 (Fees, Fines and Forfeiture) and 800 (Other Receipts of State Election Commission). The details are given in Table 17.1.

17.2 For conducting the Corporations' elections, a sum of Rs. 96, 62,534 towards POL and Election Expenses at field level and Rs.21, 66,165 towards the printing of ballot papers and the purchase and printing of election materials etc. at Headquarter was incurred. The expenditure towards salary, office expenditure, rent, rate and taxes and other items is of regular nature and has not been taken in account. The details are given in Tables 17.2 and 17.3.

Chapter-18

SOCIO-ECONOMIC PROFILE OF CANDIDATES

- 18.1 The State Election Commission has collected statistics relating to socioeconomic profile of the contesting candidates and the elected members. The
 age related data was collected in respect of all the contesting candidates.
 However, the information relating to educational qualification and occupation
 could be collected in respect of the elected members only. The statistics so
 received have been analyzed to generate some useful information in this
 Chapter. The Commission has also decided to obtain information in respect
 of educational qualification, occupation and age of all the candidates who
 contest elections as and when held held in future.
- 18.2 **Age** In all the seven municipal corporations, out of 1,686 contesting candidates, 238 (14.1%) were in the age group of 21-30 years, 591 (35.1%) in the age group of 31-40 years, 470 (27.9%) in the age group of 41-50 years, 272 (16.1%) and in the age group of 51-60 years. Only 115 (6.8%) candidates were of the age above 60 years. The number of contesting candidates in various age groups and their percentages are given in Table 18.1. It is interesting to note that in percentage terms, there were lesser women candidates than men in the age groups 51-60 years and above 60 years.

18.3 In respect of 144 elected members, 10 (6.9%) were in the age group of 21- 30 years, 56 (38.9%) in the age group of 31-40 years, 48 (33.3%) in the age group of 41-50 years, 25 (17.4%) in the age group of 51-60 years and only 5 (3.5%) members were of the age above 60 years. It is interesting to note that the age of more than three-fourth (79.2%) of all the elected members was up to 50 years. Only 3.5 percent of the elected members were of the age above 60 years. The percentage of elected members in different age groups according to gender shows that 75% of the male elected members and 85% percent of the female elected members were up to the age of 50 years. The details are given in Table 18.2.

18.5 Educational Qualification – The educational profile of all the 144 elected members have also been categorized in different groups based on their educational qualification and the results have been summarized and given in Table 18.4. It is significant to note that 99.3 percent members were educated and only 0.7 percent illiterates. 3.8 percent members have obtained professional degrees, e.g. Law and Engineering. 8.3 percent members were

Graduates. 25.0 percent of the elected members were Matriculate and 27.1 percent members below Matriculate.

18.6 **Occupation** – The occupation profile of all the 144 elected members have also been categorized according to their occupation/profession. The summary has been given in Table 18.5. It may be observed from the Table that the highest number of elected members in case of male were businessmen (43.1%) and in case of female, house wives (36.1%), followed by farmers constituting 11.8 percent. Advocates and Servicemen/ESM constituted 1.4 and 2.1 percent respectively of the total number of elected members.

Chapter-19

ELECTION OF CHAIRPERSONS

- 19.1 Legal Provisions Under Section 36 of the Haryana Municipal Corporation Act, 1994 read with Rule 71 of the Haryana Municipal Corporation Elections Rules, 1994, one of the elected members of a municipal corporation is elected as Mayor for a period of five years or the residue of the term of his office, whichever is less and the member so elected becomes Mayor of the Corporation.
- 19.2 Similarly, two of the elected members of a corporation are elected as Senior Deputy Mayor and Deputy Mayor for a period of five years or the residue of the term of their office as a member, whichever is less.
- 19.3 Reservation of Office of Mayor The Government had, vide its notification No.14/34/2010-5C-1, dated June 8, 2010, No.4/20/2011-3CL, dated May 20, 2011 and No. 18/28/2013-3C1, dated March 9, 2013, notified that the office of Mayors of the seven Municipal Corporations shall be filled-up from the categories referred below:-

19.4 As per provisions of Rule 71 of the Haryana Municipal Corporation Elections Rules, 1994, the Divisional Commissioner of the Municipal Corporation concerned, within a period of thirty days of the notification of the names of the members elected to the corporation, convenes and preside over the first meeting of the newly constituted corporation at the forty eight hours notice to be delivered at the ordinary place of residence of elected members. The

notice shall clearly state that the oath of allegiance shall be administrated to the members present and that the election of Mayor shall also be held in this meeting. The rule 71(1A) further provides that the Commissioner shall, within a period of sixty days of the notification of the names of the members elected to the Corporation, convene a meeting of the Corporation at forty eight hours notice to be delivered at the ordinary place of residence of members. The notice shall clearly state that the election of Senior Deputy Mayor and Deputy Mayor shall be held in this meeting to be presided over by the Mayor in the presence of Commissioner.

19.5 The election of the Mayor, Senior Deputy Mayor and Deputy Mayor of the Municipal Corporation, Ambala, Karnal, Hisar, Panipat, Panchkula, Rohtak and Yamunanagar were held on different dates by the authorities mentioned above. The names of the elected Mayor, Senior Deputy Mayor and Deputy Mayor are notified by the State Government. As per information received from the Government, the names of the elected Mayor, Senior Deputy Mayor and Deputy Mayor are given in Table 19.1.

Chapter -20

ELECTION PETITIONS

- 20.1 Rule 78(1) of the Haryana Municipal Corporation Election Rules, 1994 provides that no election of a member shall be called in question except by an election petition presented to the Tribunal and rule 78(2) provides that an election petition against the return of a candidate to an election or against the return of Mayor or Senior Deputy Mayor or Deputy Mayor or against unsuccessful candidates with a view to his disqualification on the ground of a corrupt practice or material irregularity in the procedure shall be in writing signed by a person, who was a candidate at such election.
- 20.2 Rule 77 of the rules ibid also provides the following
 - (1) the Government shall appoint a Tribunal to hold an enquiry in accordance with the provisions of these rules.
 - (2) In the case of a one man Tribunal, the appointment shall be made from amongst:-
 - (a) Subordinate Judges of the 1st Class belonging to the State Judicial Service; or
 - (b) Persons who may have retired from the State Judicial Service as a District Judge.
 - (3) In the case of multi member Tribunal, at least one member shall be appointed from amongst the category of persons mentioned in sub-Rule (2) and the remaining members of the Tribunal may be appointed from amongst advocates duly enrolled as such under the Advocates Act, 1961, who may have served at the bar of the State High Court for a minimum period of ten years. The member appointed under sub-Rule (2) shall be designated as the Chairman of the Tribunal.
 - (4) The remunerations and terms of appointment of members other than those who are serving members of the State Judicial Service shall be such as may be specified by the Government.
 - (5) The Government may appoint a person by name or by office to be a Tribunal, and if a person is appointed by virtue of his office, the person for the time being holding the office shall be the Tribunal unless the Government otherwise directs.
 - (6) If a vacancy occurs in a Tribunal by reason of a death, resignation or any other causes, the Government may make a fresh appointment.

- (7) If on the application of any party to an election petition the Government is satisfied that there are reasonable grounds for the transfer of case from the Tribunal appointed to hear such an election petition, it may appoint a fresh Tribunal as provided heretofore.
- (8) A change of incumbency in the Tribunal whether by reasons of death, transfer, resignation or any other reason shall not invalidate any provision or subsequent proceedings in any matter pending before it, nor shall it be necessary for a Tribunal on account of such change, to recommence any enquiry into any matter pending before it for disposal.
- 20.3 The Government, vide its notification no.18/80/2013-3Cl dated 5th July, 2013, had notified that the Civil Judges (Senior Division) posted in the Municipal Corporations, Ambala, Hisar, Karnal, Panipat, Panchkula, Rohtak and Yamuna Nagar as one man Tribunal to hold enquiries in accordance with these rules. Though, the elections of the Corporations were held peacefully and there was no repoll, fourteen election petitions have been filed as per the details given in Table 20.1. The petions are still pending.

CHAPTER-21

APPLICATION OF ICT IN GENERAL ELECTIONS TO MUNICIPAL CORPORATIONS - 2013

- The local bodies' elections evoke huge enthusiasm and interest amongst the public and political parties, whether they contest elections on party lines or not. Usually the number of candidates contesting these elections is large and the percentage of votes polled very high. All actions of the officials, who manage elections, are under intense public scrutiny and it is important to generate confidence amongst the public. Therefore, elections are not only required to be conducted with impartiality, but appear to have been done so. The application of information and communication technologies (ICT) in elections helps doing so by improving efficiency, bringing transparency and reaching out to the public, candidates, media and political parties, thus achieving the objective of conducting elections in a free and fair manner to the satisfaction of all stakeholders.
- 2. The municipal elections, like other elections, involve a large number of time bound processes, starting with the preparation of electoral rolls and thereafter, announcement of elections, polling and ending with counting, declaration of results and notification thereof. The entire exercise is complex involving a large number of officials and departments. Realising the multiple benefits of the application of the ICT in elections, the State Election Commission decided to use them extensively in the Municipal Corporations Elections 2013.
- 3. Introduction of ICT in Municipal Corporations General Elections 2013: The Commission assigned the task of developing ICT based solutions to the National Informatics Centre, Haryana and also obtained services of a private agency for certain tasks. The following areas were identified for which the ICT solutions were developed and successfully implemented:-
 - Uploading Notifications, Orders and Instructions on the Commission's Website – All general communications, instructions, notifications, orders etc. of the Commission were uploaded and updated on its official website, http://secharyana.gov.in.
 - b. **Preparation of Electoral Rolls** The draft electoral rolls were prepared ward-wise by converting the Assembly rolls of the areas

falling within the Corporation concerned. The databases of the Assembly rolls were obtained from the Chief Electoral Officer, Haryana and transferred to various field offices through NICNET. The ward marking, data processing and the preparation of the draft rolls was done at field units, using the software designed to migrate assembly rolls to the local bodies' rolls. Final data after ward-marking, running de-duplication and correction software was made to sync with the central server at the NIC Data Centre over NICNET. This data was finally linked to a web based voter helpline making it available to the voters to check their names in the draft rolls. The electoral rolls were also hosted on the NIC State Data Centre with links on the websites of the Commission and district administration concerned for inviting claims and objections from the public. The CDs of the rolls were also given to the political parties.


- c. Claims and Objections from Public A centralized solution, developed by the NIC, Haryana, was used to accept claims and objections on a centralized server, which were decided by the concerned authorities to whom, they were submitted online. Anyone could see the status of his/her claim online.
- d. Setting up of Voter Information and Collection Centres (VICCs) As mentioned in para 3.14 of Chapter 3, 93 VICCs were setup in all seven municipal corporation to furnish information to the public about elections, their status as electors or other electors and to receive applications for registration in roll rolls and objections in respect of other entries in the rolls. All the VICCs were equipped with internet connection, computer, printer and phone. Every claim and objection received at the VICCs was entered in the online system and the persons filing claims and objects were given an acknowledgement number, which could be used to track their applications online.
- e. Publication of Electoral Rolls and Distribution of Voters' Slip –
 After disposal of all claims and objections, it was decided to covert the
 ward-wise rolls into polling station-wise rolls for better clarity and public
 satisfaction. With the electronic databases, it was very convenient to
 divide the ward-wise rolls into polling station-wise rolls. Accordingly, the

rolls were prepared and published as such. Voter slips with photos were generated using the electoral databases to every voter and distributed to all voters. The slips were used as the proof of voters.



Snapshot of an electoral roll


f. Know Your Candidate (KYC) Application – Every candidate was required to submit with his nomination information in the prescribed formatse.g. criminal background and the details of moveable and immoveable assets. All these documents were scanned and uploaded on http://mcelections.nic.in/kyc with hyperlinks to the websites of the Commission and the district administration for the information of the public.




A screenshot of Know Your Candidate web application

g. Duty Assignment and Randomization of Polling Parties – The duty assignment of polling staff and randomization of polling parties was done through computer software. The necessary information about polling parties was disseminated to the respective Presiding Officers through SMS using Government SMPP gateway. A well tested software, developed by National Informatics Centre, Haryana was used for randomization and duty assignment of the polling staff in all districts.

h. GIS Mapping of Polling Stations on Web - The Commission got an elaborate GIS portal developed through ilex Softhub Pvt. Ltd, Panchkula at a cost of Rs. 30,000/- only. The portal provided facilities for backend data updation and was linked to Google Earth for depicting GIS information of the wards and polling stations. The GIS data of all polling stations and their photographs were collected through the field offices with the help of Android based phones having GPS facility. The GIS lat-long of all the polling stations with their photographs were uploaded on the GIS portal. Electoral rolls and addresses and photographs of all the polling station buildings were attached to the GIS locations. The names and contact numbers of the Booth Level Officers were also provided. Convenient browsing and search facility was made part of the application to make it more user friendly.




GIS portal showing booth details and voter's information




Polling booths information of a particular ward

- i. E-Dashboards for Monitoring of Polling, Counting and Results A web based e-dashboard was developed to monitor entire poll process starting from of departure of polling parties and setting of polling stations till the counting and display of results. The portal provided the following information in respect of every polling station:-
 - Day before Polling Day Dispatch of polling parties, establishment of polling stations,
 - Polling Day Start of polling, whether polling is going on smoothly, law and order situation, polling percentage on a regular basis, close of polling etc. and
 - Counting Counting of votes with update on a regular basis.

All these statistics were available on the dashboard polling station-wise and were updated through SMS using predefined SMS codes. The data on these e-dashboards was uploaded from the polling booths and the counting centers. Mobile number of each presiding officer was preregistered and each Presiding Officer was given an amount of Rs 100/for meeting the cost of sending SMS alerts to keep the e-Dashboards up-to-date. The training on sending the SMSes was provided to all presiding Officers well in advance.

j. Website Hit Statistics for E-Dashboards - Since every type of information relating to the municipal corporations' elections was available on the website, most of the people, including media persons, preferred to visit it instead of going to the election offices or contacting the officers, more so on the polling and the counting days. At the State level, most of the media persons were busy in the media room set up by the Commission, where they were able to get the latest updates.

The public was also accessing the latest information from the dashboard. This is evident from the following website hit statistics obtained from the NIC:-

Number of website hits on the day of polling	8,62,936
Number of website hits on the counting day	20,40,565

The hit statistics show that the website and the dashboards were very popular with general public and the media, who did not have to waste time in contacting various authorities to get the poll related information.

- k. Cost Effectiveness The whole system was highly cost effective as no additional expenditure was incurred in terms of manpower, hardware and software resources, transport etc. As the NIC, Haryana developed the software and implemented, there are hardly any expenditure. The polling staff was given training on use of SMSes and SMS formats. No additional manpower was hired for project development and implementation. However, a small expenditure of Rs. 35,000/- was made for the development of the GIS portal through a private vendor, which is insignificant considering the expenditure made for holding the elections and the benefit in terms of the enormous public interface. Besides, it was very useful for the district administration and the Commission, who could monitor the conduct of polling and counting of votes on a regular basis.
- In view of the experience gained in using the ICT in the Municipal Corporations Elections 2013, the Commission will consider using the ICT in the General Elections of Panchayats and the urban local bodies. The following additional features could be considered for making the applications more useful:
 - o online tracking of the movement of the vans carrying election material through GPS or mobile service providers and
 - Development of mobile apps in addition to the use of SMS technology.

ANNEXURE-6.1

QUALIFICATIONS AND DISQUALIFICATIONS FOR CANDIDATE

Qualifications - A person shall not be qualified to be chosen as a member unless :-

- (a) he has attained twenty-one years of age and
- (b) his name is registered as an elector in the electoral roll of a ward in the Municipal area.

Disqualifications— (1) A person shall be disqualified for being chosen as, and for being a member of the Corporation

- (a) if he is so disqualified by or under any law for the time being in force for the purposes of elections to the Legislature of the State:
- (b) if he is so disqualified by or under any law made by the Legislature of the State.
- (2) A person shall also be disqualified for being chosen as, and for being a member—
 - (a) if he is of unsound mind and stands so declared by a competent court;
 - (b) if he is an undercharged insolvent;
 - (c) if he is not a citizen of India, or has voluntarily acquired the citizenship of a foreign State, or is under any acknowledgement of allegiance or adherence to a foreign State;
 - (d) if he has, in proceedings for questioning the validity or regularity of an election, been found to have been guilty of
 - i. any corrupt practice under section 22 of this Act;
 - ii. any offence punishable under section 171-E or 171-F of the Indian Penal Code, 1860, or any offence punishable under section 30 or clause (a) of sub-section (2) of section 31 of the Act;

unless a period of five years has elapsed since the date of the finding:

- (e) if he has been sentenced or convicted by a criminal court to imprisonment for an offence involving moral turpitude;
- (f) if he holds any office of profits under the Corporation;
- (g) if he is a licensed architect, draftsman, engineer, plumber, surveyor or town planner or is a partner of a firm of which any such licensed person is also a partner;
- (h) if he holds any office of profit under the Government;
- (i) if he interested in any subsisting contract made with, or any work being done for the Corporation except as a share holder (other than a director) in an incorporated company or as a member of a co-operative society;
- (j) if he is retained or employed in any professional capacity either personally or in the name of a firm of which he is a partner or with which he is engaged in a professional capacity, in connection with any cause or proceedings in which the

- Corporation or any of municipal authorities is interested or concerned;
- (k) if he, having held any office under the Government the Corporation or any other local authority, any Government company or any corporate body owned or controlled by the Government has been dismissed from service;
- (I) if he fails to pay any arrears of any kind due to him, otherwise, than as an agent, receiver, trustee or an executor, to the Corporation within three months after a notice in this behalf has been served upon him;
- (m) if he furnishes a false caste certificate at the time of filing nomination and he shall be so disqualified for a period of six years from contesting the election of the Corporation;
- (n) if he is convicted or has been convicted of an offence punishable under section 29, 30 and 31 of the principal Act, the Prevention of Corruption Act, 1988 (49 of 1988) or the Prevention of Terrorism Act, 2002(15 of 2002).
- (3) Notwithstanding anything contained in sub-section (1) and (2) above.-
 - (a) a disqualification under clause (e) of sub-section (2) shall not take effect until three months have elapsed since the date of such disqualification or if within these three months an appeal or petition for revision is brought in respect of the conviction or sentence until that appeal or petition is disposed of;
 - (b) a person shall not be deemed to have incurred any disqualification under clause (f), or clause (g) of sub-section (2) by reason only of his receiving
 - i) any pension; or
 - ii) any allowance or facility for serving us a Mayor of Deputy Mayor or as a member; or
 - iii) any fee for attendance at a meeting of any committee of the Corporation;
 - (c) a person shall not be deemed to have any interest in a contract or work such as is referred to in clause (i) of sub-section (2) by reason only of his having a share or interest in.
 - i) any lease, sale, exchange or purchase of immovable property or any agreement for the same; or
 - ii) any agreement for the loan of money or any security for the payment of money only; or
 - iii) any newspaper in which any advertisement relating to the affairs of the Corporation is inserted; or
 - iv) the sale to the Corporation or to any other municipal authority or any officer or other employee of the Corporation on behalf of the Corporation of any article in which he regularly trades or purchases from the Corporation or from any such authority, officer or other employee on behalf of the Corporation of any article of a value in either case not exceeding five thousand rupees in the aggregate in any year during the period of the contract or work; or
 - v) the letting out on hire to the Corporation or the expiry from the Corporation of any article of a value not

- exceeding two thousand rupees in the aggregate in any year during the period of the contract or work;
- vi) any agreement or contract with the Corporation or any other municipal authority for taking water or any other thing which the Corporation may generally supply.
- (4) If a person sits or votes as a member of the Corporation where he is not qualified or that he is disqualified for such membership he shall be liable in respect of each day on which he so sits or votes to penalty of five hundred rupees to be recovered as an arrear of tax under this Act.
- (5) If any question arises as to whether a member of the Corporation has become subject to any of the disqualifications mentioned In subsections (1) and (2) the question shall be referred for decision of such authority and in such manner as the Government may by notification provide.

The State Election Commission to be the authority, for the purpose of sub-section (1) and (2) of the section, to whom the case shall be referred to for decision through the Deputy Commissioner whose decision shall be final.

No candidate has been disqualified by the Commission under any provision contained in Section 8 of the Haryana Municipal Corporation Act, 1994.

Additional Disqualification:

No person shall be eligible for election as a member of the Corporation who, in the case of a seat reserved for Scheduled caste, Backward Classes or a woman, is not a member of any of these categories.

Annexure-11.1

General Guidelines for Election Observers (Elections)

1.	You must visit the Corporation assigned to you at least four times – (i) before the last date of filing nominations, (ii) scrutiny of nominations, allotment of symbols and publication of final list of contesting candidates, (iii) during campaign period and training session, (iii) second randomization of poll staff, formation of polling parties, distribution of poll material and till polling is over and EVMs are delivered back and stored safely and (iv) day of counting and declaration of results.
	This is indicative. If situation so warrants, you must visit the area more frequently and stay as long as required.
2.	Review whether necessary arrangements for the conduct of free, fair and peaceful elections have been made as per provisions contained of the Haryana Municipal Corporation Act, 1994, the Haryana Municipal Corporation Election Rules, 1994 and instructions issued by the State Election Commission from time to time.
3.	For above purpose you may hold a meeting with the DC, RO/SSP/ DCP and other officers as required to review the election related arrangements. In particular, review whether the district administration has taken steps so that women and weaker sections of the society are able to use their right of franchise in a free and fair manner.
4.	Review whether the election related complaints received by the DCs, SSPs/DCPs, ROs etc. have been attended to and disposed off?
5.	Review law and order arrangements made by district administration at the polling station and in the Corporation area, whether sensitive and hyper sensitive polling stations and areas have been identified, whether adequate police force is proposed to be deployed and all other necessary security arrangements have been made to deal with any law and order problem in the Corporation/Committee area so that the polling takes place in peaceful, free and fair manner. Review the status of parole and bail jumpers and arms license. Please see the letter no. dated issued by the Commission as Annexure-7.
6.	Ascertain whether Deputy Commissioner has stored sufficient quantity of election material, especially EVMs, ballot papers, indelible ink and voters' lists.
7.	Ascertain whether the officer concerned has checked all the EVMs and they are in working order.
8.	Ascertain whether electoral rolls along with supplements of all wards/ polling stations have been uploaded on the website of the district administration. Check on random basis whether electoral rolls to be provided to Presiding Officers are error free, complete and up to date and there is no entry in the roll without the orders of the competent authority.
9.	Observe whether the instructions issued by the Commission regarding prevention of defacement of property etc. (copy enclosed as Annexure -6) are followed in letter and spirit.
10.	The Commission has decided to deliver slip to every voter before the day of polling. Please check whether slips have been delivered to voters.

11. Visit a few polling stations on the day before the polling and observe whether polling stations have been set up properly. You should give special attention to (i) the polling stations having large population of Scheduled Castes and Backward Classes and (ii) the buildings in which four or more polling stations have been established. 12. Inspect with DC, SSP/DCP and RO / ARO all the buildings for receipt and storage of EVMs after the poll and counting centers. Review the security arrangements in respect of safe storage and counting of votes. 13. Ascertain whether the model code of conduct issued for the Govt. employees and contesting candidates is being followed and the District Administration is vigilant about its enforcement. 14. You may attend as an Observer the meeting(s) of the contesting candidates and political parties, if convened by the Deputy Commissioner and/or Returning Officer, but you should not call any meeting of the contesting candidates / political parties independently. 15. You should be easily accessible to the political parties, candidates and the public and send his complaint / representation / suggestion to the Deputy Commissioner, Returning Officer or any other officer for appropriate action and inform you of the action taken. 16. Check at least 8 polling stations before the day of poll to ensure that all polling parties have reached in time and set up polling stations. 17. On the day of poll, visit polling stations to observe whether the polling is taking place satisfactorily and in a free and fair manner. Whether Presiding Officer is maintain Daily Diary and Polling Officer at Sr. No.1 is following due process of identification of voters. 18. On the day of poll, also see law and order arrangements at the polling stations, effectiveness of police patrol parties, police force in reserve and supervisory officers. 19. Any report which you want to send to the Commission should be kept confidential. Besides, it should not be discussed and / or shared with anyone at any stage. 20. You should send information to the Commission through fax / telephone / email Immediately after the close of poll and safe return of the parties with the EVMs etc. If there is any disturbance, send a detailed report. 21. Minutes of the meeting held on may 9, 2013 at 10.30. AM under the chairmanship of Shri Dharam Vir, State Election Commissioner, Haryana at Nirvachan Sadan, Plot No 2, Sector-17, Panchkula

- 1 The following officers participated in the meeting:
 - i. Sh. Samir Mathur, IAS, Additional Chief Secretary, Home, Haryana.
 - ii. Sh. S.N. Vashishth, IPS, Director General of Police, Harvana.
 - iii. Sh. K. K. Sharma, IPS, ADGP, Law & Order, Haryana.
 - iv. Sh. Subhash Mehta, Secretary, State Election Commission, Haryana.
 - v. Sh. Puran Mal, OSD (Elections), State Election Commission, Haryana.
 - Shri Dharam Vir, State Election Commissioner, Haryana welcomed the officers and explained 2 the purpose of the meeting. He said that the Commission has decided to hold general elections of seven newly constituted seven municipal corporations, two municipal committee and a few bye-elections of vacant seats of municipal bodies on June 2, 2013 and the present meeting has been convened to discuss the law and order arrangements for conducting the elections. The State Election Commissioner (SEC) explained that the steps that are proposed to be taken to conduct the elections. He also gave lists of corporations with number of wards, voters and polling stations proposed to be set up for the elections. He said that for the convenience of the public, candidates, political parties and administration, lists of voters, wards and polling stations have been uploaded on the website of the State Election Commission (http://secharyana.gov.in) with convenient search options. Any person can search his status and polling station where he has to go to cast his vote. Before the day of polling, a slip would delivered to every voter giving his number and location of polling station. In addition, all polling stations have been mapped using GIS/GPS technology and marked on the maps using the Google Earth. Such mapping will provide a very good base for planning and managing law and order during elections in a very effective manner. The SEC also said that there is considerable excitement in the public about these elections and turnout is likely to be high. At the outset, both Shri samir mathur, ACS, Home and Shri Vashist, DGP assured that fool proof arrangements would be made and action taken for conducting elections in a peaceful manner.
- 3 After the brief introduction, the following points relating law and order arrangements were discussed and decisions taken:
 - i. Maintaining Close Watch on Law and Order Situation The SEC requested the DGP to maintain close watch on the law and order situation in areas where elections would take place, on parole and bail jumpers and history sheeters. Wherever required, the police should take action under the relevant provisions of law. Flag march may be organized in sensitive areas, especially where population is predominantly weaker sections. The ACS, Home and the DGP assured that needful would be done.

- ii. Deployment of Police Force The DGP assured that police force in large number would be deployed to maintain law and order at the polling booths and none would be allowed to disturb it. For this purpose and for meeting the serious law and order during the polling, the SEC requested that HAP and IRB may be kept in reserve well in advance in every corporation area. The DGP agreed to this suggestion.
- iii. Daily Law & Order Report It was agreed to send daily report on law and order on the pattern of elections of Lok Sabha / Vidhan Sabha.
- iv. Sensitive / Hypersensitive Polling Stations and Areas— The DGP said that after identification of such polling stations, sufficient police would be deployed.
- v. Building where more than four polling stations have been set up Special attention would be made for such buildings.
- vi. Bail and Parole Jumpers and history Sheeters Close watch would be kept on such persons and efforts would be made to nab the bail and parole jumpers.
- vii. Arms Licenses No new license should be issued till the elections are complete.
- viii. Counting Centers As the counting would be centralized and take place one day after the polling, adequate security arrangements (including deployment of HAP and IRB) shall be made for safe storage of EVMs and counting of votes. Details would be worked by the DC and SSP concerned.
- ix. Patrol Parties There would be sufficient number of Police Patrol parties, at least one per ward. Every polling station should be visited in routine by the patrol as frequently as possible, at least once hour.
- x. Supervisory Officers For every corporation area, there would be sufficient number of supervisory officers, say one per ward, who would have extra manpower for deployment at the polling station in case of emergency. In addition, he would carry a few spare EVMs to provide replacement wherever required without loss of time.
- xi. Videography of Sensitive / Hypersensitive Polling Stations the DGP agreed to use the video cameras and other equipment already available with district police for videography.
- xii. Information about voting and Law & Order by Presiding Officers Every Presiding Officer shall be asked to send an SMS every hour or more often about the no of votes polled and law and order. The Dc and SP could tie up so that the Presiding Officer can broadcast such information to police authorities.
- xiii. Coordination There should be complete coordination between civil and police officials at all levels, especially at the operational level. DC and SSP should work out the details.
- xiv. Sale of Liquor It may be ensured that there is no sale of liquor after the closure of election campaign.

The meeting ended with a vote of thanks to the Chair.

ORDER

Subject:- Restriction on use of vehicles on poll day for the Municipal General elections, June, 2013.

The State Election Commission, Haryana has issued Election Programme for the General Elections to Municipal Corporation, Ambala, Panchkula, Karnal, Panipat, Hisar, Rohtak, Yamuna Nagar, Municipal Committee, Kalanaur (Rohtak), Farukh Nagar (Gurgaon), bye elections in Ward No.3 of Municipal Council, Narwana, District Jind and Ward No.7 of Municipal Committee, Gharaunda, Distt. Karnal vide its Notifications No. SEC/IME/2013/2387 and No.SEC/1ME/2013/2415, dated 09/05/2013 according to which the poll shall take place on 02/06/2013.

- 2. In the interest of preserving the fairness of election process and rendering the same reflective of true choice of the people, the State Election Commission has issued instructions and directions on various aspects. The Commission has particularly been concerned about the increasingly vitiating role of criminality and muscle power at elections and has been directing the taking of a number of measures for ensuring peaceful, free and fair poll.
- 3. One of the ways in which the voter sought to be wooed is by providing him the "facility of free transport" on the day of poll.
- 4. The State Election Commission further observes that during the hour/period of election, private vehicles are used by the candidates, their agents and supporters for carting the supporters of a candidate within the wards and on many occasions the anti-social elements with muscle power are openly paraded to create a sense of fear in the minds of the voters, so that they either vote in favour of a particular candidate or abstain from voting altogether. These vehicles are also used some times to smuggle arms and ammunition with a view to create disturbances during the elections.
- 5. In order to curb such undesirable and illegal activities, the State Election Commission in exercise of the powers vested in it under Article 243ZA of the Constitution of India read with Section 3A of the Haryana Municipal Act, 1973 and all other powers enabling it in this behalf, hereby imposes restriction to hire or procure not more than 2 vehicles or vessels whether on payment or otherwise for use by a contesting candidate himself or his agents or his supporters on the day of poll during the Municipal General Election.
- 6. The State Election Commission further directs that the expression "Vehicle" means any vehicle used or capable of being used for the purpose of road transport whether propelled by mechanical power or otherwise, and whether used for drawing other vehicle or otherwise.
- 7. The State Election Commission further directs that the contesting candidates should be issued permits as per proforma prescribed by the Commission appended herewith. The permits should be issued to the contesting candidates at least 2 days before the day of poll.
- 8. The State Election Commission further directs that the District Administration shall keep a close watch on the vehicles used by persons accompanying the contesting candidates and their supporters for any possible mischief, including criminal activities like carrying of illegal arms and

weapons. If any of these vehicles, either of a contesting candidate or a private owner, is found to be involved in any such act or for carting anti-social elements with a view to intimidating or creating terror in the minds of the voters, it should be the duty of the local administration to impound such vehicles and not to release them till the process of elections is completed. In addition, accordingly action against the owner, the occupant/occupants and the candidate who is involved in such illegal activities shall also be taken as per law.

- 9. So as to ensure free, fair and peaceful elections, the District Administration shall launch a drive for checking the vehicles immediately upon the announcement of the elections and shall continue the drive till the completion of the process of elections.
- A copy of this order shall be made available to the local units of all recognized National/State Political Parties in the State of Haryana immediately and to each contesting candidates, or an agent authorized by him.
