### **PREFACE**



Free and fair elections are the foundation of a healthy democracy. Parts IX and IXA of the Constitution of India brought into force by the 73<sup>rd</sup> and the 74<sup>th</sup> Constitutional amendments, deal with matters relating to the constitution, composition and the functional ambit of the Panchayats and

Municipalities respectively. By virtue of the **Articles 243K and 243ZA**, the responsibility for superintendence, direction and control of the preparation of electoral rolls for, and the conduct of elections to, the Panchayats and Municipalities have been vested in the State Election Commission. Subject to the provisions of the Constitution, the Legislature of a State may, by law, make provisions with respect to all matters relating to, or in connection with elections to such local bodies.

The State Election Commission is a constitutional body responsible for the conduct and supervision of elections to the Panchayati Raj Institutions in the State of Haryana. We are also required to bring about the work of Election Commission in a transparent manner for all, interested to see it including many progressive groups and individuals who have contributed their time, energy and ideas in order to make the 3rd General Elections of Panchayati Raj Institutions a great success, in all respects.

I am pleased to present this **Election Report** for the 3<sup>rd</sup> General Elections to Panchayati Raj Institutions and on some important achievements of the State Election Commission of Haryana. This narrative report by the State Election Commission, Haryana gives you a comprehensive account of election events in the relevant period. The present State Election Commission has made some major efforts in various directions for improving the system and has taken numerous initiatives to enhance the capability of this Commission to conduct

peaceful and fair elections in the State of Haryana. This time State Election Commission has completed this gigantic task and stupendous work within a lesser amount of budget by making a saving of about one crore rupees of public money/budget for the conduct of 3<sup>rd</sup> General Elections. This has been brought out in details in the different chapters of this report. The process of saving public money also continues even after the elections are over and also follow up action to continue for electoral reforms including improvements in the existing laws and rules related to the elections at grass root level by initiating dialogue with the State Government. It is also heartening to see the enthusiasm shown by number of officers and officials working round the clock to complete this process of all elections within a short period of 31 days, only.

I would like to put on record my appreciation for assistance rendered for successful organisation of the third General Elections by all the officers and staff of the State Election Commission as well as all the Deputy Commissioners, Sub-Divisional Magistrates, City Magistrates, District Development & Panchayat Officers and other supporting staff of field offices. I have issued appreciation letters to all the Deputy Commissioners with a copy to Chief Secretary's office with a request that appreciation letters be placed in their service record, also.

I hope that the present report will prove a valuable asset for this Commission and the field offices specially District Election Officers-cum-Deputy Commissioners, Electoral Registration Officers, Policy Planners, Scholars and other organizations, as some guidelines with minute details have been provided in the various chapters of this report.

### STATE ELECTION COMMISSION, HARYANA

The State Election Commission, which is a creation of the Constitution (Seventy Third and Seventy fourth) Amendment Acts, 1992, was constituted in the State of Haryana w.e.f. 18<sup>th</sup> November, 1993 vide the State Government's Notification No.SO.101/Const.Art.243A/243ZA/93.

The provisions relating to the status and powers of the State Election Commission in Article 243K and 243ZA are analogous to the powers and status of the Election Commission of India provided under Article 324 (1) of the Constitution of India. The only difference in these two provisions is that the State Election Commission has been entrusted with the responsibilities for the preparation of the electoral rolls for, and the conduct of, all elections to the Panchayati Raj Institutions and Municipalities under Articles 243K and 243ZA and the Election Commission of India has been assigned the responsibility for the preparation of electoral rolls for, and the conduct of, all elections of Parliament and to the Legislatures of every State and of elections to the offices of President and Vice President of India. In order to ensure that the State Election Commission functions as an independent **Constitutional body** outside the executive to enable it to conduct the elections to the Panchayats and Municipalities in a free and fair manner, the concept of independence has been made far explicit in the provisions of Article 243K (2) which provides that the State Election Commissioner shall not be removed from his office except in the like manner and on the like grounds as the Judge of a High Court and the Conditions of Service of the State Election Commissioner shall not be varied to his disadvantage after his appointment. The State Election Commission, unlike the Election Commission of India, is Commission headed by the State Election Commissioner, who is appointed by the Governor of the State under clause (2) of Article 243K of the Constitution of India. Clause (3) of Article

243K explicitly provides that the Governor of the State shall, when so requested by the State Election Commission, make available to the State Election Commission such staff as may be necessary for the discharge of functions conferred on the State Election Commission by clause (1).

In pursuance of the above Constitutional provisions, the Legislature of the State of Haryana has also, in the Haryana Panchayati Raj Act, 1994, made provisions in this regard in consonance with the provisions of Article 243K of the Constitution of India. Section 212 of the Haryana Panchayati Raj Act, 1994 provides the powers and responsibilities of the State Election Commission, which are identical to the provisions made in Article 243K of the Constitution of India. Similar provisions have been made in Section-3A of the Haryana Municipal Act, 1973 for the conduct of elections to the Municipal Committees and Municipal Councils and in Section-9 of the Haryana Municipal Corporation Act, 1994 for the conduct of elections to the Municipal Corporation in the State.

In pursuance of the provisions contained in clause (2) of Article 243K, the State Government has prescribed the Conditions of Service and tenure of the office of the State Election Commissioner in "the State Election Commissioner (Conditions of Service) Rules, 1994" which are in consonance with the provisions contained in clause (2) of Article 243K. The State Election Commissioner has been defined as the State Election Commissioner appointed under clause (1) of Article 243K of the Constitution of India, meaning thereby that the State Election Commissioner shall be appointed by the Governor of the State. The qualifications for the State Election Commissioner has been prescribed as that of a person who is or has been a Judge of a High Court, or a person who has served the Government in the rank of Commissioner for a minimum period of five years or is serving the State Government in a higher rank namely Financial Commissioner. The minimum age for the State Election Commissioner has been prescribed as 55

years. The tenure of the State Election Commissioner has been prescribed as five years from the date he assumes office subject to that where the State Election Commissioner attains the age of sixty five years before the expiry of the said term of five years, he shall vacate his office on the date on which he attains the said age. Provided further that the State Election Commissioner may, at any time, by writing under his hand addressed to the Governor, resign his office. A person who on the date of his appointment as State Election Commissioner was in the service of the Central or a State Government, shall be deemed to have retired from such service with effect from the date of his appointment as State Election Commissioner. The State Election Commissioner is entitled to the salary equal to the salary of the Chief Secretary to Government of Haryana subject to the condition that if a person who immediately before the date of assuming office as the State Election Commissioner was in receipt of, or, being eligible so to do, had opted to draw a pension in respect of any previous service under the Government of India or under the State Government or any other service, his salary in respect of service as the State Election Commissioner shall be reduced (a) by the amount of that pension, (b) by the amount of the commuted value in respect of previous if he had, before assuming office, received, in lieu of a portion of the pension due to him. The State Election Commissioner shall be entitled to travelling allowance, provision of rent free accommodation, conveyance facilities, medical facilities, leave an such other conditions of service as were applicable to him at the time of retirement or at the time of his appointment as State Election Commissioner, so far as may be apply to the State Election Commissioner. The Governor of the State is vested with the power to grant or refuse leave to the State Election Commissioner and to revoke or curtail leave granted to him. On ceasing to hold office, the State Election Commissioner, shall not be eligible for any further appointment under the Government. A person, if he is of unsound mind or if he is an undischarged

insolvent or if he has been convicted of an offence involving moral turpitude, shall be disqualified for being appointed or for being as the State Election Commissioner

The State Election Commissioner, Haryana has been given the status equivalent to the Chief Secretary to Government of Haryana under Article 24 of the State Order of Precedence issued vide Government Notification No.50/215/99-5PP dated 25<sup>th</sup> May, 2000.

The State Election Commissioner, Haryana has also been delegated all the financial and administrative powers available to the Administrative Secretary to Government, Haryana, in so far as the work relating to the State Election Commission, Haryana, is concerned. These powers have been delegated by the State Government vide orders issued under No.20/18/94-4(2P)(i)/(ii), dated 28.3.1995. Despite this, the instructions relating to ban on purchase of vehicles, recruitment an other such restrictions for the Government departments are also made applicable to the State Election Commission.

### **INCUMBANCY POSITION OF STATE ELECTION COMMISSIONERS**

**Sh.J.K.Duggal**, an IAS officer of 1963 batch of Haryana Cadre was appointed the first State Election Commissioner, who joined on 15.7.1994 and continued as such till the completion of his tenure on 14.7.1999. During his tenure, the First General Panchayat Elections were conducted in the year 1994.

**Sh.T.D.Jogpal**, an IAS officer of 1968 batch of Haryana Cadre became the next State Election Commissioner on 14.7.1999 and continued till the completion of his tenure on 14.07.2004. During his tenure, the Second General Panchayat Elections were held in the year 2000.

**Sh.Chander Singh**, an IAS officer of 1973 batch of Haryana Cadre joined as the Third State Election Commissioner on 14.09.2004 and is continuing as such. During his tenure, the Third General Panchayat Elections were held in April, 2005 successfully.

Ever since its inception, the State Election Commission is functioning in a rented building in SCO No.16-17, Sector 20-D, Chandigarh. Besides the State Election Commissioner, the following officers/officials are working in the Commission against the sanctioned post(s) mentioned against their names.

### STAFF POSITION IN FIELD OFFICES

The Government had also sanctioned 19 posts of Assistants and 19 posts of Clerks for the "Local Bodies Election Cells" at district level, i.e. one Assistant and one Clerk for each district. Later on, 16 posts of Assistants and 14 Clerks were abolished. At present, 3 posts of Assistants and 5 posts of Clerks have been sanctioned for "Local Bodies Election Cells" at field level. Out of these, one Assistant and one Clerk each in Faridabad and Rohtak districts, one Assistant in Sirsa district and one Clerk each in Jind, Jhajjar and Narnaul districts have been posted.

### **LIST OF VOTERS**

### **ELECTORAL PROGRAMME-PREPARATION OF VOTERS LISTS**

The provisions relating to the preparation of list of voters for the Panchayat Elections are contained in Section 162 to 169 in Part-V-Chapter XX of the Haryana Panchayati Raj Act, 1994, which inter-alia provide that every **Sabha Area, Block** and **District** shall be devided into Wards (i.e. Electoral Division) and for every Electoral Division, the list of voters shall be prepared and maintained in accordance with provisions of this Act under the superintendence, direction and control of the State Election Commission.

### First Notification dated 7.12.2004

Initially the State Election Commission, vide its notification issued vide No.SEC/2E-III/2004/13021 dated 07.12.2004, in terms of the provisions contained in the Haryana Panchayati Raj Act, 1994 and the Haryana Panchayati Raj Election Rules, 1994, directed the District Election Authorities that the list of voters in respect of all the wards of Gram Panchayats, Panchayat Samitis and Zila Parishads in the State of Haryana for the Third Panchayat General Elections shall be prepared on the basis of the Assembly electoral rolls published on 23.2.2004, with qualifying date as 01.01.2004, according to which the final voters' lists were to be published on 27.12.2004 and on that basis, the programme for the conduct of Third Panchayat General Elections was to be issued by the Commission before 31.12.2004.

### Stay Granted by High Court

However, in the meanwhile, the Hon'ble High Court had stayed the operation of the Government Notification dated 07.12.2004 with regard to the amendment in Section 161 of the Haryana Panchayati Raj Act, 1994.

### Second Notification dated 27.12.2004

Consequent upon the stay granted by the High Court, the matter was reconsidered by the State Election Commission and it was decided that the publication of voters' lists should not be done on 27.12.2004 in pursuance of Commission's notification dated 07.12.2004 and for the Third Panchayat General Elections, the voters' lists shall be prepared/revised on the basis of Assembly electoral rolls published on 03.01.2005, with qualifying date as 01.01.2005. Accordingly, a detailed programme for preparation of the lists of voters for the Panchayati Raj Institutions on the basis of the Assembly electoral rolls finally published on03.01.2005 with qualifying date as 01.01.2005 was issued by the Commission vide its notification No.SEC/2E-III/2004/15397 dated 27.12.2004. As per this programme/time schedule, the voters' lists were finally published on 22.2.2005.

### Assignment of job of printing of voters' lists to Printing Presses

The job for the printing of voters' lists was assigned to the printing presses approved by the Commission at a competitive rate which was much less than the cost charged for the same job in previous General Elections.

### <u>Appointment of District Electoral Officers & Deputy District Electoral Officers</u>

The State Election Commission, vide its notification No.SEC/2E-III/2004/10547 dated 6.10.2004, appointed the HCS officers of the rank of City Magistrates and Sub Divisional Officers (Civil) as District Electoral Officers for the preparation of the lists of voters in their jurisdiction in respect of the Gram Panchayats, Panchayat Samitis and Zila Parishads for the conduct of Third Panchayat General Elections.

Further, vide Commission's notification No.SEC/2E-III/2004/ 10773 dated 6.10.2004, the Block Development and Panchayat Officers were appointed as Deputy District Electoral Officers for their concerned blocks to assist the District

Electoral Officers for preparation of the lists of voters of the wards of Sarpanch and Members of Gram Panchayats, Members of Panchayat Samitis and Zila Parishads, to ensure successful conduct of the Third Panchayat General Elections. However, in view of certain administrative exigencies arising in some district offices with regard to the availability of HCS officers of the rank of City Magistrates and Sub Divisional Officers (Civil) in sufficient number, it was felt that the work relating to the preparation of voters' lists was suffering. Hence, with a view to overcome this situation, vide Commissions notification No.SEC/2E-III/2004/14088 dated 09.12.2004, it was decided to delegate powers to the Deputy Commissioners-cum-District Election Officers (Panchayat) in the State to appoint any HCS officer, District Revenue Officer, Sub Divisional Officer (Civil) or any other officer at the District Headquarter vested with powers of Collector/Magistrate, to perform the duty as District Electoral Officer for the preparation of voters' lists for the conduct of Panchayat elections.

### **Compliance**

It was ensured by the District Election Authorities that the draft voters' lists so prepared for preliminary publication for all the wards of Zila Parishads, Panchayat Samitis and Gram Panchayats were in conformity with the electoral rolls of the Assembly Constituencies published on 03.01.2005 and the names of such persons whose names appear in the Assembly electoral rolls were not excluded from the voters' list at the time of preliminary publication. A person who had attained the age of 18 years on 25.01.2005 and if he, filed claim for inclusion of his name in the voters' list, his name was also included in the voters' list. Further, it was also ensured that the Electoral Identity Card number as indicated against the names of voters in the Assembly electoral rolls is also entered under column-8 of the voters' list prepared for the Zila Parishads, Panchayat Samitis and Gram Panchayats.

### Writ Petitions:

Through a CWP No.5690 of 2005 filed in the Hon'ble Punjab & Haryana High Court, Sh.Jagir Singh & Others prayed for directing the respondents to include their names in the voters' list of Gram Panchayat Dhani Satnam Singh, Block Rania, District Sirsa. The Hon'ble High Court, vide its order dated 07.04.2005, disposed off the Writ Petition directing the respondents to take a decision in the matter by 08.04.2005, in accordance with law. The said order of the High Court, alongwith representation of the petitioners, was sent to the Deputy Commissioner, Sirsa. The Deputy Commissioner, Sirsa decided the representation and allowed the names of the petitioners to be included in the voters' list of Gram Panchayat Dhani Satnam Singh.

In a similar CWP No.5676 of 2005 filed by Sh.Tikka Ram and others praying for the inclusion of their names in the voters' list of Gram Panchayat Kheri Mor Singh, Block Rania, District Sirsa, the Hon'ble High Court passed the same order dated 07.04.2005 directing the respondents to decide the representation by 08.04.2005. This order of the High Court, alongwith the representation, was also sent to the Deputy Commissioner, Sirsa to comply with the orders of the Hon'ble High Court. The Deputy Commissioner disposed off the representation, allowing the names of the petitioners to be included in the voters' list of Gram Panchayat Kheri Mor Singh.

Another CWP No.5679 of 2005 was filed before the Hon'ble High Court by Prince Pal Singh & Others praying for the inclusion of name of the petitioner, his mother and wife in the voters' list of Gram Panchayat, Sangoli Rangdan, Block Babain, District Kurukshetra. This Writ Petition was also disposed of by the Hon'ble High Court, vide order dated 07.04.2005 with the direction to decide the representation by 08.04.2005. The order of the High Court, alongwith the representation, was sent to the Deputy Commissioner, Kurukshetra for complying with the orders of the High Court. However, the Deputy Commissioner, Kurukshetra vide his order dated 08.04.2005 rejected the representation on the plea that the petitioners had not availed of the opportunity of filing claims for the inclusion of their names, during the period provided in the schedule of preparation of voters' lists as per programme issued by the State Election Commission.

### THIRD PANCHAYAT GENERAL ELECTIONS, 2005

The State Election Commission, Haryana, started functioning in the right earnest to fulfill its constitutional obligations of conduct of 3<sup>rd</sup> Panchayat General Elections in the State. However, the function of delimitation of constituencies and reservation of seats and offices of Chairpersons of Panchayats have not been assigned to the State Election Commission, rather, the Government authorities who have been assigned the work of delimitation of constituencies and reservation of seats and offices of chairpersons of local bodies did this job at their own level. However, the Commission persued the matter with the Government for expeditious completion of work relating to delimitation and reservation of wards. Thereafter, the State Election Commission undertook various steps for the conduct of Elections of Panchayati Raj Institutions in the State of Haryana and issued Election Programme vide its Notification No.SEC/2E-III/2005/17778 dated 14.03.2005.

### **Meetings with District Authorities**

The State Election Commissioner, immediately after the issuance of election programme, held meetings with the Divisional Commissioners as well as Deputy Commissioners-cum-District Election Officers (Panchayat) to take a stock of the poll arrangements made by the District Authorities.

### Rehearsal/Training of Polling Staff

Rehearsal/training was also got conducted at the District Headquarters. All the Deputy Commissioners-cum-District Election Officers (Panchayat) and other District officers connected with the election work were briefed about the election process.

### Coordination

The District Authorities were advised to remain in touch with the State Election Commission to sort out any problem relating to the conduct of elections and keep a proper coordination with the officers of the Commission, who were appointed Nodal Officers for this purpose.

### **Visit to Printing Presses**

State Election Commissioner also took a personal initiative to visit Printing presses at their respective locations with a view to assess and ensure that these presses were having the required infrastructure and technical capability and were in a position to successfully complete the assigned job regarding printing of ballot papers and voters' lists for the Third Panchayat General Elections. For this purpose, a proper liaison was also kept by the State Election Commissioner with the District Authorities to keep himself abreast with the day-to-day development of election related work. Staff of the State Election Commission was also deputed to the Printing Presses from time to time to supervise and check the progress of the printing of voters' lists and ballot papers.

The elections were held in two phases i.e. first phase on 03.04.2005 and second phase on 09.04.2005.

**Polling Stations and Poll Personnel:** For these elections 8055 Polling Stations were set up and a total number of 32176 Polling Personnel were appointed to conduct these elections. The polling was peaceful by and large except a few stray incidents.

Observers: The State Election Commission appointed officers of the rank of Commissioner (Super Time Scale IAS) as Election Observers (General) and also appointed officers not below the rank of ETO as Observers (Expenditure) from the Excise and Taxation Department. All the Observers appointed by the State Election Commission were to ensure that elections in all the wards are conducted in a free and fair manner without any favour and fear. The Observers (Expenditure) were to observe that no candidate should exceed the expenditure limits prescribed by the State election Commission. The Commission observed that Observers performed their duties diligently. No violation of election rules and expenditure limit by the candidates was reported to the Commission.

Deployment of Police Force: In order to maintain law & order, about 36,000 Police Personnel were put on election duty. To keep an overall check on the poll process, as many as 985 officials were appointed as Returning Officers (Panchayat). The polling started at 8.00A.M. and concluded at 4.00P.M. In two incidents, the Presiding Officers of Polling Booth No.790 of Gram Panchayat Balkara, Block Dadri, District Bhiwani and one Polling Booth of Gram Panchayat Silana, Block Kharkhoda, District Sonipat, died due to heart attack at the polling stations, but as the reserve staff was available, the polling was held smoothly at these Polling Stations also. The overall poll percentage in the State was 80 to 85%.

**Repoll:** Fresh poll/re-poll was ordered for the elections to the offices of Panches, Sarpanches, Member, Panchayat Samitis and Zila Parishads during the Third Panchayat General Elections on 7.4.2005, 9.4.005 and 11.4.2005.

In the First Phase, re-poll at 61 Polling Stations of 26 Gram Panchayats and recommencement of poll at 4 Polling Booths of 2 Gram Panchayats, was ordered.

### **SECOND PHASE**

**Number of Seats:** As per the election programme, in the Second Phase, the votes for the offices of 33459 Panches and 3443 Sarpanches of Gram Panchayats, 1577 Member of Panchayat Samitis and 220 Member of Zila Parishads in the following 66 blocks of 19 districts were polled 09.04.2005:-

The votes for the offices of 632 Panches, 10 Sarpanches and 32 Members of Panchayat Samitis, where the seats remained vacant due to non-filing of nominations and other reasons and also because of re-poll at 52 Polling Stations where the poll was disrupted during the First Phase, were also polled on 09.04.2005.

**Polling Stations and Poll Personnel:** For these elections, 9768 Polling Stations were set up and a total number of 38868 Polling Personnel were appointed to conduct these elections. The polling was peaceful by and large except a few stray incidents reported in routine.

Re-poll: In the Second Phase, re-poll in 121 Polling Booths of 44 Gram Panchayats was ordered by the Commission. The State Election Commission had to cancel the election of Panch of Wards No. 9 & 10 of Gram Panchayat Thana Kalan and Ward No.10 of Gram Panchayat Sehjadpur of District Sonepat, Sarpanch of Gram Panchayat Malab in District Gurgaon, Panch of Ward No.3 of Gram Panchayat Kakrali, District Panchkula and Panch of Ward No.10 of Gram Panchayat Didwada, due to wrong acceptance of nomination papers and the revised election programme was issued by the Commission, according to which the poll for these offices was held on 15.04.2005. The State Election Commission also had to cancel the election of Panch of Ward No.17 and Sarpanch of Gram Panchayat, Nangal Kalan, Sarpanch of Gram Panchayat, Palri Kalan Block Rai, District Sonepat, due to wrong allotment of symbols. The Commission received preliminary reports that polling could not take place on 20 polling Booths of village Deeghal and 4 Polling Booths of village Marot in district Jhajjar, due to disruption of poll process by some miscreants. Polling also could not be held in 5 booths of village Subana, District Jhajjar due to wrong allotment of symbol to the candidate for election to the office of Sarpanch. However, the poll was vitiated in village Dhani Bhartu District Bhiwani due to some local dispute.

**Counting of Votes:** The counting of votes for the offices of Panches & Sarpanches of Gram Panchayats in both First and Second Phases, was started at the Polling Stations itself, immediately after the close of poll. The counting of votes for Members, Panchayat Samitis and Zila Parishads was initially scheduled to be

held on 10.04.2005 but keeping in view some administrative difficulties/requirements, it was actually held on 12.04.2005.

The overall picture that emerged is detailed below through the following facts and figures:-

On the whole, the Third General Elections to the Panchayati Raj Institutions were conducted peacefully barring a few stray incidents, which emanated due to personal reasons.

### **NOMINATION**

Rule 26,27,29 and 30 of the Haryana Panchayati Raj Election Rules,1994 deals with supply, presentation, notice and scrutiny of nomination papers. It also provides that any person may be nominated as candidate for the election to fill the seat if he is qualified to be elected under the provisions of these Rules/Act.

During the Third Panchayat General Elections, the nomination papers completed in all respects, for the offices of Panches and Sarpanches were received at the Headquarters of the Gram Panchayats. The nominations papers for election to the offices of Members, Panchayat Samitis were received at the Block Headquarters and for the Members of Zila Parishads, the nomination papers were received at the District Headquarters.

The details regarding presentation of nomination papers, notice of nomination, time and place for scrutiny of nomination papers under rules 26, 27, 29 and 30 respectively of the Haryana Panchayati Raj Election Rules, 1994, are already discussed in the First Election Report published in the year 2004.

Some analysis about the percentage of persons elected Un-opposed, average number of nomination received, accepted, contesting candiates to the total number of such offices, during the 3<sup>rd</sup> Panchayat General Elections has also been made officewise/districtwise, the detail of which are given in **Annexure 18 to 21** and analysis of which are as under:-

### **Panches**

Against the 60276 seats of Panches of the Gram Panchayats where the 3<sup>rd</sup> Panchayat General Elections were held in the State, total 1,39,955 nominations papers were received i.e. average 2.3 nomination papers received against one

seat of Panch. The highest average of nomination received is 2.8 of District Karnal and lowest average is 1.9 is of District Sonepat. Whereas the average of nomination received in 13 Districts is equivalent and more than the mean average and 6 Districts average is the lowest than the mean average i.e. 2.3. The average of nomination received in the 2<sup>nd</sup> Panchayat General Elections was 1.6.

A total 91198 nomination papers were accepted from the total 1,39,955 nomination papers i.e. the average 1.5 nomination papers were accepted against one seat of Panch.

Out of the total 60276 seats of Panches, 36645 were elected Unopposed i.e. 60.8% election were Unopposed which is on higher side than the average of 56% in 2<sup>nd</sup> Panchayat General Elections held in March,2000. The highest average of the Panches elected Unopposed is 75% of District Panchkula and lowest is 44.6% of District Karnal.

A total of 54553 candidates contested the elections for the remaining 23557 seats of Panches. Thus on an average 2.3 number of candidates contested for the election of one seat of Panch which is also higher than the average of 1.6 in the 2<sup>nd</sup> Panchayat General Elections held in March, 2000.

### <u>Sarpanches</u>

Against the total 6180 seats of Sarpanches of the Gram Panchayats where the 3<sup>rd</sup> Panchayat General Elections were held in the State, total 63,746 nominations papers were received i.e. average 10.3 nomination papers received against one seat of Sarpanch. The highest average of nomination received is 15.9 of District Hisar and lowest average is 8.4 is of District Sirsa. Whereas the average of nomination received in 10 Districts is equivalent and more than the mean average and 9 Districts average is the lowest than the mean average i.e. 10.3. The average of nomination received in the 2<sup>nd</sup> Panchayat General Elections was 4.3.

A total 30165 nomination papers were accepted from the total 63,746 nomination papers i.e. the average 4.9 nomination papers were accepted against one seat of Sarpanch.

Out of the total 6180 seats of Sarpanches, 473 were elected Unopposed i.e. 7.7% election were Unopposed which is lower than the average of 12% in 2<sup>nd</sup> Panchayat General Elections held in March,2000. The highest average of the Sarpanches elected Unopposed is 13.8% of District Sirsa and lowest is 2.6% of District Rohtak.

A total of 29,692 candidates contested the elections for the remaining 5704 seats of Sarpanches. Thus on an average 5.2 number of candidates contested for the election of one seat of Sarpanch which is also higher than the average of 4.3 in the 2<sup>nd</sup> Panchayat General Elections held in March, 2000.

### Member Panchayat Samiti (MPS)

Against the total 2833 seats of Member Panchayat Samitis in the State, total 16,818 nominations papers were received i.e. average 5.9 nomination papers received against one seat of MPS. The highest average of nomination received is 7.7 of District Kurukshetra and Mahendergarh and lowest average is 4 of District Sonepat. Whereas the average of nomination received in 10 Districts is equivalent and more than the mean average and 9 Districts average is the lower than the mean average i.e. 5.9. The average of nomination received in the 2<sup>nd</sup> Panchayat General Elections, 2000 was 3.1.

A total 10918 nomination papers were accepted from the total 16,818 nomination papers i.e. the average 3.8 nomination papers were accepted against one seat of MPS.

Out of the total 2833 seats of MPS, 302 were elected Unopposed i.e. 10.7% election were Unopposed which is on the lower side than the average of 18% in 2<sup>nd</sup> Panchayat General Elections held in March,2000. The highest average of the

MPS elected Unopposed is 22.5% of District Ambala and lowest is 3.3% of District Rewari.

A total of 10616 candidates contested the elections for the remaining 2531 seats of MPS. Thus on an average 4.2 number of candidates contested for the election of one seat of MPS which is also higher than the average of 3.1 in the 2<sup>nd</sup> Panchayat General Elections held in March, 2000.

### Member Zila Parishad (MZP)

Against the total 384 seats of MZP in the State, total 4658 nominations papers were received i.e. average 12 nomination papers received against one seat of MZP. The highest average of nomination received is 18 of District Mahendergarh and lowest average is 8.7% of District Sirsa. Whereas the average of nomination received in 8 Districts is equivalent and more than the mean average and 11 Districts average is the lowest than the mean average i.e. 12. The average of nomination received in the 2<sup>nd</sup> Panchayat General Elections,2000 was 4.4 only.

2886 nomination papers were accepted from the total of 4658 nomination papers i.e. the average 7.5 nomination papers were accepted against one seat of MZP and also average 4.6 nomination papers were Rejected or withdrawn.

Out of the total 384 seats of MZP, only 2 Members of Yamunanagar Zila Parishad were elected Unopposed i.e. 0.5% election were Unopposed which is lower than the average of 14% in 2<sup>nd</sup> Panchayat General Elections held in March,2000.

A total of 2884 candidates contested the elections for the remaining 382 seats of MZPs. Thus on an average 7.5 number of candidates contested for the election of one seat of MZP which is higher than the average of 4.4 in the 2<sup>nd</sup> Panchayat General Elections held in March, 2000.

In the above analysis, **it comes out** that the average of the nomination papers filed and the number of contesting candidates for one seat of all the offices

has increased and percentage of Un-opposed election is decreased (except in case of Panches were it has increased) in the 3<sup>rd</sup> Panchayat General Elections,2005 as compared to the 2<sup>nd</sup> Panchayat General Elections held in March,2000.

Some information about the number of contesting candidates i.e. Numberwise contesting candidates for the office of Panches, Sarpanches, Members Panchayat Samitis and Members Zila Parishads in the 3<sup>rd</sup> Panchayat General Elections held in March, 2005 has been collected, the details of which are given in **Annexure 22 to 25** and analysis of which are as under:-

### **Panches**

Out of the total 60276 seats of Panches, 36645 were elected Unopposed, 74 seats remained vacant due to no nomination received and for the remaining 23557 seats, a total of 54553 candidates had contested the elections. Out of which for 17989 seats the two candidates were in contest. Thus, on the 76% seats, only two candidates were in contest. The maximum number of contesting candidates was 20 in Ward No.11 of Gram Panchayat Kavi, Block Madlauda, District Panipat and in another seat i.e. Ward No.18 of Gram Panchayat Sarhaul, Block & District Gurgaon 18 candidates contested the election and for the remaining seats the contesting candidates were less than or equal to 9 candidates.

### **Sarpanches**

Out of the total 6180 seats of Sarpanches, 473 were elected Unopposed, 3 seats remained vacant due to no nomination received and on the remaining 5704 seats, a total of 29692 candidates had contested the elections. Out of which for 1132 seats the two candidates were in contest. Thus, for 20% seats, only two candidates were in contest, for 18% seats 3 candidates and for 15% seats 4 candidates were in contest. The maximum number of contesting candidates was 49 in Gram Panchayat Gorakhpur, Block Bhuna, District Fatehabad and for the

remaining seats the contesting candidates were less than or equal to 34 candidates.

### Members Panchayat Samitis (MPS)

Out of the total 2833 seats of MPS, 302 were elected Unopposed and for the remaining 2531 seats, a total of 10616 candidates had contested the elections. Out of which for 19% seats two candidates, for 24% seats three candidates and for 21% seats 4 candidates were in contest. The maximum number of contesting candidates was 15 in Ward No.13 of Panchayat Samiti Nagina, District Gurgaon and in Ward No. 7 of Panchayat Samiti Kairu of District Bhiwani and in another seat i.e. Ward No.21 of Panchayat Samiti Nagina, District Gurgaon 14 candidates contested the election and for the remaining seats the contesting candidates were less than or equal to 13 candidates.

### Members Zila Parishad (MZP)

Out of the total 384 seats of MZP only two members were elected as Unopposed and for the remaining 382 seats, a total of 2884 candidates had contested the elections. Out of which for the maximum number of seats i.e. 51 and 48, where five or six candidates respectively were in the field. Thus, for 13% seats, only five or six candidates were in contest. The maximum number of contesting candidates was 21 in Ward No.21 of Zila Parishad Bhiwani and in another seat i.e. Ward No.20 of Zila Parishad Sonepat 20 candidates contested the election and in three seats of Zila Parishad 19 candidates were contested the election and for the remaining seats the contesting candidates were less than or equal to 17 candidates.

### **POLITICAL PARTIES AND SYMBOLS**

The State Election Commission notified the list of symbols for election to Members of Zila Parishads, Panchayat Samitis, Sarpanch and Panches of Gram Panchayats vide notification No.SEC/2E-III/2005/19451, dated 21.03.2005, in supersession of its earlier notification issued on 01.05.2002. However, the list of symbols was again revised vide State Election Commission's notification No.SEC/4E-III/2005/4939 dated 01.06.2005.

The Haryana Panchayati Raj Election Symbols (Reservation and Allotment) Order, 1996 which was issued by the State Election Commission vide notification dated 15.5.1996, provides that the election to the offices of Panches and Sarpanches which are not held on party basis, on the last date of withdrawal of nominations, the symbols (from the list notified by the Commission) shall be allotted to the contesting candidates seriatumwise in the order in which their names are mentioned in the list of contesting candidates prepared in Hindi in alphabetical order of Devnagri Script. It also provides that no candidate will ask for any other symbol but for the symbol notified by the State Election Commission.

As per the above notification the candidates contesting the election of Panches and Sarpanches were not allowed to contest the election of Political Party basis. The candidates for contesting the election to the offices of Members Panchayat Samitis and Zila parishads were allowed to contest the election on political party basis. However, there was response from any Political Party to contest the Panchayat Elections.

### **BALLOT PAPERS AND BALLOT BOXES**

### **Ballot Papers**

Rule 41 of the Haryana Panchayati Raj Election Rules, 1994 provides that every ballot paper shall be of such design as may be approved by the State Election Commission and the ballot papers for election of Panches, Sarpanches, Members of Panchayat Samitis and Zila Parishads shall be in four different colours throughout the State of Haryana. The Commission had issued instructions for printing of ballot papers providing therein the specifications about size and form of the ballot paper.

### Third Panchayat General Elections-2005

For the Third Panchayat General Elections held in April, 2005, it was decided that the ballot papers even for the elections to the offices of Panches and Sarpanches of the Gram Panchayats shall also be got printed on the pattern of the ballot papers printed for the elections to the offices of the Members of Panchayat Samitis and Zila Parishads. As every Ward of the Gram Panchayat is an independent constituency, the work for printing of the ballot papers involved printing of about more than 69673 different types of ballot papers. The State Printing and Stationery Department expressed its inability to print the ballot papers for the Panchayat elections due to insufficient infrastructure for printing more than 69673 different types of ballot papers. The total number of ballot papers required to be printed were about four crore. In view of the inability shown by the State Printing & Stationery Department for the printing of ballot papers, sealed tenders were invited by publishing Tender Notice in the leading newspapers. In response to the Tender Notice, four printing presses quoted their rates. Out of these four firms, only one firm had quoted the minimum rate of 60 paise per ballot paper with paper and 49 paise per ballot paper without paper, irrespective of the number of ballot

papers to be printed. The other three printing presses had quoted their rates on the basis of per thousand ballot papers meaning thereby that they would charge rates for the printing of minimum 1,000 ballot papers even if lesser ballot papers were to be printed as was allowed to them in 2<sup>nd</sup> General Panchayat Elections held in March,2000.

### **HIGH POWER PURCHASE COMMITTEE**

The State Government constituted a High Power Purchase Committee under the Chairmanship of Sh.Chander Singh, IAS (Retd.), State Election Commissioner, Haryana, in which Sh.Hardeep Kumar, IAS, Special Secretary to Government Haryana, Finance Department, Smt. Jaiwanti Sheokand, IAS, Director Panchayats Haryana, Sh.R.B.Langyan, IAS, Director Local Bodies, Haryana and Sh.A.S.Yadav, HCS, Controller, Printing & Stationery Department, Haryana were the members. The High Powered Purchase Committee under the Chairmanship of Sh.Chander Singh, State Election Commissioner Haryana negotiated the rates with the printing presses and the final rates of 46.5 paise per ballot with paper upto 9 candidates in single column, 58.5 paise per ballot paper with paper upto 18 candidates in two columns and for every additional column of 3½" width having maximum upto 9 candidates or its multiples is 10 paise per ballot paper and so on, irrespective of the number of ballot papers to be printed, were approved. In this way, during the Third Panchayat General Elections, 2005 an amount of about rupees one crore was saved in comparison to the expenditure incurred on the printing of ballot papers during the Second General Panchayat Elections, 2000. As per the instructions issued by the Commission, the ballot papers were printed on Cream wove paper in four different colours i.e. Black for Panches, Blue for Sarpanches, Yellow for Member Panchayat Samitis and **Red** for Member Zila Parishad.

### Supervision of Security Presses

In order to ensure timely completion of printing of ballot papers, the Deputy Commissioners were asked to deploy experienced and competent staff for supervision of the printing of ballot papers. A team comprising one member from the Commission and one member from the Controller, Printing & Stationery Department was deputed at each printing press to review the progress of the printing work regularly during the period when the printing was undertaken. On the request of the Commission, the Director General of Police, Haryana provided sufficient police force at the Printing Presses. Instructions were issued that no unauthorized person should be allowed to enter inside the Printing Presses when the printing work was in progress. Adequate security arrangements were made for the transportation of ballot papers from the premises of the Printing Presses to the District/Block Headquarters. The ballot papers were kept under lock and key with proper security arrangements till the issue of election material to the polling staff.

### **Ballot Papers**

During the 3<sup>rd</sup> Panchayat General Elections,2005 a total number of 3,34,26,021 ballot papers (4596729 of Panches, 9735051 for Sarpanches, 9085873 for Members Panchayat Samitis and 10008368 for Members Zila Parishads) were got printed from the three private printing presses.

### **Ballot Boxes**

Rule 40 of the Haryana Panchayati Raj Rules, 1994 provides that every ballot box shall, subject to general or special order of the State Election Commission, be of such design that ballot papers can be inserted therein but cannot be withdrawn there from without the box being unlocked and the seals being broken. No independent and separate design of ballot box was made by the State Election Commission and the ballot boxes used for the Assembly and Parliamentary elections, were used in the Panchayat elections as well. The

Commission had already purchased 1500 ballot boxes for use in the Panchayat elections. Since a very large number of ballot boxes were required to be used for the Third Panchayat General Elections, the ballot boxes were taken from the State Election Department, Haryana and from the State Election Commission, Punjab on rent basis.

### MODEL CODE OF CONDUCT

In exercise of the powers conferred under Article 243K(1) of the Constitution of India, the State Election Commission, Haryana, issued the Model Code of Conduct for elections to the Panchayati Raj Institutions (i.e. offices of Panches, Sarpanches of Gram Panchayats, Members of Panchayat Samitis and Zila Parishads) to ensure free, fair and peaceful elections. The Model Code of Conduct was made applicable to all the political parties, contesting candidates, Ministers, employees of the State Government and Local Bodies and other public servants related to the conduct of elections to the Panchayati Raj Institutions. The Model Code of Conduct was enforced from the date of issue of the notification for elections till the completion of the election process.

Ban on Sale of Liquor: As per the provisions of the Model Code of Conduct, the campaigning was stopped 48 hours before the hours fixed for the close of poll. The State Election Commission, requested the Financial Commissioner & Secretary to Government, Haryana, Prohibition and Excise & Taxation Department to notify 'dry days' at or around the areas where the Panchayat elections were held for such period during which the Panchayat elections were held. The period of dry days declared and notified included the period of one day before the poll day, i.e. the polling and counting day and the day immediately, thereafter. In compliance with the instructions issued by the State Election Commission, the Financial Commissioner & Secretary to Government, Haryana, Prohibition and Excise & Taxation Department also issued directions to the field offices that:-

(i) no liquor shops, hotels, restaurants, clubs and other establishments selling/serving liquor should be permitted to sell and serve liquor on the aforesaid dates.

- (ii) no proprietary clubs, Star Hotels, restaurants etc. and hotels run by anyone even if they are issued different categories of licenses for possessions and supply of liquor, should be permitted to serve liquors on these days.
- (iii) the storage of liquors by individuals shall be curtailed during the above period and the restrictions provided in the Excise Law on the storage in unlicensed premises should be vigorously enforced.
- (iv) Steps should also be taken to prohibit sale of liquor in adjoining areas where elections were held, so that there were no chances of clandestine movement of liquor from those areas where the restrictions were not in operation.

Declaration of Holiday: In compliance with the proposal made by the State Election Commission vide letter No.SEC/2E-III/2005/18088, dated 15.03.2005, the Chief Secretary to Government Haryana also declared dates of Polls as Holidays under Section 25 of the Negotiable Instruments Act, 1881, at the places where the polls were scheduled to be held, so that the workers engaged in various factories and commercial establishments located in the above areas could exercise their right to vote.

Ban on Transfers: Further in view of the suggestions made to the Chief Secretary, Haryana by the State Election Commission, the State Government also issued orders *imposing ban on transfer* of officers and officials connected with the conduct of elections to the Panchayati Raj Institutions during the period when the Model Code of Conduct was in force.

Ban on release of grants and laying foundation stones etc.: In compliance with the reference made by the State Election Commission, the State Government also issued instructions that during the period when the Model Code of Conduct is in force, the Ministers will not give any grant from the Government funds and no foundation stone will be laid down for any new project or scheme.

**Misuse of Vehicle:** Instructions were also issued by the State Election Commission to all the Deputy Commissioners-cum-District Election Officers (Panchayat) to prevent *misuse of vehicles* on the poll day.

*Miscellaneous:* Instructions were also issued to the Deputy Commissioners about the use of Electoral Photo Identity Cards for identification of voters during polling, to hold meetings with the representatives of the Political Parties, deployment of police force at the counting centres, review law and order situation during the elections.

### **Chapter-8**

### **OBSERVERS**

In exercise of the powers conferred under Article 243K of the Constitution of India, the Commission had appointed senior *IAS officers of the rank of Commissioner & Secretary as Election Observers and Senior Officers of the rank of District Excise & Taxation Officer and Excise & Taxation Officer of the Excise & Taxation Department as Expenditure Observers for the Third Panchayat General Elections held in April, 2005.* 

The Election Observers were asked to oversee the election process in the Districts allotted to them and the Expenditure Observers, in particular, were assigned the responsibility to observe that the expenditure incurred by the contesting candidates for the election is as per the limits prescribed by the Commission.

Detailed instructions were issued to all the Deputy Commissioners in the State to ensure to provide suitable accommodation in the Government Rest Houses or Circuit Houses, Government vehicles, telephone facilities, police escorts and security guards to the Observers appointed for their Districts. The Deputy Commissioners were also asked that senior Revenue Officers be deputed to accompany the Observers, during their visit to the Polling Stations.

The Election Observers were asked to paste stickers on their vehicles clearly showing that the vehicle was being used by the Election Observer. The Observers were also advised that they should meet the representatives of the recognized political parties, the candidates and also listen to their grievances and look into the complaints received from the candidates and general public. They were also, advised to give special attention to the sensitive polling stations and in the cases of threats to the voters, especially to the people belonging to the weaker sections. The Expenditure Observers were instructed to ensure that the contesting

candidates should maintain day-to-day accounts of expenditure incurred by them from the last date of withdrawal onwards. They were also asked to see that all expenses incurred by the contesting candidates or their authorized election agents, on petrol, postage, printing of pamphlets, election campaign material, advertisements in the newspapers, expenditure on stationery items and any other such expenses, which may be directly or indirectly related with the election, are taken into account.

The following IAS officers were appointed as Election Observers for the Third Panchayat General Elections held on 3<sup>rd</sup> and 9<sup>th</sup> April, 2005:-

The State Election Commission, vide its Notification No. SEC/2E-III/2005/17778, dated 14.03.2005, issued the election programme for holding elections to the offices of Panches & Sarpanches of Gram Panchayats, Members of Panchayat Samitis and Zila Parishads in the State in two phases. According to the election schedule, the poll for the First Phase was held on 03.04.2005 and for the Second Phase, the poll was held on 09.04.2005. As specified in the notification issued by the Commission, the votes were polled between 08.00 A.M. and 04.00 P.M on the above said dates and overall Poll percentage in the State was **80 to 85**%. Except a few minor incidents the poll remained peaceful.

#### Repoll

Since the poll process was vitiated for various reasons at certain places, the State Election Commission ordered re-poll at 61 Polling Stations of 26 Gram Panchayats in 9 Districts during the First Phase.

Re-poll was ordered at 121 Polling Stations in 44 Gram Panchayats in 9 Districts during the Second Phase also. The recommencement of the adjourned poll was also ordered at 4 Polling Stations in 2 Gram Panchayats of 2 Districts during the First Phase.

The details of the Polling Stations where re-poll was ordered by the State Election Commission are given at **Annexure 1 and 2**.

### Chapter-10

### **COUNTING OF VOTES**

The detailed instructions for the counting of votes have been provided in the booklets titled as "Guidelines for the Presiding Officers" and "Instructions for the Returning Officers/Assistant Returning Officers".

The counting of votes being one of the most important aspects in the process of election, in the rehearsal of Polling Staff, it was stressed upon the Returning Officers, Presiding Officers and Polling Officers that they should strictly adhere to the instructions provided in the instructions booklet supplied to them. During the rehearsals, the necessary forms and dummy ballot papers were also displayed to explain them about the various steps they should take during the counting of votes, specially about different types of markings on the ballot papers for classification of votes as valid or invalid votes.

In the programme for the elections to the offices of Panches & Sarpanches of Gram Panchayats, Members of Panchayat Samitis and Zila Parishads in the State as notified by the Commission, directions were given that the counting of votes polled for the elections to Panches and Sarpanches shall be made at the Polling Stations itself immediately after the close of poll and the counting of votes for the election to the Members of Panchayat Samitis and Zila Parishads shall be done on 10.04.2005. However, due to administrative reasons, the Commission, vide notification No.SEC/E-III/2005/364 dated 04.04.2005, directed that the counting of votes polled for the elections to Members of Panchayat Samitis and Zila Parishads shall be made on 12.04.2005 at the places specified by the Deputy Commissioner-cum-District Election Officers (Panchayat). Accordingly, the counting of votes polled for elections to the offices of Members of Panchayat Samitis and Zila Parishads was held on 12.04.2005.

### Chapter-11

### **FILLING OF CASUAL VACANCIES**

Section 6 of the Haryana Panchayati Raj Act, 1994 provides that whenever a vacancy occurs due to death, resignation, removal or otherwise of a Panch, Sarpanch, Member, Chairman, Vice-Chairman of Panchayat Samiti, President or Vice-President of Zila Parishad, as the case may be, a new Panch, Sarpanch, Member, Chairman, Vice-Chairman, President or Vice-President, as the case may be, shall be elected in the manner as may be prescribed. It also provides that any person elected to fill up a vacancy shall hold office for the unexpired period of the term for which such person in whose place he is elected would have otherwise continued in office.

The details of 2875 casual vacancies during the period from 21.7.2000 to 28.12.2003, which were filled up by holding by-elections after the Second Panchayat General Elections held in the year 2000, has already been mentioned at Page-88 of the First Election Report.

However, details regarding vacant seats/casual vacancies of Panches, Sarpanches, Members of Panchayat Samitis and Zila Parishads, which were filled up through by-elections during the period from 29.12.2003 till date, is given as under:-

### Chapter-12

## ANALYSIS OF ACHIEVEMENTS OF STATE ELECTION COMMISSIONER DURING HIS TENURE

Printing of Ballot Papers and Voters' Lists: The expertise of the State Election Commissioner in the field of finance was fruitfully utilised to its optimum by adopting the strategy of economy measures in achieving a large scale saving approximately rupees one crore, on account of printing of ballot papers and voters' lists etc. for the Third General Panchayat Elections as against the heavy expenditure incurred in the Second General Panchayat Elections held in March, 2000. Because of his professional ability and rapport as Chief Electoral Officer of the State Election Department with the private printers who did not feign their loyalty to give a handsome royalty of concession to the State Election Commission by slashing their rates substantially on account of printing of ballot papers and the voters lists, as well.

**Transportation during Polls:** Besides this, a considerable amount was also saved on account of hiring of private buses and trucks on rates fixed by State Transport Department, as per past practice, for carrying polling parties to their respective destinations.

**Videography:** During the current elections of Panchayats, no videography was allowed to the Deputy Commissioners as per the past practice. Hence, the Commission was able to save a considerable amount on this account also.

Litigation: There has been a substantial decline in the expenditure on account of litigation also. There were a bundle of court cases during the Second General Panchayat Elections, 2000, in which a huge amount of Rs.3,60,000 was paid to the private Defence Counsels engaged to defend the cases on behalf of the State Election Commission. Whereas, during the current General Panchayat Elections, there were only a few court cases where the Advocate General, Haryana was

asked to defend them on behalf of the State Election Commission, thereby saving a huge amount on account of legal fees which was earlier paid to the Private Counsels.

Office Expenses: The bills on account of electricity and water charges, telephone, fax, POL, Travel Expenses etc. have gone down considerably during the tenure of the present State Election Commissioner because of his being a role model in putting the concept of 'Economy in Expenditure' into real practice thereby setting a fine example for the staff also to follow the same.

The following economy measures were adopted by the State Election Commission:-

- 1. No expenditure for hiring the private vehicles for transportation/cartage of election material was allowed to the district/field offices.
- 2. No expenditure on account of entertainment/hospitality to the election staff was incurred resulting in total saving on this account.
- 3. Economic and optimum utilisation of the election material.
- 4. Effective monitoring and proper coordination/liaise with the Deputy Commissioners have yielded better results in saving the over all expenditure on the conduct of elections of Panchayati Raj Institutions.
- 5. Economy measures were also adopted in the allocation of funds to the Deputy Commissioners-cum-District Election Officers in a very stringent manner to avoid all kinds of wasteful/unnecessary expenditures.

**Status of Pendency:** No case on the part of the Commission is pending for want of a decision regarding payment of any bill or otherwise where the approval of the State Election Commissioner is involved for final settlement.

Improvement in the system of purchase and management of election material/electronic items:

Strenuous efforts were made to streamline/rationalise the purchase and procurement of election material with a view to provide an improvised system to ensure better quality of election material and its timely delivery to the district

officers, on requisition made by them. However, it was also ensured that a proper checklist of election material is maintained at the Headquarter to oversee its proper utilisation in the field offices so that there is no misutilisation and no excess stock on account of extravagant purchase of election material is lying in the field offices.

To avoid the delay in effecting purchase of office apparatuses/ electronic items which are usually purchased through HARTRON which is a time consuming process indeed, the State Election Commission made a departure from the prevailing system and went in for the direct purchase from the open market, after observing the codal formalities and even made profitable purchases on competitive rates by negotiating the bargains with the open competitors in the market, thereby yielding a handsome saving on this account. To make the system more effective and workable, in some cases, the Deputy Commissioners were also allowed to make petty purchases of election material at their level on the rates not exceeding the rates approved by the Commission for this purpose.

State Election Commission also contacted Haryana Government from time to time for consultation purpose which is mandatory for conduct of elections as per amendment of the Haryana Panchayati Raj Act,1994.

All efforts were made for timely allotment/release of funds to enable this Commission to discharge its constitutional obligations in a most successful manner.

The State Election Commission has made a great achievement in accomplishing this stupendous task of conducting the elections in a short period of only 31 days.
