Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of bye-election five wards, namely, Ward No. 15 of Municipal Council, Sohna, district Gurugram, Ward No. 01 of Municipal Council, Kaithal, Ward No. 16 of Municipal Council, Narnaul, district Mahendergarh, Ward No. 05 of Municipal Committee, Rajound, district Kaithal and Ward No. 11, Municipal Committee, Bawal, district Rewari vide Notification No. SEC/1ME/2023/1680 dated 12.10.2023 (copy enclosed). As per schedule, the nomination papers shall be presented from **20.10.2023 to 26.10.2023** (except on 22.10.2023 &




24.10.2023 being gazetted holidays) and the poll shall be held on **05.11.2023**. Counting of votes shall be taken up after the close of poll in all the polling stations and the result shall be declared immediately after completion of counting.

2. I have, therefore, been directed to request you to declare **05.11.2023** a public holiday for all the factories, commercial establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction of the municipalities, where poll shall be held on **05.11.2023**, to enable workers of the factories, commercial establishments, shops etc. located in the areas to cast their votes.

3. I have also been directed to request you that a copy of the orders issued in this respect may kindly be sent to the State Election Commission.


