### ORDER

No.SEC/3ME/2024/ 714

Dated: 05.06.2024

Whereas the general election of the Municipal Council, Nuh was held on 19.06.2022 and the result of the election was declared on 22.06.2022.

2. Section 13E of the Haryana Municipal Act, 1973 provides that every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure incurred in connection with the election or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive. The account shall contain such particulars, as may be notified by the State Election Commission in this behalf. The total of the said expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.

3. Section 13F of the Haryana Municipal Act, 1973 further provides that if the State Election Commission is satisfied that a person who contested the election but failed to lodge an account of election expenses within the time and manner as prescribed by the State Election Commission and has no reason or justification thereof, the State Election Commission shall by order published in the Official Gazettee, declare him/her to be disqualified for contesting an election for a period of five years from the date of the order under this Act.

4. The State Election Commissioner, Haryana, in exercise of powers vested in him under Section 3B of the Haryana Municipal Act, 1973 has

authorized the Deputy Commissioner concerned vide order bearing endorsement No.SEC/3ME/2023/304-446 dated 07.03.2023 to decide the cases of disqualification of the contesting candidates, who have failed to lodge their account of election expenses within the time and manner, as prescribed by the State Election Commission.

5. Now, in pursuance of the above orders passed by the State Election Commissioner, Haryana, the Deputy Commissioner, Nuh vide order dated 10.04.2024 alongwith copy endorsed to the State Election Commission, Haryana, has disqualified the following candidates who had contested general elections of the Municipal Council, Nuh held on 19.06.2022 but had not submitted their election expenses account within the stipulated time:-

6. Therefore, in exercise of the powers envisaged in Section 13F of Haryana Municipal Act, 1973, I, Dhanpat Singh, State Election Commissioner, Haryana hereby order to notify the order declaring the above mentioned candidates disqualified by the Deputy Commissioner, Nuh vide Endst. No.

2093-99/LFA, dated 10.04.2024 in the Haryana Government Gazette. The disqualification shall run from the date of order passed by the Deputy Commissioner, Nuh in this respect i.e dated 10.04.2024.
