**No. 9/148/2024-4CII.**- In exercise of the powers conferred under clauses (b) and (c) of sub-section (1) and sub-section (7) of section 257 of the Haryana Municipal Act, 1973 (24 of 1973) and in consultation with State Election Commission, with reference to Haryana Government, Urban Local Bodies Department, notification No. 9/148/2024-4CII, dated the 6<sup>th</sup> December, 2024, the Governor of Haryana hereby makes the following rules further to amend the Haryana Municipal Delimitation of Ward Rules, 1977, namely:-

1. These rules may be called the Haryana Municipal Delimitation of Ward (Amendment) Rules, 2024.
2. In the Haryana Municipal Delimitation of Ward Rules, 1977, (hereinafter called the said rules), in clause (i) of rule 5, after the words, alphabet and signs "Backward Classes 'A' ", the words, alphabet and signs ",Backward Classes 'B' " shall be inserted.
3. In the said rules, in clause (c) of rule 7, for the words, alphabet and signs "and Backward Classes 'A' ", the words, alphabet and signs ",Backward Classes 'A' and Backward Classes 'B' " shall be substituted.

संख्या. 9/148/2024-4क II .- हरियाणा नगरपालिका अधिनियम, 1973 (1973 का 24) की धारा 257 की उप-धारा (1) के खण्ड (ख) और (ग) तथा उप-धारा (7) के अधीन प्रदत्त शक्तियों का प्रयोग करते हुए तथा राज्य निर्वाचन आयोग के परामर्श से और हरियाणा सरकार, शहरी स्थानीय निकाय विभाग, अधिसूचना संख्या 9/148/2024-4क II, दिनांक 6 दिसम्बर, 2024 के प्रतिनिर्देश से, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा नगरपालिका वार्ड परिसीमन नियम, 1977 को आगे संशोधित करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

1. ये नियम हरियाणा नगरपालिका वार्ड परिसीमन (संशोधन) नियम, 2024 कहे जा सकते हैं।
2. हरियाणा नगरपालिका वार्ड परिसीमन नियम, 1977 (जिन्हें, इसमें, इसके बाद, उक्त नियम कहा गया है) में, नियम 5 के खण्ड (i) में, "पिछड़े वर्गों 'क' " शब्द के बाद, ",पिछड़े वर्गों 'ख' " चिह्न, शब्द तथा वर्णाक्षर रखे जाएंगे।
3. उक्त नियमों में, नियम 7 के खण्ड (ग) में, "तथा पिछड़े वर्गों 'क' " शब्दों, चिह्न तथा वर्णाक्षर के स्थान पर, ",पिछड़े वर्गों 'क' तथा पिछड़े वर्गों 'ख' " चिह्न, शब्द तथा वर्णाक्षर प्रतिस्थापित किए जाएंगे।
