**Subject: General/Bye-elections of municipal bodies in the State of Haryana - Creation of e-Dashboard linked with the website of State Election Commission, Haryana regarding.**

Sir,


I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notifications for conduct of general elections for the seats of Mayors & Members of all the wards of 08 Municipal Corporations and Presidents & Members of all the wards of 04 Municipal Councils & 21 Municipal Committees and bye-elections of 02 seats of Mayors i.e. Municipal Corporations, Ambala and Sonapat; 03 seats of Presidents i.e. President, Municipal Council, Sohana (Gurugram); Municipal Committee, Assandh (Karnal) & Municipal Committee, Ismailabad (Kurukshetra) and 03 seats of Members i.e. Ward No. 11 of Municipal Committee, Ladwa (Kurukshetra); Ward No. 14 of Municipal Committee, Safidon (Jind) & Ward No. 5 of Municipal Committee, Taraori (Karnal) vide Notification Nos. SEC/1ME/2025/530 and SEC/1ME/2025/581 both dated 01.02.2025 (copies enclosed). As per schedule, nomination papers (except Municipal Corporation, Panipat) shall be presented from **11.02.2025 to 17.02.2025** (except 12.02.2025 & 16.02.2025 being holidays) and in respect of Municipal Corporation, Panipat from **21.02.2025 to 27.02.2025** (except 23.02.2025 & 26.02.2025 being holidays). Poll (except Municipal Corporation, Panipat) shall be held on **02.03.2025** and in respect of Municipal Corporation, Panipat on **09.03.2025**. Re-poll if any required, shall be held on **04.03.2025** (except Municipal Corporation, Panipat) and in respect of Municipal Corporation, Panipat on **11.03.2025**. Counting of votes shall be held on **12.03.2025** at **8.00 A.M.** at the place(s) specified by the Deputy Commissioner concerned and result shall be declared immediately after the completion of counting.

2. For the smoothness of work, transparency and public convenience, the State Election Commission intends to create e-Dashboard (web portal populated with SMS) on the pattern of e-Dashboard created at the time of the general elections of the municipalities held in the months of 12/2018, 12/2020 and 06/2022 for these elections also.

3. You are, therefore, requested to immediately create booth wise e-Dashboard (web portal populated with SMS) on the pattern of e-Dashboard created at the time of the general elections of municipalities held in the months of 12/2018, 12/2020 and 06/2022 under intimation to the State Election Commission, by incorporating the seats of Mayors/Presidents and Members of the Municipal Corporations/Committees/Councils (**referred at Annexure-A**) in it. The e-Dashboard must be linked with the site of State Election Commission, Haryana and shall have all the features available, as were available in the e-Dashboard created in the year, 2018, 2020 and 2022.

3. Any information or assistance required in this respect from this Commission or from field offices, may directly be obtained from the concerned through mail under intimation to this Commission.
