Subject: Voter list programme of Panchayati Raj Institutions-- data regarding.

Sir

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has received database of the respective areas of the Legislative Assembly constituencies, published in August/September, 2024 for preparation of wardwise voter list of Panchayati Raj Institutions. However, database of the voters added, deleted and transposed after August/September has not been made available to the State Election Commission. Due to non availability of the database after August/September, 2024, it is not possible to add/delete the names of voters added or deleted after this period.

2. I have been directed to draw your attention towards section 12B of the Haryana Panchayati Raj Election Rules, 1994 which provides as under:-

"12-B. Inclusion, deletion and correction of names in the ward wise list of voters finally published.- Any person whose name is not included in the ward wise list of voters finally published may apply to the Deputy Commissioner-cum-District Election Officer (P) for addition/deletion/ correction of his/her name in the ward wise list of voters:

Provided that the addition/deletion or correction of any name in the ward wise list of voters of Gram Panchayat, Panchayat Samiti and Zila Parishad can only be made, if the name of claimant/applicant exists in the relevant part of assembly electoral roll till the first day of filing nomination papers for the elections of Gram Panchayat, Panchayati Samiti and Zila Parishad".

3. In view of the above provisions, I have been directed to request you to direct all the concerned Election Tehsildars and Electoral Registration Officers (EROs) to provide complete details regarding addition/deletion/transposition etc. of the voters after August/September, 2024 alongwith copies of all documents/lists i.e. form 9, 10, 11 etc or any other form to the concerned District Electoral Officers so that the integrated draft/final voter list is published without any discrepancy to avoid any difficulty in conducting elections to the Panchayati Raj Institutions (as per list enclosed) in near future.

4. This may be treated as most urgent.

A copy is forwarded to all the Deputy Commissioners-cum-District Election Officers (Panchayats) with the request that if name of any person is deleted or added in the voter list of Legislative Assembly constituencies but not added/deleted in the finally published voter list of Gram Panchayat/Panchayat Samiti/Zila Parishad In this situation as per provisions contained in Section 12 B of the Haryana Panchayati Raj Election Rules, 1994, he/she has to apply in form 1A or 1B (as the case may be) to the concerned officer and the concerned officer after proper verification would enter his/her name in the voter list of Gram Panchayat/Panchayat Samiti/Zila Parishad.
