As per schedule, the nomination papers shall be presented from 10.06.2025 to 16.06.2025 (except on 11.06.2025 & 15.06.2025 being holidays) and poll shall be held on **29.06.2025**. Re-poll, if any required, shall be held on **01.07.2025** and counting of votes shall be held on **02.07.2025** from **11.00 A.M**. onwards at the place(s) specified by the Deputy Commissioner **or** if there is no re-poll, counting will be held on **30.06.2025** from **11.00 A.M**. onwards at the specified place(s).

I have, therefore, been directed to request you to declare
29.06.2025 a public holiday for all the factories, commercial establishments, industrial undertakings, trade, shops etc., falling within the jurisdiction of the

Municipal Committee, Kalanwali, district Sirsa, where poll shall be held on **29.06.2025**, to enable workers of the factories, commercial establishments, shops etc. located in the areas to cast their votes.
