То

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections for the seat of President and Members of all the wards of Municipal Committee, Kalanwali, district Sirsa vide Notification No. SEC/1ME/2025/4882 dated 03.06.2025 (copy enclosed). As per schedule, the nomination papers shall be presented from 10.06.2025 to 16.06.2025 (except on 11.06.2025 & 15.06.2025 being holidays) and poll shall be held on 29.06.2025. Re-poll, if any required, shall be held on 01.07.2025 and counting of votes shall be held on 02.07.2025 from 11.00 A.M. onwards at the place(s) specified by the Deputy Commissioner or if there is no re-poll, counting will be held on 30.06.2025 from 11.00 A.M. onwards at the specified place(s).

2. The State Election Commission has earlier noticed that despite the fact that the Model Code of Conduct only remains effective in the areas where the poll is to be held, several Govt. Departments, semi Government Departments, Boards, Corporations, Universities etc. approach this

Commission for relaxation on separate issues, issuance of NOC, permission etc.

3. The State Election Commission therefore makes it clear that the Model Code of Conduct remains effective only in the areas where the poll is to be held and not in outside areas.

4. I have, therefore, been directed to request you to bring it into the notice of all the offices under your administrative control that the model code of conduct is only effective in the area of Municipal Committee, Kalanwali, district Sirsa where election is to be held and as such, issues pertaining to other urban/municipal areas are not required to be sent to this Commission for any kind of relaxation, issuance of NOC, permission etc.
