2. Since the election programme has been issued by this Commission on **03.06.2025**, the Model Code of Conduct prescribed by the State Election Commission has come into operation with w.e.f. **03.06.2025** in the area of Municipal Committee, Kalanwali, district Sirsa where poll is to

3. I have, therefore, been directed to request you that this may be brought to the notice of the Hon'ble Chief Minister / Ministers and other authorities and they may further be requested to strictly follow the model

code of conduct. I have further been directed to request you to invite attention of the Hon'ble Chief Minister and Ministers towards para No.9 of the Model Code of Conduct, that no grant be sanctioned by them from the discretionary fund or from Govt. fund nor will they sanction any scheme till the elections are completed in all respect. During this period neither any foundation stone shall be laid nor will any scheme / plan may be inaugurated in the area of respective Municipal Committee. Any violation of the Model Code of Conduct will be viewed seriously by the State Election Commission.

- 4. I have further been directed to say that State Election

 Commission will not hesitate to cancel the election in case of any violation

 of the Model Code of conduct.
