### ORDER

No.SEC/3ME/2025/6152

Dated: 11.11.2025

Whereas general election of the Municipal Committee Siwan, was held on 02.03.2025 and the result of the election were declared on 12.03.2025.

2. Section 13E of the Haryana Municipal Act, 1973 provides that every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure in connection with the election incurred or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive. The account shall contain such particulars, as may be notified by the State Election Commission in this behalf. The total of the said expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.

3. Section 13F of the Haryana Municipal Act, 1973 further provides that if the State Election Commission is satisfied that a person who was contested election and has failed to lodge an account of election expenses within the time and manner as prescribed by the State Election Commission and has no reason or justification thereof, the State Election Commission shall by order published in the Official Gazettee, declare him/her to be disqualified for contesting an election for a period of five years from the date of the order under this Act.

4. The State Election Commissioner, Haryana in exercise of powers vested with him/her under Section 3B of the Haryana Municipal Act, 1973 has authorized the Deputy Commissioner concerned vide order bearing endorsement No.SEC/3ME/2023/304-446 dated 07.03.2023 to decide the cases of disqualification of the contesting candidates, who have failed to lodge their account of election expenses within the time and manner, as prescribed by the State Election Commission.

5. Now, in pursuance of the above orders passed by the State Election Commissioner, Haryana, the Deputy Commissioner, Kaithal vide order dated 24.09.2025 and a copy also endorsed to the State Election Commission, Haryana, has disqualified Shri Ajay Kumar S/o Sh. Satpal Parshad Rank, Ward No. 12, Municipal Committee, Siwan who had contested general election of the Municipal Committee Siwan held on 02.03.2025 but had not submitted his election expenses account within the stipulated time.

6. Therefore, in exercise of the powers envisaged in Section 13F of Haryana Municipal Act, 1973, I, Devender Singh Kalyan, State Election Commissioner, Haryana hereby order to notify the order declaring **Sh. Ajay Kumar S/o Sh. Satpal Parshad Rank, Ward No. 12, Municipal Committee, Siwan** disqualified by the Deputy Commissioner, Kaithal vide Endst.No. 3873-3879/LFA, dated 24.09.2025 in the Haryana Government Gazette. The disqualification shall run from the date of order passed by the Deputy Commissioner, Kaithal in this respect i.e dated 24.09.2025.


