ORDER

No.SEC/3ME/2025/ 6158

Dated: 12.11.2025

Whereas general election of the Municipal Corporation, Sonipat was held on 27.12.2020 and the result of the elected candidates was declared on 30.12.2020.

2. Section 8B of the Haryana Municipal Corporation Act, 1994 provides that every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure in connection with the election or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive. The account shall contain such particulars, as may be notified by the State Election Commission, Haryana in this behalf. Total of the said expenditure shall not exceed such amount as may be notified by the State Election Commission, Haryana from time to time.

3. Section 8E of the Haryana Municipal Corporation, Act 1994 further provides that if the State Election Commission, Haryana is satisfied that a person who contested the election but failed to lodge an account of election expenses within the time and manner as prescribed by the State Election Commission, Haryana and has no reason or justification thereof, the State Election Commission, Haryana shall by order published in the Official Gazettee, declare him/her to be disqualified for contesting a municipal election for a period of five years from the date of the order passed under this Act.

4. The State Election Commissioner, Haryana, in exercise of powers vested in him under Section 3B of the Haryana Municipal Act, 1973 has authorized the Deputy Commissioner concerned vide order bearing endorsement No.SEC/3ME/2023/304-446 dated 07.03.2023 to decide cases of disqualification of the contesting candidates, who have failed to lodge their account of election expenses within the time and manner, as prescribed by the State Election Commission, Haryana.

5. In pursuance of the above orders passed by the State Election Commissioner, Haryana, the Deputy Commissioner, Sonipat vide order dated 31.01.2025 and issued corrigendum datd 30.05.2025 as per provision under Section 8B of the Haryana Municipal Corporation, Act, 1994, the following

candidates have disqualified for an election for a period of five years from the date of order i.e. 31.01.2025.

6. The following candidates had contested the election of Municipal Corporation, Sonipat but failed to submit their election expenditure account within the prescribed time limit or thereafter:-


