ORDER

No.SEC/3ME/2025/ 6172

Dated: 12.11.2025

Whereas the general elections of the Municipal Council Jind/Narwana and Municipal Committee, Uchana and Safidon were held on 19.06.2022 and the results of the election were declared on 22.06.2022.

2. Section 13E of the Haryana Municipal Act, 1973 provides that every candidate at an election shall, either himself or by his election agent, keep a separate and correct account of all expenditure incurred in connection with the election or authorized by him or by his election agent from the date of filing of nomination papers to the date of declaration of the result thereof, both dates inclusive. The account shall contain such particulars, as may be notified by the State Election Commission in this behalf. The total of the said expenditure shall not exceed such amount as may be notified by the State Election Commission from time to time.

3. Section 13F of the Haryana Municipal Act, 1973 further provides that if the State Election Commission is satisfied that a person who contested the election but failed to lodge an account of election expenses within the time and manner as prescribed by the State Election Commission and has no reason or justification thereof, the State Election Commission shall by order published in the Official Gazettee, declare him/her to be disqualified for contesting an election for a period of five years from the date of the order under this Act.

4. The State Election Commissioner, Haryana, in exercise of powers vested in him under Section 3B of the Haryana Municipal Act, 1973 has authorized the Deputy Commissioner concerned vide order bearing endorsement No.SEC/3ME/2023/304-446 dated 07.03.2023 to decide the cases of disqualification of the contesting candidates, who have failed to lodge their account of election expenses within the time and manner, as prescribed by the State Election Commission.

5. Now, in pursuance of the above orders passed by the State Election Commissioner, Haryana, the Deputy Commissioner, Jind vide order dated 26.09.2025 alongwith copy endorsed to the State Election Commission, Haryana, has disqualified the following 40 candidates who had contested general elections of the Municipal Council Jind/Narwana and Municipal Committee, Uchana/Safidon

held on 19.06.2022 but had not submitted their election expenses account within the stipulated time:-
