- 2) That only government employees who come under the purview of Rule 8 (36) of Haryana Government Employees (General) Rules, 2016 would be considered for temporary transfer/deputation basis.
- Number of posts could be increased or decreased. The appointment in the District Election Cells are inter-changeable and the employee taken on temporary transfer/deputation could be appointed in any district or in the office of State Election Commission, Haryana, Panchkula as per exigency of the work.

You are therefore, requested to forward applications of such employees with detail filled in proforma (as attached) of those officials who are willing to work in the District Election Cell under the administrative control and supervision of the State Election Commission, Haryana and the respective Deputy Commissioner on temporary transfer/deputation basis alongwith attested copy of the summary of ACRs for the last 5 years within 40 days from the date of issue of this circular. While forwarding the applications, it may be ensured that no disciplinary proceedings under Rule 7 & 8 of Haryana Civil Services (Punishment & Appeal Rules 2016) or vigilance enquiry and/or any other criminal proceedings are pending/contemplated against the employee concerned.
