Whereas, the State Election Commission, Haryana vide notification No.SEC/E-II/2022/8623, dated 30.11.2022 had notified the name of Ashish Chouhan s/o Sh.Rakesh Chouhan as Member, Ward No.19, Panchayat Samiti Radaur, District Yamuna Nagar under section 161 (4) of the Haryana Panchayati Raj Act, 1994.

And whereas the Block Development and Panchayat Officer-cum-Executive Officer, Panchayat Samiti, Radaur vide letter No.552-553, dated 19.02.2026 has informed that Director General, Development and Panchayat Department, Haryana vide letter No.Zila-2025/779, dated 07.01.2026 has informed that Sh.Ashish Chouhan, Member, Ward No. 19, Panchayat Samiti, Radaur, has been absent from four consecutive meetings of the Panchayat Samiti without the permission of the Panchayat Samiti during his tenure. Hence, as per Section 63 of the Haryana Panchayati Raj Act, 1994, he will cease to be a member of the Panchayat Samiti and his post will be deemed to be vacant.

3. In view of the above, the State Election Commission, Haryana hereby denotifies the name of Sh.Ashish Chouhan s/o Sh.Rakesh Chouhan from the post of Member, Ward No.19, Panchayat Samiti Radaur, District Yamuna Nagar with immediate effect.
