I have been directed to refer to the above subject and to inform you that the election of 03 Municipal Corporation, Ambala, Sonapat, Panchkula, 01 Municipal Council, Rewari and 03 Municipal Committee, Dharuhera (Rewari), Uklana (Hisar), Sampla (Rohtak) and 06 bye elections of municipalities i.e. Ward No. 17, Municipal Council, Tohana (Fatehabad), Ward No. 13, Municipal Council, Jhajjar (Jhajjar), Ward No. 11, Municipal Committee, Rajound (Kaithal), Ward No. 14, Municipal Committee, Kanina (Mahendergarh), Ward No. 08, Municipal Committee, Taraori (Karnal) and Ward No. 09, Municipal Committee, Sadhaura (Yamuna Nagar) are to be conducted in near future.

It is intimated that in view of the sensitivity of general elections / bye-elections of the abovesaid municipalities, the State Election Commission, Haryana has decided that Voters' Slips without photograph of voters be distributed to all enrolled voters by District Administration through BLOs/ other concerned staff well before the day of Poll in the said elections. The Voter's slip may be generated from database of the electoral roll of the concerned municipality entered / updated in VLMS (Voter List Management System). Two voters slips can be printed on an

A4 size page. The Voters' Slips should be authenticated by the Returning Officer concerned before distribution. The sample of Voter's Slip is enclosed herewith. All concerned should be appropriately briefed and the training of Polling Staff/RO/ARO should be updated, accordingly.


