Whereas, the Deputy Commissioner, Panipat vide order No.1568-79/Panchayat, dated 20.02.2026 removed Sh.Kuldeep Kumar s/o Sh.Krishan Kumar from the post of Sarpanch, Gram Panchayat Kalkha, Block Madlauda, District Panipat under Section 51(1)(b) of the Haryana Panchayati Raj Act, 1994.

2. Whereas, the State Election Commission, Haryana vide No.SEC/4E-II/2026/349, dated 03rd March, 2026 de-notified the name of Sh.Kuldeep Kumar s/o Sh.Krishan Kumar as Sarpanch, Gram Panchayat Kalkha, Block Madlauda, District Panipat.

3. Whereas, Sh.Kuldeep Kumar s/o Sh.Krishan Kumar, Sarpanch, Gram Panchayat Kalkha, Block Madlauda, District Panipat filed an EA No.832 of 2026 against the order dated 20.02.2026 passed by the Deputy Commissioner, Panipat in the Hon'ble Court of Divisional Commissioner, Karnal Division, Karnal.

4. Whereas, the Deputy Commissioner-cum-District Election Officer (Panchayat), Panipat vide letter No.2514/Panchayat, dated 01.04.2026 has informed that the Hon'ble Court of Divisional Commissioner, Karnal Division, Karnal granted stay to the order passed by the Deputy Commissioner, Panipat on dated 20.02.2026 till the next date of hearing i.e. 22.04.2026.

5. Therefore, State Election Commission in exercise of powers conferred under clause (1) of Article 243K of the Constitution of India, hereby orders that notification No.SEC/4E-II/2026/349, dated 03.03.2026, whereby Sh.Kuldeep Kumar s/o Sh.Krishan Kumar was de-notified from the post of Sarpanch, Gram Panchayat Kalkha, Block Madlauda, District Panipat is hereby withdrawn with immediate effect.


