Subject:- To set up "Single Window Operating System" for issuance of No Dues Certificate (NDC) well before the date of filling nomination for general/bye election, 2026-regarding.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notifications for conduct of general elections for the posts of Mayors & Members of all the wards of 03 Municipal Corporations i.e. Ambala, Panchkula & Sonapat and Presidents & Members of all the wards of Municipal Council, Rewari & 03 Municipal Committees i.e. Sampla (Rohtak), Dharuhera (Rewari) & Uklana (Hisar) and bye-elections of 06 vacant seats of members i.e. Ward No. 17 of Municipal Council, Tohana (Fatehabad), Ward No. 13 of Municipal Council, Jhajjar (Jhajjar), Ward No. 11 of Municipal Committee, Rajound (Kaithal), Ward No. 08 of Municipal Committee, Taraori (Karnal), Ward No. 14 of Municipal Committee, Kanina (Mahendergarh) and Ward No. 09 of Municipal Committee, Sadhaura (Yamuna Nagar) vide Notification Nos. SEC/1ME/2026/786 and SEC/1ME/2026/836 both dated 13.04.2026 (copies enclosed). As per schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026**. Poll shall be held on **10.05.2026**. Re-poll if any required, shall be held on **12.05.2026**. Counting of votes shall be done on **13.05.2026** at **8.00 A.M.** at the place(s) specified by the Deputy Commissioner concerned and result shall be declared immediately after the completion of counting.

2. No Dues Certificate to following Department/Organizations are required to be enclosed by every contested candidate with the nomination papers:-

- i. NDC from Municipal Corporation/Council/Committee concerned.
- ii. NDC from Primary Agriculture Co-operative Society
- iii. NDC from District Central Co-operative Bank.
- iv. NDC from District Primary Co-operative Agriculture Rural Development Bank.
- v. NDC from Electricity.

3. Prospective candidates face several difficulties in obtaining NDC from the above said Departments/Organizations due to different locations of the above said offices. In order to facilitate contesting candidates to obtain NDC, the State Election Commission, Haryana intends that concerned department/organization should set up single window operating system at one place after consulting with the Returning Officer concerned.

4. In view of the above, I have been directed to request you to direct the concerned Department/Organization for issuance of necessary directions to the field offices for setting up of single window operating system at one place after consulting with the Returning Officer concerned under intimation to the Commission.
