Subject:- Deemed Deputation of Polling Personnel, IAS/IFS/HCS Officers and Police Officers who are deputed as Observers & other officers/officials on election duty with the State Election Commission during general/bye-elections of Panchayati Raj Institutions.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana, Panchkula has issued notification for conduct of general/bye-elections of Panchayati Raj Institutions in the State of Haryana vide notification No.SEC/4E-II/2026/565, dated 13.04.2026(copy enclosed). As per election schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026** and poll shall be held on **10.05.2026**. The counting of votes shall be done immediately after the close of poll at the polling stations and result shall be declared immediately after the completion of counting. In case of re-poll, the poll shall be held on **12.05.2026** and counting would be after the completion of re-poll.

2. As per Rule 23-A of the Haryana Panchayati Raj Election Rules, 1994 are reproduced here as under:-

“23-A. Officers and staff deemed to be on deputation to State Election Commissioner.—The officers and staff deputed for election duty in connection with the preparation, revision and correction of the voters lists for, and the conduct of, all elections shall be deemed to be on deputation to the State Election Commission for the period during which they are so deputed and such officers and

staff shall, during that period, be subject to the control, superintendence and discipline of the State Election Commission.”.

3. In view of the above, I have been directed to request you to bring these provisions into the notice of all concerned for information and strict compliance.
