**Subject: Ban on Postings/Transfers of Officers/Officials who are engaged in conduct of General/Bye-elections of the Panchayati Raj Institutions in the State of Haryana during the period of Model Code of Conduct is in force.**

Sir, –

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana, Panchkula has issued notification for conduct of general/bye-elections of Panchayati Raj Institutions in the State of Haryana vide notification No.SEC/4E-II/2026/565, dated 13.04.2026(copy enclosed). As per election schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026** and poll shall be held on **10.05.2026**. The counting of votes shall be done immediately after the close of poll at the polling stations and result shall be declared immediately after the completion of counting. In case of re-poll, the poll shall be held on **12.05.2026** and counting would be after the completion of re-poll.

2. I have, therefore, been directed to request you that the officers/officials of the State Government deputed to conduct the above said elections or connected with the conduct of these elections in any manner shall not be transferred till the declaration of election results of the Panchayati Raj Institutions. However, in case, where it is considered necessary to transfer an officer/official connected with the above said Panchayat elections in larger public interest due to some emergency, prior written approval of the State Election Commission shall be obtained.

Necessary instructions in this regard may kindly be issued to all the Departments, Boards, Corporations, Autonomous Bodies/Authorities etc. of the State Government under intimation to the State Election Commission, Haryana.
