**Subject : General/Bye-Elections of Panchayati Raj Institutions in the State ---
Prohibition of sale of liquor during elections--regarding.**

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana, Panchkula has issued notification for conduct of general/bye-elections of Panchayati Raj Institutions in the State of Haryana vide notification No.SEC/4E-II/2026/565, dated 13.04.2026(copy enclosed). As per election schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026** and poll shall be held on **10.05.2026**. The counting of votes shall be done immediately after the close of poll at the polling stations and result shall be declared immediately after the completion of counting. In case of re-poll, the poll shall be held on **12.05.2026** and counting would be after the completion of re-poll.

2. In discharge of the constitutional responsibility of conducting and ensuring free and fair elections of the Panchayati Raj Institutions in a transparent and peaceful manner, the State Election Commission, Haryana, Panchkula proposes to take strict measures to ensure an atmosphere conducive for holding free, fair and peaceful elections reflective of true choice of the electorate.

3. For meeting this objective, the State Election Commission, Haryana, Panchkula in exercise of powers conferred upon him under article 243K (1) of Constitution of India, under Section 173A of Haryana Panchayati Raj Act, 1994 and Section 135C of the Representation of People Act, 1951 as applicable and all other powers enabling him in this behalf, hereby directs that the State Government shall declare and notify 'dry days' under relevant laws for such period during general/bye-elections of Panchayati Raj Institutions as are appropriate at or around the areas where Panchayati Raj Institutions elections are to be held. Such period of 'dry days'

so declared and notified must include the period of one day before the day of poll, actual date of polling including re-poll, if any.

4. The State Election Commission, Haryana, Panchkula further directs that:-

- (I) No liquor shops, hotels, restaurants, clubs and other establishments' selling/serving liquor shall be permitted to sell/serve liquor to any person, on the aforesaid dates.
- (II) No proprietary clubs, star hotels, restaurants etc. and hotels, even if they are issued different categories of licenses for possession and supply of liquor, should be permitted to serve liquor on these days.
- (III) The storage of liquor by individuals shall be curtailed during the above period and the restrictions provided in the Excise laws on the storage in unlicensed premises shall be vigorously enforced.
- (IV) Steps shall also be taken to prohibit sale of liquor in adjoining areas of the Panchayati Raj Institutions where the elections are to be held, so that there are no chances of clandestine movement of liquor from those areas, wherein the restriction is not in operation.


5. In pursuance of the above directions the State Election Commission, Haryana, Panchkula hereby directs that the above ban must be imposed within the jurisdiction of the areas, where general/bye-elections of the Panchayati Raj Institutions are to be held and the areas adjoining to the jurisdiction thereof on **09.05.2026 & 10.05.2026**, where poll is scheduled to be held on **10.05.2026**.

6. A nodal officer from Excise & Taxation Department may be appointed for these elections who will ensure compliance of the aforesaid order(s) in these districts and coordinate with State Election Commission.

7. It is requested that a copy of order issued in furtherance of the above mentioned directions may be sent to the State Election Commission, Haryana, Panchkula without delay.
