**Subject : General/Bye-Elections of Municipal Bodies --- Model Code of
Conduct.**

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notifications for conduct of general elections for the posts of Mayors & Members of all the wards of 03 Municipal Corporations i.e. Ambala, Panchkula & Sonapat and Presidents & Members of all the wards of Municipal Council, Rewari & 03 Municipal Committees i.e. Sampla (Rohtak), Dharuhera (Rewari) & Uklana (Hisar) and bye-elections of 06 vacant seats of members i.e. Ward No. 17 of Municipal Council, Tohana (Fatehabad), Ward No. 13 of Municipal Council, Jhajjar (Jhajjar), Ward No. 11 of Municipal Committee, Rajound (Kaithal), Ward No. 08 of Municipal Committee, Taraori (Karnal), Ward No. 14 of Municipal Committee, Kanina (Mahendergarh) and Ward No. 09 of Municipal Committee, Sadhaura (Yamuna Nagar) vide Notification Nos. SEC/1ME/2026/786 and SEC/1ME/2026/836 both dated 13.04.2026 (copies enclosed). As per schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026**. Poll shall be held on **10.05.2026**. Re-poll if any required, shall be held on **12.05.2026**. Counting of votes shall be done on **13.05.2026** at **8.00 A.M.** at the place(s) specified by the Deputy Commissioner concerned and result shall be declared immediately after the completion of counting.

2. Since the election programme has been issued by this Commission on **13.04.2026**, the Model Code of Conduct prescribed by the State Election Commission has come into operation w.e.f. **13.04.2026** in the areas of municipalities where polls are to be held.


3. I have, therefore, been directed to request you that this may kindly be brought to the notice of the Hon'ble Chief Minister, all Ministers, MPs/MLAs, Chairpersons (Non Official) and other authorities of all Boards/Corporations that

Model Code of Conduct has come into force immediately and will remain in force till the announcement of election results in respect of these municipal bodies. They may further be requested to strictly follow the model code of conduct during this period. I have further been directed to request you to invite attention of the Hon'ble Chief Minister and Ministers towards para No.9 of the Model Code of Conduct, that no grant can be sanctioned by them from the discretionary fund or from Govt. fund nor sanction shall be granted for any new scheme/project in these areas, till the elections are completed in all respect. During this period, no foundation stone shall be laid nor will any scheme/plan be inaugurated in the respective areas. Any violation of the Model Code of Conduct shall be seriously viewed by the State Election Commission.

4. I have further been directed to say that the State Election Commission will not hesitate to cancel the elections in case of any violation of the Model Code of Conduct.
