Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notifications for conduct of general elections for the posts of Mayors & Members of all the wards of 03 Municipal Corporations i.e. Ambala, Panchkula & Sonapat and Presidents & Members of all the wards of Municipal Council, Rewari & 03 Municipal Committees i.e. Sampla (Rohtak), Dharuhera (Rewari) & Uklana (Hisar) and bye-elections of 06 vacant seats of members i.e. Ward No. 17 of Municipal Council, Tohana (Fatehabad), Ward No. 13 of Municipal Council, Jhajjar (Jhajjar), Ward No. 11 of Municipal Committee, Rajound (Kaithal), Ward No. 08 of Municipal Committee, Taraori (Karnal), Ward No. 14 of Municipal Committee, Kanina (Mahendergarh) and Ward No. 09 of Municipal Committee, Sadhaura (Yamuna Nagar) vide Notification Nos. SEC/1ME/2026/786 and SEC/1ME/2026/836 both dated 13.04.2026 (copies enclosed). As per schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026**. Poll shall be held on **10.05.2026**. Re-poll if any required, shall be held on **12.05.2026**. Counting of votes shall be done on **13.05.2026 at 8.00 A.M.** at the place(s) specified by the Deputy Commissioner concerned and result shall be declared immediately after the completion of counting.

2. The State Election Commission intends to create e-Dashboard (web portal populated with SMS) on the pattern of e-Dashboard created at the time of the general elections of the municipalities held in the months of 12/2018, 12/2020, 06/2022 and 03/2025 for these elections also.

3. You are, therefore, requested to immediately create booth wise e-Dashboard (web portal populated with SMS) on the pattern of e-Dashboard created at the time of the general elections of municipalities held in the months of 12/2018, 12/2020, 06/2022 and 03/2025 under intimation to the State Election Commission, by incorporating the seats of Mayors/Presidents and Members of the Municipal Corporations/Council/Committees referred to above. The e-Dashboard must be linked with the site of State Election Commission, Haryana.

3. Any information or assistance required in this respect from this Commission or from field offices, may directly be obtained from the concerned through mail under intimation to this Commission.


