Subject: General/Bye-elections of Panchayati Raj Institutions in the State of Haryana - Creation of e-Dashboard linked with the website of State Election Commission, Haryana regarding.

Sir,

I have been directed to refer to the above subject and to say that the State Election Commission, Haryana has issued notification for conduct of general elections of all Panches and Sarpanches of **Gram Panchayat Mandi Adampur and Jawahar Nagar, Block Adampur, District Hisar; Gram Panchayat Govindpura and Polar, Block Siwan, District Kaithal** and bye elections on 528 vacant seats viz. 485 Panches, 29 Sarpanches of Gram Panchayat, 12 Members of Panchayat Samitis and 2 members of Zila Parishad vide Notification No.SEC/4E-II/2026/565, dated 13.04.2026 (copy enclosed). As per schedule, nomination papers shall be filed from **21.04.2026 to 25.04.2026**. Poll shall be held on **10.05.2026**. Re-poll if any required, shall be held on **12.05.2026**. Counting of votes shall be done immediately after close of poll and result shall be declared immediately after the completion of counting.

2. The State Election Commission intends to create e-Dashboard (web portal populated with SMS) on the pattern of e-Dashboard created at the time of the general elections of the Panchayati Raj Institutions held in the month of October/November, 2022 for these elections also.

3. You are, therefore, requested to immediately create booth wise e-Dashboard (web portal populated with SMS) on the pattern of e-Dashboard created at the time of the general elections of Panchayati Raj Institutions held in the month of October/November, 2022 under intimation to the State Election Commission, by incorporating the seats mentioned above. The e-Dashboard must be linked with the site of State Election Commission, Haryana.

4. Any information or assistance required in this respect from this Commission or from field offices, may directly be obtained from the concerned through mail under intimation to this Commission.
