ORDER

Order under Section 13G read with Section 13K of the Haryana Municipal Act, 1973

Subject : Review petition filed by Smt. Geeta under Section 13K of the Haryana Municipal Act, 1973 for review of the order passed under Section 13J of the Haryana Municipal Act, 1973 and for removal of the disqualification incurred under the Act.

1. Whereas, Smt. Geeta, wife of Sh. Somveer, Member, Ward No. 12, Municipal Committee, Uchana, District Jind filed a review application on 16.03.2026 before the State Election Commission, Haryana within the prescribed period under Section 13K of the Haryana Municipal Act, 1973 against the order No. SEC/3ME/2026/285 dated 13.02.2026 whereby she was removed from the post of member, Municipal Committee, Uchana in terms of Section 13J of the Haryana Municipal Act, 1973. In the said review petition, the applicant is seeking review of the aforesaid order and for removal of the disqualification.
 2. And whereas, the Commission has considered the ground taken in the review application alongwith the facts and circumstances explained by Smt. Geeta in the review petition. Upon reconsideration of the matter in review after taking into account the material placed on record as well as the explanation furnished by Smt. Geeta, the Commission is satisfied that sufficient grounds exist for removal of the disqualification incurred by her under Section 13F of the Haryana Municipal Act, 1973.
 3. Now, therefore, in exercise of the powers conferred under Section 13G read with Section 13 K of the Haryana Municipal Act, 1973, the State Election Commission, Haryana hereby removes the disqualification incurred by Smt. Geeta under the Section 13F of the Act.

4. Consequently, the order dated 13.02.2026 passed under Section 13J of the Haryana Municipal Act, 1973 is hereby reviewed and set aside.

Smt. Geeta, wife of Sh. Somveer, Member, Ward No. 12, Municipal Committee, Uchana, shall accordingly stand reinstated to the office concerned with immediate effect, subject to there being no other legal impediment.


